Counsel for the appellant present.

Learned counsel argued the matter at some length but when confronted with the position that the impugned corrigendum dated 14.05.2019, issued in respect of respondent No. 4 regarding her posting at Government Girls Higher Secondary School Hathian District Mardan, did not reflect any contents adverse to the service right of the appellant, requested for disposal of instant appeal in view of the certificate of transfer of charge in favour of appellant issued on 03.05.2019.

It is a matter of record that the appellant took over charge at GGHSS Hathian District Mardan as Senior Drawing Master BPS-16 in pursuance to corrigendum dated 02.05.2019 in respect of order dated 29.04.2019. On the other hand, the impugned corrigendum requiring the posting of respondent No. 4 at GGHSS Hathian was issued on 14.05.2019, a date much later to that of assumption of charge by the appellant at the stated school. The impugned corrigendum, therefore, is not to affect any service right of the appellant in absence of order contrary to corrigendum dated 02.05.2019 and the resumption of duty by the appellant in consequence thereof.

The appeal is disposed of in view of the above. File be consigned to the record.





On acceptance of this appeal the Corrigendum order dated 14.05.2019 in respect of Respondent No. 4, may please be set-aside and the appellant be allowed to continue her duties as SDM, at Government Girls Higher Secondary School Hathian District Mardan.

Respectfully Submitted:

1. That the appellant was initially appointed in the respondent department as DM vide office order dated 31.05.2004 on contract basis and was posted at GGMS Shuja Abad however later her services were regularized vide notification dated 05.01.2006. (*Copies of Office Order dated 31.05.2004 and notification dated 05.01.2006 are attached as Annexure A & B*)
2. That it is pertinent to mention here that ever since appointment the appellant has been performing her duties with zeal and devotion up-to the entire satisfaction of her superiors.
3. That in the year 2007 the appellant was transferred to GGMS Kaudary vide office order dated 20.01.2007 where the appellant served till 2019. While the Respondent No. 4 was performing her duties as DM at GGHS Hathian. (*Copy of Office Order dated 20.01.2007 is attached as Annexure C*)
4. That the Petitioner and Respondent No. 4 were promoted as SDM vide Promotion and Adjustment order dated 29.03.2019 and upon transfer the appellant was adjusted at GGHS Chamrang while the Respondent No. 4 was adjusted as GGHSS Khazana Dheri. (*Copy of the Promotion and Adjustment order dated 29.03.2019 is attached as Annexure D*)
5. That the respondent No. 4 was relieved from GGHS Hathian on 30.03.2019 and she took charge at her new station and started performing her duties. (*Copies of the certificate of transfer of charge dated 30.03.2019 and attendance for the month April-May 2019 are attached as Annexure E & F*).
6. That the appellant requests to the respondents that since there is a vacancy at GGHSS Hathian and keeping in view the fact that she has already performed her duties for 12 years at GGMS Kaudary which is far away from her place of residence so she may be adjusted at GGHSS Hathian. Her request was honored and a corrigendum notification was issued and she was posted at GGHSS Hathian vide notification dated 02.05.2019. The appellant was relieved on 03.05.2019 and she took charge at her new station on the same day. (*Copies of the corrigendum notification dated 02.05.2019, certificates of transfer of charge dated 03.05.2019 and are attached as Annexure G, H & I*).

7. That it is pertinent to mention here that ever since her posting at GGHSS Hathian the appellant has been performing her duties without any break.
8. That the Respondent No. 4 approached the Official Respondents to adjust her back at Hathian School. The Official Respondents, quite illegally and without giving attention towards the fact that the appellant is already performing her duties^{as} SDM at GGHSS Hathian, issued corrigendum notification dated 14.05.2019 vide which she was also adjusted in the same school and on the same day the principal GGHSS Khazan Dheri relieved her from duties. *(Copies of the corrigendum notification dated 14.05.2019 and relieving chit dated 14.05.2019 and are attached as Annexure J & K).*
9. That feeling aggrieved the appellant under good faith filed civil suit before the senior civil judge Mardan however the said suit was ~~dismissed~~ for lack of jurisdiction vide order and judgment dated 28.06.2019. *(Copy of order and judgment dated 28.06.2019 is attached as Annexure L).*
10. That the appellant also submitted her departmental appeal on 29.06.2019 against the order / corrigendum dated 14.05.2019, however the same has not been responded despite the lapse of statutory period. *(Copy of the departmental appeal dated 27.06.2019 is attached as Annexure M)*
11. That the impugned order is illegal, unlawful, without lawful authority against law and facts, and against the transfer and posting policy hence liable to be set aside inter alia on the following grounds:

Grounds of Appeal:

- A. That the appellant has not been treated in accordance with law his rights secured and guaranteed under the law are badly violated.
- B. That the impugned transfer orders are illegal, unlawful, void ab-initio, without lawful authority, hence liable to be set aside.
- C. That the appellant is still performing her duties^{as} SDM at GGHSS Hathian and neither she has been transferred nor relieved so the impugned corrigendum in respect of Respondent No. 4 is illegal, void and liable to be set aside.
- D. That the appellant has not been allowed to complete her tenure and thus the order impugned is violation of transfer posting policy of the Govt and the judgment of the apex court reported in PLD 1995. SC Page No 530 and PLD 2013 Supreme Court Page No 195. *(Copy of*

the transfer and posting policy is attached as Annexure L)

- E. That during the posting of the appellant as SDM at GGHSS Hathian her performance has been commendable and there was no complaint whatsoever regarding her performance.
- F. That in fact there exist no exigencies of service nor the order of transfer can be termed as in the public interest, rather it was issued in violation of law and transfer / posting policy of the Provincial Govt.
- G. That the impugned transfer order (through corrigendum) is illegal, unlawful, without lawful authority and passed without jurisdiction, not in the prescribed period, in violation of transfer and posting policy.
- H. That the impugned order dated 14.05.2019 has badly affected the working environment in the school in the sense that the appellant has not relinquished her charge and respondent No. 4 is trying to take charge.
- I. That the appellant seeks the permission of this Honorable Tribunal to rely on additional ground at the hearing of this appeal.

It is therefore prayed that on acceptance of this appeal the Corrigendum order dated 14.05.2019 in respect of Respondent No. 4, may please be set-aside and the appellant be allowed to continue her duties as SDM, at Government Girls Higher Secondary School Hathian District Mardan.

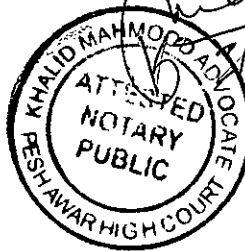

Respectfully submitted:

1. That the appellant has today filed the accompanied appeal before this honorable tribunal in which no date of hearing is fixed so far.
2. That the applicant prays for condonation of delay if any in filing the instant appeal inter alia on the following grounds:-

GROUND OF APPLICATION

- A. That the appellant throughout agitated the matter before the departmental authority and never remained negligent in perusing her remedy, the applicant, being unaware of law on the subject initially filed civil suit in good faith and initially got status quo order however later on it was ~~quashed~~ for lack of jurisdiction vide order and judgment dated 28.06.2019 thus delay if any in filing the instant appeal deserves to be condoned.
- B. That the appellant is still performing her duties ^{as} SDM at GGHSS Hathian and neither she has been transferred nor relieved so the impugned corrigendum in respect of Respondent No. 4 is illegal, void and liable to be set aside. Thus an order based on such defective proceedings is void in nature and no period of limitation is applicable against a void order.

- C. That valuable rights of the appellant are involved in the instant case in the instant case, hence the delay if any in filing the instant case deserves to be condoned.
- D. That the departmental appeal of the applicant has not been responded by the official respondents within the statutory period of ninety days and the instant appeal is being filed within period of limitation prescribed for it.
- E. That it has been the consistent view of the Superior Courts that causes should be decided on merit rather than technicalities including limitation. The same is reported in 2004 PLC (CS) 1014 and 2003 PLC (CS) 769.

It is therefore humbly prayed that on acceptance of this application the delay if any in filing the instant appeal may please be condoned.

My this order will decide an application moved by the defendants for rejection of plaint U/O-7 Rule-11 CPC.

Brief facts of the case are that plaintiff brought instant suit for declaration to the effect that she was promoted as senior primary master and through a corrigendum she was appointed in village Hathyan but DEO with malafide and illegally issued another corrigendum by adversely affecting her rights and appointed one Mst.Sakeena Ali in GGHS Hathyan which is illegal. It is also submitted by the plaintiff that defendants be restrained from cancellation corrigendum No.3802-3, dated 02.05.2019 and corrigendum No.5197/99 dated 14.05.2019.

Defendants were summoned. Defendant No.6 appeared and submitted an application for rejection of plaint. Defendants No.1 to 5 also submitted application for rejection of plaint. Replication is submitted by the plaintiff.

I heard arguments from both sides and gone through the available record.

It is to be mentioned here that posting and transfer are the exclusive domain of the concerned authority. If someone is aggrieved from such posting and transfer he can the special forum which is provided for such purpose. According to Article 212 of Constitution of Pakistan whenever special forum is provided for a special task the courts of ordinary jurisdiction will not entertain the matter. Even otherwise according to Section-56-(d) of Specific Relief Act prohibits the grant of injunctions as it will amount to interference in the duties of public department.

For the reasons mentioned above instant plaint is hereby returned to plaintiff with necessary endorsement for presentation the same to the proper forum. No order as to costs.
