JUDGMENT

NIAZ MUHAMMAD KHAN, CHAIRMAN: Arguments of the learned
counsel for the appellant heard and record perused.

FACTS

2. The appellant was dismissed from service on 15.09.2015, against which he filed
departmental appeal on 29.09.2015 which was not responded to and thereafter, he filed the
present service appeal on 11.1.2016. The charge against the appellant as discernible from
the final order is that appointment order of the appellant was fake.

ARGUMENTS

3. The learned counsel for the appellant argued that except final order dated 15.09.2015, nothing was given to the appellant in the shape of charge sheet, statement of allegations, show cause notice, report of enquiry officer etc. That the defence of the respondents was struck off by this Tribunal therefore, all factual controversy shall be deemed to have been admitted by the respondents. That on merits too, no case was made out against the appellant by the department.


4. Since the defence of the respondents was struck off the learned District Attorney submitted that he was not in a position to argue the appeal.

CONCLUSION.


5. As per record available on the file, the department has not complied with the mandatory procedural due processes. In absence of such vital steps condemning the appellant would be unfair and unjust. The very order of dismissal in the first recital speaks about the charge of fake appointment order. But in the third recital it has been mentioned that the appointment has been made against the merits. In the dismissal order there is mention of some enquiry committee but there is no mention of any charge sheet/statement of allegations nor there is any mention of reply of the appellant or the show cause notice or personal hearing.

6. In view of this position this Tribunal is of the view that the whole proceedings are against the law and the dismissal order cannot be sustained in the eyes of law. The present appeal is therefore, accepted and the appellant is reinstated in service. However, the department is at liberty to hold denovo proceedings against the appellant in the light of the

above mentioned observations and rules on the subject within 90 days from the date of receipt of this judgment. The issue of back benefits of the appellant shall be subject to the final outcome of denovo proceedings, if any, and the rules on the subject. Parties are left to bear their own costs. File be consigned to the record room.

EVEN ASSIGNING ANY FAULT TO THE APPELLANT WHICH IS UNLAWFUL, DISCRIMINATORY, WITHOUT LAWFUL AUTHORITY AND AGAINST THE CONSTITUTIONALLY GUARANTEED RIGHTS OF THE APPELLANT, AND A RESULT OF GRUDGE/ MALAFIDE BY THE RESPONDENT NO. 3 REGARDING FILING OF CONSTITUTIONAL PETITION NO. 423-A OF 2014, THIS ACT OF THE RESPONDENTS IS LIABLE TO BE STRUCK DOWN

PRAYER:- ON ACCEPTANCE OF THE INSTANT APPEAL, THE IMPUGNED NOTIFICATION MAY BE SET ASIDE BEING ILLEGAL, VOID, WITHOUT LAWFUL AUTHORITY, DISCRIMINATORY AND AGAINST THE GOLDEN NORMS OF JUSTICE AND DIRECTION MAY BE ISSUED TO RESPONDENTS FOR REINSTATEMENT OF APPELLANT ALONGWITH PAYMENT OF MONTHLY SALARIES TO THE APPELLANT FROM 18/08/2012 TO DATE WITHOUT ANY FURTHER DELAY AND SALARIES IN FUTURE TILL REINSTATEMENT, THE

RESPONDENTS MAY ALSO BE RESTRAINED FROM DOING ANY DISCRIMINATION TO THE OF APPELLANT IN FUTURE AND ALSO REGULARIZE HIM ACCORDING TO RULES.

Respectfully Sheweth: -

Brief facts of the instant writ petition are arrayed as under: -

1. That, the Appellant was duly appointed as Primary School Teacher by competent authority on the recommendation of duly constituted departmental selection committee against the vacant post lying at GPS Nakholi in BPS-07 on dated 18/08/2012. (Copy of publication, merit list and appointment letter are annexed as Annexure "A" to "C").
2. That, after being duly appointed the appellant was medically examined on dated 23/08/2012 and he submitted arrival report at the concerned posted school on dated 18/08/2012. (Copies of medical certificate and arrival report are annexed as Annexure "D" & "E" respectively).

3. That, appellant performed his duties with of devotion and honesty. (Copies of attending register and inspection report by respondent No. 4 and certificate by Head Teacher are annexed as Annexure "F", "G" & "H").
4. That, the appellant was adjusted at GPS Dheri by upgradation order dated 16/07/2013 and appellant was promoted from grade 7 to grade 12 and in compliance the appellant submitted charge report on 17/07/2013. (Copies of upgradation / posting order and charge report are annexed as Annexure "I" & "J" respectively).
5. That, the appellant was assigned Polio campaign duties by ASDEO (respondent No 4) on 12/09/2013 and the appellant performed the same as a regular teacher, along with other teachers. (Copy of order is annexed as Annexure "K").
6. That, through mutual transfer appellant was posted in Danna Sherkool, where appellant is performing his duties with honesty and devotion. (Copies of transfer order, charge report and attendance register are annexed as Annexure "L" to "N").

7. That, the appellant time and again requested the respondents No. 3 & 4 for releasing of his monthly salaries, but of no avail, ultimately an appeal was filed with respondent No. 2. (Copy of application is annexed as Annexure "O").
8. That appellant thereafter filed a writ petition No. 423-A of 2014 before the Honourable Peshawar High Court for release of salary etc., the respondent No. 3 being present in the court stated at the bar that he has approved the release of salary of the appellant, which resulted into disposal of the said petition. (Copy of order is annexed as Annexure "P").
9. That instead of honouring the statement given at the bar, respondent No. 3 created personal hatefulness/ grudge against the appellant and after releasing just three months salary issued the impugned order, the other salaries are still outstanding against the respondents department. (Copy of order is annexed as Annexure "Q").

10. That, appellant again filed a writ petition and the same was withdrawn, upon direction to approach the proper forum. (Copy of writ petition No. 920-A of 2015 and order are annexed as Annexure "R" & "S").
11. That appellant filed a departmental appeal to respondent No. 2, but result of the same is still awaited. (Copy of appeal is annexed as Annexure "T").
12. That there is no other alternate, speedy and efficacious remedy except to invoke the instant appeal, inter-alia, on the following grounds:-

GROUND:-

- a. That releasing in payment of monthly salaries of a government servant is a constitutional guaranteed right, which is infringed by the respondents No. 3 & 4 and upon filing of the writ petition No. 423-A of 2014 they developed grudge against the appellant and malafidely issued the impugned notification which is totally

against the law, justice/ precedents of the superior courts.

- b. That it was the bounden duty of the respondents to pay the salaries to the appellant for which he has been rendering his services regularly.
- c. That, there is nothing adverse against the appellant with the respondent No. 3, which could justify issuance impugned notification.
- d. That, the appellant is a poor man and he is being discriminated with, while issuing the impugned notification after 3 years of service no misconduct or deficiency of appellant was even alleged by the respondent No. 3 against the appellant.
- e. That, the act of the respondent No. 3 is unconstitutional, illegal, unlawful, without lawful authority and violative of the fundamental rights of the appellant.

- f. That the appellant was duly appointed by the competent authority after fulfilling all the criteria for appointment and later on respondents made so many orders for postings/ transfers of appellant and remarks of respondent No. 4 are also available on record regarding performance of appellant.
- g. That other so many employees were appointed by the same authority in the same manner and they are serving in the department. (Copy of reinstatement order of one of them is annexed as Annexure "U").
- h. That appellant is qualified more than the criteria fixed for the post in question. (Copies of testimonials of appellant are annexed as Annexure "V").

It is, therefore, most humbly prayed that on acceptance of the instant appeal, the respondents No. 2 & 3 may graciously be directed to withdraw the impugned notification and issue reinstatement order appellant alongwith payment of the arrears of monthly salaries of the appellant without any further delay alongwith salaries

from issuing of impugned notification till reinstatement and in future restrain from every illegal/ discriminated act to the appellant. Any other relief which this Honourable Tribunal deem fit and proper in the circumstances of the case.

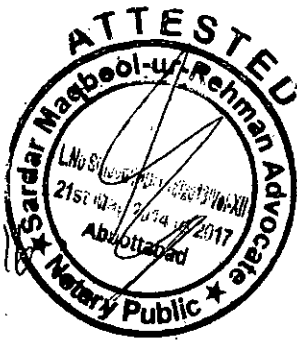

TERMS & CONDITIONS:

1. Their appointments are purely on temporary basis and liable to termination at any stage without assigning any reason/notice.
2. They will be governed by such rules and regulations enforce and as may be prescribed by the Government from time to time for the category of the Government servants to which they belong.
3. In case they failed to assume the charge of their posts within 15 days of their appointment, candidature-ship will be stand automatically cancelled.
4. Their services are regular but will not be entitled for pension/gratuity & they will not contribute any amount towards GP Fund however they will contribute CP fund on the prescribed rate & half contribution will be made by the Government.
5. They will submit to this office, their all testimonial and along-with bank drafts in the name of controller / treasurer of the concerned BISE / University within 7 days after the taking over charge for verification.
6. The release of the pay by the concerned DDOs will be subject to the receipt of verified documents by the appointing authority / (EDO E&SE Manshra)
7. In case a document or documents is / are found fake or forged or Bogus on such scrutiny or all the verification, the service of the teachers concerned shall be terminated. The whole amount paid to him/her as salary will be recovered and a case against him/her shall be registered under relevant section of Law.
8. Their services are liable to termination on one month prior notice from either side in case of resignation without prior notice. Their one month pay/allowances if any shall be forfeited to Government Treasury.
9. Their services can be terminated at any time in case their performance is found un-satisfactory; they will be proceeded against under the removal from service under E&D Rules 2011.
