

SERVICE APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL, 1974 AGAINST THE APPELLATE ORDER DATED 26/12/2023 WHEREBY THE DEPARTMENTAL APPEAL OF THE APPELLANT FOR THE GRANT OF ANTE-DATED PROMOTION TO THE POST OF SUPERINTENDENT I.E. W.E.F. 11/12/2017 HAS BEEN REGRETTED AND AGAINST THE ORIGINAL IMPUGNED NOTIFICATION DATED 12/04/2023, WHEREBY THE APPELLANT WAS PROMOTED TO THE POST OF SUPERINTENDENT (BPS-17) WITH IMMEDIATE EFFECT INSTEAD OF FROM THE DATE WHEN THE IBID POST BECAME VACANT I.E. W.E.F. 11.12 2017.

Prayer:-

That on acceptance of the instant service appeal, the impugned appellate order dated 26/12/2023 may very kindly be set aside and the impugned notification dated 12/04/2023 may very kindly be notified/amended to the extent of anti-dated promotion by directing the respondents to promote the appellant to the post of Superintendent (BPS-17) w.e.f 11.12.2017 with all back benefits including seniority. Any other remedy which this august Tribunal deem fit may also be awarded in favour of the appellant.

R/SHEWETH:

ON FACTS:

- 1) That the appellant was appointed in the respondent department and after appointment, the appellant is serving in the respondent department with zeal and zest to the satisfaction of his superiors. Copy of appointment order is attached as annexure.....A

- 2) That the case for the promotion of the Office Assistant BPS-16 to the post of office Superintendent BPS-17 was submitted to the respondent department for placing before the departmental promotion committee for consideration during October, 2017. Copy of promotion list is attached as annexure.....**B**
- 3) That the above mentioned meeting of the departmental Promotion Committee was convened during October, 2017, but due to some unknown reasons that meeting was postponed and the case of the appellant was not considered for that very promotion though being the senior most employee of the respondents Department the appellant was entitled for promotion to the post of Superintendent. Copy of the Seniority list is attached as annexure**C**
- 4) That the respondent department vide DPC held on 22/12/2022, the appellant was promoted from the post of Office Assistant BPS-16 to Office Superintendent BPS-17. Copy of notification dated 12/04/2023 is attached as annexure.....**D**
- 5) That the appellant was promoted to the post of Superintendent (BPS-17)12/04/2023,instead of due dated i.e., 04/01/2018, on which the incumbent of the post of office super indent was retired.Copy of the working paper of the respondent department is attached herewith as annexure.....**E**
- 6) That the appellant feeling aggrieved from the impugned notification dated 12/04/2023, the appellant filed departmental appeal before the competent authority for grant of ante-dated promotion to the post of Superintendent i.e. w.e.f. 11.12.2017, which was regretted vide impugned appellate order dated 26/12/2023. Copies of departmental appeal and impugned appellate order dated 26/12/2023 are attached as annexure.....**F&G**
- 7) That now feeling aggrieved from both the appellate order dated 26/12/2023 and impugned original order dated 12/04/2023, the appellant preferring the instant Service Appeal before this Honourable Tribunal inter alia on the following grounds:-

GROUND:


- A- That both the appellate order dated 26/12/2023 and impugned original order dated 12/04/2023 are illegal, against the law, fact and circumstances of case.
- B- That the respondents have not treated appellant in accordance with law, rules and policy on subject and acted in violation of

Article 04 & 25 of the Constitution of Islamic Republic of Pakistan 1973, and unlawful refused to promote the appellant to the post of Superintendent (BPS-17), which act of the respondents is unjust, unfair and hence not sustainable in the eye of law.

- C- That non issuance of the ante-dated promotion to the appellant, which is the due right of the appellant is the violative of the Civil Servant Act, 1973 as well as of the Appointment, Promotion & Transfer Rules, 1989.
- D- That the regrettal of the departmental appeal of the appellant by the appellate authority is violative of the precedents of the superior courts, hence liable to be set aside and the appellant be granted ante-dated promotion from the due date.
- E- That the Appellant has not been treated by the respondents in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the constitution of Islamic Republic of Pakistan 1973.
- F- That, the treatment meted out to the Appellant is clear violation of the Fundamental Rights of the Appellants as enshrined in the Constitution of Pakistan, 1973.
- G- That, the Appellant has been discriminated by the respondents on the subject noted above and as such the respondents violated the Principle of Natural Justice.
- H- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal may kindly be accepted as prayed for.



It is therefore prayed that on acceptance of this application the delay in filing the above noted appeal may please be condoned.


