**Para wise Comments On Behalf Of Respondent No. 01 to 03**

**Respectfully Sheweth:**

Respondents humbly submit as under.

**Preliminary objections:**

1) That as per section 8 (4) of civil servants act 1973 "*seniority in a post, service or cadre to which a civil servant is promoted shall take effect from the date of regular appointment to that post;*" while the appellant has been appointed on dated 21-05-2016 so he is clearly low in seniority from the teachers who were regularly appointed prior to him in the year 2012, thus his present prayer in instant service appeal is against the law , rules and policy.

2) That the appellant has never challenged/objected his appointment order and he has rightly been placed in the seniority list according to his date of appointment as mentioned in his appointment order that is 21-05-2016. So his present service appeal for considering him at par with his senior colleagues appointed vide office order dated 25-05-2012 is clearly against the law, rule and policy, hence liable to be dismissed.

- 3) That this Honorable Tribunal lacks jurisdiction to entertain the appeal of the appellant as it is related to the seniority of the period when he was not a civil servant at all, hence liable to be dismissed.
- 4) That the present appeal is also hit by the principle of res-judicata as his matter of appointment has already been redressed through judgment of Honorable Peshawar High Court Peshawar.
- 5) That appellant has not performed any duty or work for the period he is claiming benefits on this ground also he is not entitled for any such relief.
- 6) That the appellant has no cause of action/locus standi to file the instant appeal.
- 7) That no departmental appeal has been filed by the appellant. The one nominal and factious as annexed is also badly time barred.
- 8) That the appellant is concealing material facts from this Hon'ble Tribunal.
- 9) That the service appeal of the appellant is badly time barred, hence liable to be rejected.
- 10) That the appellant was appointed on 21-05-2016 and regularized vide order dated 11-08-2018 with effect from his date of appointment and he is undisputedly performing his duties as such without any objection.

**REPLY ON FACTS:-**

- 1) Para -01 pertains to record.
- 2) Para -02 is correct subject to the explanation that the stance of the petitioner in the mentioned writ petition was properly denied and defended by the respondents on various grounds but the said writ was allowed in favor of the appellant, however there was no such specific directions of retrospective appointment or back benefits etc. in the mentioned judgment, neither the

appellant objected his appointment order issued on dated 21-05-2016 with immediate effect on any forum, he accepted the same and now after passing of about 8 years he is malafidely trying to engage and harass the department through vexatious litigation by claiming that he may be considered at par with his senior colleagues appointed vide office order dated 25-05-2012 is clearly against the law, rule and policy, hence liable to be dismissed. Similarly with due regard it is also stated that this Honorable Tribunal lacks jurisdiction to entertain the appeal in hand being related to the period when appellant was not a civil servant at all and also being hit by the principle of res-judicata.

- 3) Para -03 is correct subject to the explanation mentioned in para 2.
- 4) Para-04 is correct, subject to the explanation mentioned in para 2.
- 5) Para-05 is correct with the explanation that appellant was appointed according to the prevailing law, rule and policy existing at the time of his appointment.
- 6) Para-06 is correct.
- 7) Para 7 is incorrect as the appellant was appointed on 21-05-2016 and regularized vide order dated 11-08-2018 with effect from his date of appointment and he is undisputedly performing his duties as such without any objection while the mentioned colleagues of the appellant were appointed in the year 2012 hence he is junior to them and will be promoted on his due turn subject to his seniority cum fitness.
- 8) Para 8 is incorrect as appellant is junior to the mentioned teachers as all of them have been appointed prior to him and he has never challenged his such

appointment order nor he has objected any previous seniority list. ( Copy of seniority list of 2019 is annexed as A)

9) Para 9 is incorrect, no departmental appeal has been filed by the appellant.

The one nominal and factious as annexed is also badly time barred.

**REPLY ON GROUNDS:**

- A) Ground -A is incorrect. Appellant has been appointed just according to law, rules, policy and judgment of Peshawar High Court Peshawar in year 2016 with immediate effect and he has never object his such appointment order nor he has either object any of the seniority list in the past 6-7 years, now he is malafidely trying to engage and harass the department through vexatious litigation.
- B) Ground -B is incorrect, as appellant has been treated according to law, rules and policy.
- C) Ground -C is incorrect, as appellant has been appointed in compliance of court judgment in the year 2016 with immediate effect, under the then existing law, rule and policy while the other teachers as objected by the appellant were appointed in year 2012, so appellant is clearly junior to them hence he has rightly been placed in seniority list and will be promoted on his turn. Similarly with due regard it is also stated that this Honorable Tribunal lacks jurisdiction to entertain the appeal in hand being related to the period when appellant was not a civil servant at all and also being hit by the principle of res-judicata.
- D) Ground -D is incorrect as seniority to a post is considered from the date of regular appointment so appellant has rightly been placed in seniority list according to law, rules and policy.
- E) Ground -E is incorrect; as no such specific directions of retrospective appointment or back benefits etc. in the judgment of appellant's writ has been given, neither the appellant objected his appointment order issued on dated 21-05-2016 with immediate effect at Honorable High Court, he accepted the


