Learned counsel argued that the appellant was appointed as Arabic Teacher BPS-15 vide order dated 30.08.1995 and performed duty to the entire satisfaction of the respondents. That vide impugned notification dated 26.02.2016 juniors to the appellant (private respondents No. 4 to 7) were promoted to the post of Senior Arabic teacher, while the appellant has been ignored without any cogent reason/justification. 

PRAYER:

That on acceptance of this appeal the impugned Notification dated 18.2.2019 may very kindly be set aside to the extent private respondents and the respondents may kindly be directed to consider the appellant for promotion to the post of Senior Arabic Teacher (BPS-16) w.e.f. 18.2.2019 with all back benefits including seniority. Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.

R/SHEWETH:

ON FACTS:

Brief facts giving rise to the present appeal are as under:-

- 1- That appellant is the employee of the respondent Department and is serving the respondent Department as Arabic Teacher (BPS-15) since 30.8.1995 till date for quite efficiently and up to the entire

satisfaction of her superiors. Copies of the appointment order, charge report, transfer Notification to District Malakand, relieving chit, charge report, domicile certificate are attached as annexure **A, B, C, D, E and F.**

2- That during service in the respondent Department at Malakand the appellant was directed to furnish complete documents along with PER'S for promotion to the next higher scale of BPS-16 (Senior Arabic Teacher). Accordingly the petitioner submitted all the requisite documents before the respondent No.3 and was hop full for her promotion to the post of Senior Arabic Teacher (BPS-16). Copies of the record is attached as annexure **G.**

3- That astonishingly vide impugned Notification dated 18.2.2019 juniors to the appellant i.e. private respondent No.4 to 7 were promoted to the post of Senior Arabic teacher while the appellant was ignored without any reason and clear justification. Copies of the seniority list, impugned Notification, adjustment orders are attached as annexure **H, I and J.**

4- That feeling aggrieved the appellant filed Departmental appeal before the appellate authority but no response has been received so far. That it is pertinent to mention that the respondents acted in arbitrary and malafide manner by ignoring the appellant from promotion just to accommodate their blue persons i.e. private respondents at the station of their choice. Copy of the Departmental appeal is attached as annexure **K.**

5- That appellant feeling aggrieved and having no other remedy filed the instant service appeal on the following grounds amongst the others.

GROUND:

A- That the impugned Notification dated 18.2.2019 issued by the respondent No.2 is against the law, facts, norms of natural justice and materials on the record hence not tenable and liable to be set aside.

B- That the appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.

C- That the impugned Notification dated 18.2.2019 whereby ignoring not granting/allowing promotion to the appellant to the post of Senior Arabic Teacher (BPS-16) is violative of Law and Rules.

D- That the respondents discriminated the appellant on the subject by not promoting the appellant to the post of Senior Arabic Teacher (BPS-16) inspite of seniority and eligibility.

- E- That the respondents acted in arbitrary and malafide intentions by not promoting the appellant to the post of Senior Arabic Teacher (BPS-16) inspite of seniority and eligibility.
- F- That the respondents violated Article 38(e) of the Constitution of Pakistan, 1973 by not promoting the appellant to the post of Senior Arabic Teacher (BPS-16) inspite of seniority and eligibility.
- G- That the impugned Notification dated 18.2.2019 is violative of Section-9 of the Civil servant Act, 1973 read with Rule -7 of the Appointment, promotion and transfer Rules, 1989, hence not tenable and liable to be set aside.
- H- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.

PRELIMINARY OBJECTIONS

1. That the appeal is badly barred by time and under the rules is not maintainable.
2. That the appellant had concealed material facts from the Honorable service Tribunal.
3. That the appellant had got no cause of action to file the instant appeal.
4. That the appellant has got no locus standi to ask for claim.
5. That the appellant is estopped by his own conduct to file the present appeal.
6. That the appeal is not maintainable in its present form and is not competent.
7. That the Honorable Tribunal has no jurisdiction to entertain the appeal.
8. That the instant appeal is bad for mis-joinder/ non joinder of necessary parties.

PARAWISE COMMENTS ON BEHALF OF RESPONDENT NO.1 to 3.

1. Pertain to record.
2. ~~Incorrect~~, the Respondent Department directed all senior AT to furnish their complete documents for the promotion to next higher scale of BPS-16 but the appellant has not submitted her required documents within time while her juniors respondent No 4 to 7 has submitted their documents well on time.
3. Incorrect, as the appellant has not submitted her documents well on time so the Departmental Promotion Committee was unable to decide her promotion case.

4. Not admitted .Departmental Promotion Committee made the promotion purely on the basis of merit in the light of promotion policy of the Government which provides equal opportunity to all on the basis of their seniority ,academic and professional qualification.
5. That the appellant has got no cause of action to file instant appeal.

GROUND

- A. Not admitted, the impugned notification dated 18.2.2019 is not against the law, facts and norms of natural justice. As it is issued after the scrutiny of the Departmental Promotion Committee.
- B. Not admitted, the appellant has been treated in accordance with law and rules by the respondent Department and no violation has been made of the constitution of Islamic Republic of Pakistan 1973.
- C. Not admitted, the notification dated 18.2.2019 provides equal opportunity to all the senior AT teacher on the basis of their academic and professional qualification. Therefore, the appellant has never been deprived of their legal right.
- D. Not admitted, no discrimination has been made with the appellant on the promotion to senior SAT (BPS-16) but the appellant deprived on her own fault when she has not submitted her required documents within time
- E. Not admitted, the impugned notification dated 18.2.2019 issued was not in arbitrary and malafidly but it provides the opportunity of promotion to all SAT of (BPS-16)
- F. As replied in para B.
- G. Not admitted, the impugned notification dated 18.2.2019 is issued according the promotion rules and no violation has been made of Civil servant Act, 1973.
- H. The respondents seek permission of the august court to advance other grounds/evidence at the time of arguments.

It is therefore humbly prayed that in the light of the above facts the present appeal may kindly be dismiss with cost.
