
APPLICATION FOR EARLY HEARING

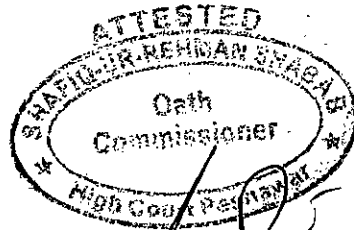
