JUDGMENT

NIAZ MUHAMMAD KHAN, CHAIRMAN: Arguments of the learned counsel for the parties heard and record perused.

FACTS

2. The appellant was removed from service on 19.10.2015 on the basis of her absence. According to the appellant it was communicated to her on 15.11.2015. Against which she filed departmental appeal on 02.12.2015 which was not responded to and thereafter, she filed the present service appeal on 10.3.2016.

ARGUMENTS

3. The learned counsel for the appellant argued that the proceedings were initiated and culminated under Rule 9 of the Khyber Pakhtunkhwa Government Servants (E&D) Rules, 2011.

That under Rule 9 the wilful absence was defined as absence for at least 7 days. That in the show cause notice, no period of absence was mentioned. That in the comments, the respondents mentioned three dates of the absence of the appellant and that these three dates were separate days and not continuous. Secondly, these dates were 18.8.2015, 03.09.2015 and 07.09.2015. That the show cause notice was issued on 11.08.2015. That how the future days of absence were mentioned in the show cause notice. That the whole proceedings are void and are liable to be set aside.

4. On the other hand, the learned District Attorney argued that the present appeal was time barred for the reason that the departmental appeal was also time barred. That the conduct of the appellant showed that she was a habitual absentee. That in the month of September, 2015 she was on maternity leave but her presence was marked in the attendance register, which meant that her attendance was being marked in proxy.


5. In rebuttal, the learned counsel for the appellant argued that the attendance register was being maintained by the school administration and it could not be gathered from the attendance register that in the month of September, 2015 the appellant was present in the school. He referred to the attendance register for the month of November, 2015 and in that register, the appellant was shown to be on maternity leave and that it was duly checked and signed by the responsible officer but the fact was that the appellant had already been removed from service in the month of October, 2015. He wanted to strengthen his arguments that the appellant could not be punished on the basis of such school record and no responsibility could be fixed on the appellant.


### **CONCLUSION.**

6. This Tribunal is first to decide the issue of limitation. According to the appellant she received removal order on 15.11.2015 and according to learned District Attorney it was dispatched on the same day when it was issued. This Tribunal in a number of judgments has held that the communication of the order for the purpose of Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974 is the basic responsibility of the department to prove in case where

the civil servant gives a particular date of its communication. The learned District Attorney argued that the order was endorsed to the appellant on the same day as was apparent from the list of the persons to whom the copies were addressed. But it was for the department to have proved the communication through receipt by the appellant or her authorized agent or by producing a receipt of dispatch through concerned mailing department. The learned District Attorney sought time for producing the dispatch register on the next date to prove the communication. But this Tribunal while going through the file has observed that the very show cause notice which contained a future dates of absence is nullity in the eyes of law and is a void order. No limitation would run against such void order/documents and any order passed on the basis of such documents is a void order as is settled principle of law of limitation. As it has been held above that the show cause notice and the order of termination passed thereon are void which cannot be sustained in the eyes of law. There is no need to discuss other lacunas like satisfaction of the authority regarding wilful absence for a period of 7 days as argued by the learned counsel for the appellant.

7. Consequently, the present service appeal is accepted and the appellant is reinstated in service, however, the department is at liberty to hold denovo proceedings in accordance with law within a period of ninety days from the date of receipt of this judgment. The issue of back benefits shall be subject to the final outcome of denovo proceedings, if any, otherwise, the back benefits shall be decided in accordance with the rules on the subject including the determination of gainful employment etc. Parties are left to bear their own costs. File be consigned to the record room.

8. That the appeal is time barred by law, hence liable to be dismissed on this score alone.
9. That the appellant has remained willful absent from her duty and was terminated after completion all codal formalities hence the appeal is liable to be dismissed without any further proceeding with cost.

**Facts:**

1. **Correct:**
2. **Para No 2:** Relates to the service record of the appellant, however it is the obligation of every civil servant to assume her/his duty whole heartedly wherever and whatever is assigned to him/her. But record shows that she remain willful absent.
3. **Incorrect:** the appellant did not submitted her application for medical leave through proper channel. moreover the appellant was remained deliberately absent from her duty at GGPS Koze Bazargay since long, as per report of ASDEO circle concerned during her surprise visits to the side school on 18-08-2015 and 07-09-2015. Furthermore the appellant insists that she was admitted in hospital for maternity case and has presented her medical certificate as annexure "B" But according to the above mentioned certificate the appellant was admitted in hospital on 03-09-2015 and gave birth to a female baby and was discharged

on 05-09-2015.while on the other hand she was present at her school GGPS Kuze Bazargay on the same days/date as reflected in the school staff attendance register that is annexure "D" page 18 of the service appeal, so it is not only fraud but also concealing of facts from this August service tribunal, hence the instant appeal is liable to be dismissed without any further proceeding.

(Copy of report ASDEO circle concerned/staff attendance register GGPS Kuze bazargay are annexed as annexure A&B)

4. **Para No 4:** is incorrect and baseless. the appellant was remained wilful and habitually absent from her duty, hence she was rightly and legally removed from service vide endstt No 1758-62 dated 19-10-2015.complete reply given in reply to Para No.3

(Termination order is annexed as annexure "c")

5. **Incorrect:** first an absence notice was served upon the appellant by the ASDEO, but the appellant did not response. After that A show cause notice was also served upon the appellant vide office endstt No 1173 dated 11-08-2015. According to rule 9 of KPK Government servant (efficiency and discipline) rule 2011 final show cause notice was also published in

Daily AAJ Peshawar dated 05-09-2015 wherein the appellant was directed to attend the concerned office for personal hearing and put forward her written defense if any but the appellant has neither resumed her duty nor submitted any reply in this regard. Therefore the appellant was terminated from service under E&D rule 2011 on 19-10-2015 by the competent authority.

6. **Incorrect:** no proper procedure has been adopted for filing departmental appeal, as annexure "F" of the instant service appeal is baseless having no date and signature of the appellant no attested copy is attached hence presumed that no departmental appeal is filed .

- a. **Incorrect:** the termination order No 1758-62 Dated 19-10-2015 was passed according to rule and law at the completion of all codal formalities.
- b. **Incorrect:** As termination made according to service rules.
- c. **Para (c) is Incorrect.** Hence denied.
- d. **Incorrect:** wrong.

- e. **Incorrect:** as stated above she was remove form service by competent authority after observing all codal formalities, show cause notice etc.
- f. **Incorrect:** the whole proceeding initiated against the appellant has been completed according to rule and regulation and without any discrimination

**Therefore it is humbly prayed that appeal of the appellant may graciously be dismissed with cost.**


