***On acceptance of this appeal, the respondents be directed to act upon the notification No.12882/EC-1, dated 07.06.2015 forthwith and the appellant's promotion order be revised w.e.f. 27.09.2011 instead of 16.04.2014 and the respondents may further be directed to place the appellant between Akhtar Gul and Fazal Karim in the seniority list of 2011.***

***Any other relief, which not specifically asked for and this Honourable Tribunal may think fit and appropriate may kindly be granted.***

***Respectfully Sheweth:***

***Precisely stating the facts of the case out of which the present appeal arise are as under:-***

1. *That in the earlier round of litigation, the appellant filed Service Appeal No.40/2012 against the impugned order of CCPO, Peshawar dated 19.03.2011, vide which the competent authority on the recommendation of DPC, pleased the appellant as Sub-Inspector on acting charge basis and further that his appeal was not entertained by the appellate authority. The appeal of the appellant was heard and decided vide order/ judgment dated 01.06.2015 by this Honourable Tribunal vide which the case was remitted back to the appellate authority with the direction to treat the same as Departmental Appeal of the appellant and to be decided within a period of one month through speaking order as required by law. (COPY OF THE ORDER DATED 01.06.2015 IS ATTACHED).*
  
2. *That after remanding the case as appeal to competent authority through impugned notification No.1282/EC-1, dated 07.06.2015 revised the promotion order of the appellant from 27.11.2011 instead of 16.04.2014, but till date the competent authority is failed to comply with the said notification, hence the present appeal, inter alia, on the following grounds;*



**GRUNDS:**

- A. *That non-compliance of the aforesaid notification dated 07.06.2015 by the respondents is illegal, without lawful authority, without jurisdiction, malafide and void ab-initio.*
- B. *That the act of the respondents is contumacious, they are intentionally avoiding to obey the notification dated 07.06.2015.*
- C. *That every government official, public functionaries and civilians are under legal obligation to honour the order/judgment of a Court of competent jurisdiction, the respondents by not complying with the same, have not performed their duty in accordance with law.*
- D. *That non-compliance of the order of the Honourable Tribunal, speaks of malafide on the part of respondents and to lower the position of the judiciary in the eye of public at large.*

*It is, therefore, prayed that on acceptance of this appeal, the respondents be directed to act upon the notification No.12882/EC-1, dated 07.06.2015 forthwith and the appellant's promotion order be revised w.e.f.*



While arguing the appeal, it was submitted by the learned counsel for the appellant that though private</p>

respondents No. 5 to 17 were junior to the appellant but they were promoted in preference to the appellant without any reason. He also submitted that name of the appellant was required to have been placed in the seniority list according to the merit list of intermediate result declared by the PTC Hangu but this principle of seniority was ignored and respondents No. 5 to 17 were promoted contrary to the said rules.

4. In rebuttal, learned Government Pleader for the respondents argued that acting charge basis promotion is no promotion in the eyes of law and further that the appellant has not challenged order of regular promotion of the respondents therefore, this appeal was not maintainable on these grounds. It was further argued that no relief can be given to the appellant on the basis of this appeal. The learned Government Pleader also pointed out that in fact the appellant was transferred from district Nowshera to Peshawar in 2008, therefore, he was given his due place in the seniority list of district Peshawar Police. He submitted that the appeal may be dismissed.

5. We have heard arguments of the learned counsel for the parties and perused the record.

6. The record on perusal would show that impugned order dated 19.3.2011 was passed by the CCPO Peshawar whereas departmental appeal of the appellant has also been disposed of by the same authority vide his order dated 28.12.2011 in the following terms:

"The case of ASI Muhammad Nawaz Khan was examined and filed.

Evidently no reason whatsoever has been given in the above order by the authority on the basis of which departmental appeal of the appellant was rejected. Under Section 24-A of the General Clauses Act, the authority was required to have given reason for his order and thus on the parameters of the said section of law, the said order is faulty and requires indulgence of this Tribunal. Hence, order dated 28.12.2011 of the CGPO Peshawar on appeal of the appellant is set aside. The case is remitted to the appellate authority to be treated as departmental appeal of the appellant and to be decided within a period of one month through a speaking order as required by the law. The appeal is disposed of accordingly. Parties are left to bear their own costs. File be consigned to the record room.
