Prayer in appeal:

On acceptance of the instant Service Appeal, both the impugned transfer order dated 06/12/2023 and 22/02/2024 of respondents No. 2 and 3 may kindly be set aside and consequently the appellant may kindly be allowed to continue her service in GGPS Shamtiaz Kala Khel, Bannu and respondents may further be directed to release the salary of the appellant for the end of justice.

Respectfully Sheweth:

That appellant humbly submits as under:

- 1. That the appellant is peaceful and law abiding citizen of Pakistan and is entitled for all the rights guaranteed by the Constitution of Islamic Republic of Pakistan, 1973. (Copy of CNIC is attached as annexure "A").
- That earlier the appellant was transferred and posted from GGPS Hala Din Murib Baka Khel to GGPS Shamtiaz Kala Bannu vide joint office order

No. 828-34 dated 28/01/2022. (Copy of joint transfer order is attached as annexure "B").

- 3. That since the above transfer and posting order the appellant perform her duties with full division and zeal and no complain has been made whatsoever against the appellant and her entire service.
- 4. That on 27/11/2023 the appellant was seriously sick and examined by the doctor of Khalif Gul Nawaz Hospital Bannu and also advised a 20 days bed rest, hence appellant submitted application to respondent No. 3 on the same day i.e. 27/11/2023 for medical leave accordingly the medical leave has been sanctioned vide office order No. 14709-14 dated 14/12/2023 in this respect the respondent also made entry in the relevant register. (Copies of medical recites, leave application, sanction order dated 14/12/2023 and relevant register pages are attached as annexure "C").
- 5. That despite the sanction medical leave granted by respondent No. 3 the head teacher of the subject school absented the appellant from her duty since

4

28/11/2023 till 16/12/2023 with malafide intention and some ulterior motives, because in fact the head teacher namely Ramzana Bibi and her two sisters namely Nasreen Begum and Gul Samina also perform their duties as School Teacher in the same school, hence due to the above gathering the head teacher willfully absented the appellant from her duty. (Copies of attendance register pages are attached as annexure "D").

- 6. That in the above mentioned facts and circumstances the respondent No. 3 illegally issued impugned premature transfer office order No. 14496-100 dated 06/12/2023 of the appellant without any reason and justification. (Copy of the impugned order dated 06/12/2023 is attached as annexure "E").
- 7. That the appellant aggrieved from the impugned order No. 14496-100 dated 06/12/2023 of the respondent No. 3, submitted departmental appeal before respondent No. 2 on 01/01/2024 which was regretted by the appellant authority vide office order No. 3457-59 dated 22/02/2024. (Copies of



departmental appeal and impugned appellate order dated 22/02/2024 are attached as annexure "F").

8. That the appellant is highly aggrieved from both the impugned office orders dated 06/12/2023 and 22/02/2024 of respondents No. 2 and 3 knock the doors of this Hon'ble Tribunal on the following grounds inter-alia:


GROUNDS:

- A. That both the impugned transfer office order dated 06/12/2023 and 22/02/2024 of respondents No. 2 and 3 are illegal, against the Posting Transfer Rules and also based on malafide intention, hence liable to be set aside.
- B. That so-called Show Cause Notice No. 25-30 dated 01/01/2024 issued by the respondent No. 3 to the appellant is based on ridicules allegations against the appellant which was thoroughly responded by the appellant, according to reply submitted by the appellant, the appellant never come late to her duties in her entire service, furthermore a proper NOC was obtained from respondents for M.Phil Studies, more so in respect of other allegations misbehavior, misconduct and harassment, the respondent No. 3 having nothing in black in whit in her hand except the bear allegations against the appellant. (Copies of show cause notice, reply of



show cause notice and NOC are attached as annexure "G").

- That respondents No. 3 and 4 issued a letter dated C. 27/12/2023 to the bank concerned for stoppage of pay / salary of the appellant, so on the direction of respondents No. 3 and 4 the monthly salary from December 2023 is frizzed/ stopped by the Bank concerned, the appellant submitted an application on 21/01/2024 for release of her salary to respondent No. 3 but in vain, thus the act and action of the respondents are illegal, unlawful and against the Service Rules. (Copies of salary stoppage order and application of appellant dated 21/01/2024 are attached as annexure "H")
- D. That the fundamental rights of the appellant has blatantly violated by the respondents and the appellant has been discriminated and has been denied his due rights which is protected under the Constitution of Islamic Republic of Pakistan, 1973.
- E. That the appellant is not treated in accordance with law, rules and regulations.



G. That any other ground can also, be taken with permission of this Hon'ble Tribunal during the arguments.

It is, therefore, humbly prayed that on acceptance of the instant Service Appeal, both the impugned transfer order dated 06/12/2023 and 22/02/2024 of respondents No. 2 and 3 may kindly be set aside and consequently the appellant may kindly be allowed to continue her service in GGPS Shamtiaz Kala Khel, Bannu and respondents may further be directed to release the salary of the appellant for the end of justice.
