Respectfully Submitted:

- 1. That the subject captioned case is pending adjudication before this Honorable Tribunal and is fixed for 11-08-2023. The contents of the appeal may be read as part and parcel for the determination and decision of the instant appeal.
- 2. That the appellant has a prima facia case and balance of convenience also lies in favor of appellant.
- 3. That a letter has been issued by the Establishment Department on 07-07-2023 regarding the streamlining of Provincial Selection Board (PSB) meetings. According to the said letter, the PSB meeting is expected to be held in first week of August 2023, and working papers have been sought from all the Administrative Secretaries to enable promotions to take place.
