That petitioner submits following para wise Rejoinder as under.

## **Preliminary Objections**

- 1. Para No 1 is incorrect. Appellant has the locus Standi to file the appeal.
- 2. Para No 2 is incorrect. Appellant has the cause of action.
- 3. Para No 3 is incorrect. Appellant is before Hon'ble Tribunal with clean hands.
  - 4. Para No 4 is incorrect. Appeal is within time.
  - 5. Para No 5 is incorrect. There is no question of non-joinder and misjoinder
  - 6. Para No 6 is incorrect. Appel is in proper form and is in accordance with law.



# Rejoinder to Reply on Facts.

- 1. Paras 1 to 3 need no reply.
- 2. Para No 4 is incorrect. In fact, appellant has annexed with appeal the posting order of his wife from which it is evident the wife of appellant is serving in Education Department and is posted in South Waziristan.
- 3. Para No 5 is incorrect. The transfer of appellant is on political basis and not in public interest. The appellant was transferred against the policy. More so, the private respondent No 4 was not eligible for posting as Executive Engineer rather he was promoted as Technical Officer. He was illegally posted as Executive Engineer and then Appellant was illegally transferred and private respondent No 4 was assigned additional charge of the post of Executive Engineer PHE South Waziristan Division at Tank. Copies of relevant record are Annexed
- 4. Para No 6 is incorrect.
- 5. Para No 7 is incorrect. Appellant has been transferred in violation of the policy.

#### **GROUNDS**

- **A.** Reply to the ground **A** is incorrect. This is candidly clear form the record that appellant was victimized and was transferred against the policy.
- B. Reply to ground B is incorrect and against the record.
- **c**. Reply to ground **C** incorrect and denied.
- **D.** Reply to ground **D** is incorrect and denied. Detail response has been given in preceding paras.

- Reply to the ground **E** is incorrect and denied. Respondents have transferred the appellant illegally and in violation of policy. Having no alternate efficacious remedy appellant has availed legal remedy
- F. Reply to the grounds **F to I** are incorrect and denied. Detail response has been given in preceding paras.

It is therefore submitted that this rejoinder may graciously be considered in the just disposal of Appeal.
