- 4. As against that learned District Attorney argued that the appellant is holding a District Cadre Post whereas only the Private Secretaries performing their duties in different departments in Khyber Pakhtunkhwa Civil Secretariat, are eligible to be promoted as PMS Officers against 20 % quota.
 - 5. Arguments heard. File perused.
 - 6. The appellant was appointed as Stenographer against the

vacancy accrued at district level and was also promoted as Private Secretary to fill up the vacancy at district level.

- 7. The appellant has annexed the seniority lists of Private Secretaries & Personal Assistants with memo of appeal and pleaded that his name should have been included in the joint seniority list. Perusal of the said seniority lists would show that only those Private Secretaries & Personal Assistants are mentioned therein who are working in different departments of Khyber Pakhtunkhwa Civil Secretariat.
- 8. From the perusal of record and arguments from both sides, this Tribunal came to the conclusion that against the vacancies of PMS Officers (BS-17), 20% quota is reserved for those Superintendents/Private Secretaries who are performing jobs in different departments in the Khyber Pakhtunkhwa Civil Secretariat.
- 9. As a sequel to above, the appellant has not been able to seek indulgence of this Tribunal. Consequently the present service appeal is dismissed. Parties are left to bear their own costs. File be consigned to the record room.



THE NORTH-WEST FRONTIER PROVINCE PROVINCIAL MANAGEMENT SERVICE RULES, 2007.

- 1. Short title and commencement.—(1) These rules may be called the North-West Frontier Province Provincial Management Service Rules, 2007.
 - (2) These rules shall come into force at once.
- 2. <u>Definitions</u>:—In these rules, unless the context otherwise requires, the following expressions shall have the meanings hereby respectively assigned to them, that is to say-
 - (a) "appointing authority" means the appointing authority as specified in rule 5 of these rules;
 - (b) "Commission" means the Public Service Commission; North-West Frontier Province
 - (c) "Department" means the Establishment and Administration
 - (d) "Departmental Examination" means the prescribed examination to be conducted by the Department for confirmation within probationary period or for promotion to higher post, as the case may be
 - (e) "Departmental Training" means any training prescribed by Government, the successful completion whereof is necessary for promotion to BS-18 and BS-19:
 - (f) "Schedule" means the Schedule appended to these rules:
 - (g) "Service" means the Provincial Management Service;

- (h) "Secretariat" means the North-West Frontier Province Civil Secretariat as defined in rule 2(r) of the North-West Frontier Province Government Rules of Business. 1985; and
- (i) "share" means the share specified for distribution between All Pakistan Unified Group and Provincial Officers as per Schedule-III.
- 3. Nomenclature of the posts.—The Service shall consist of the posts as specified in Schedule-I.
- 4. Method of recruitment. (1) The method of recruitment, minimum qualification, age limit and other matters related thereto for the Service shall be as given in Schedule-1.
- (2) Fifty per cent of posts in BPS-17 shall be filled in by initial recruitment through Commission and remaining by promotion. Ten percent of Secretariat posts in BPS-17 to 19 shall be reserved for officers of technical departments on reciprocal basis. Government may reserve twenty per cent posts for leave, deputation and training etc in each pay scale.
- (3) Posts specified in Schedule-II shall be filled in by Officers borne on Provincial Management Service and All Pakistan Unified Group in the ratio prescribed in Schedule-III.
- 14-A. <u>Training.</u>— On appointment to the post borne on the service in BS-17, whether by initial recruitment or by promotion, every officer so appointed shall successfully complete one and a half year's mandatory training including one year training at the Provincial Services Academy as per Module specified in Schedule-IV and six months training attachment as specified in Schedule-V. The training will be followed by Departmental Examination to be conducted by the Provincial Services Academy as specified in Schedule-VI.
- 5. <u>Appointing Authority.</u>—The Chief Minister, N.-W.F.P. shall be the appointing authority for posts borne on the Provincial Management Service specified in Schedule-I.
- 6. <u>Saving.</u>—In all other matters not expressly provided for in these rules, the members of the Service shall be governed by the North-West Frontier Province Civil Servants (Appointment, Promotion and Transfer) Rules, 1989, and any other rules pertaining to terms and conditions of service made or deemed to have been made under the North-West Frontier Province Civil Servants Act, 1973 (N.-W.F.P. Act No. XVIII of 1973).
- 7. <u>Transitional:</u> The condition of graduation as laid down in para 2(a) and (b) of column-5 against serial No. 1 of Schedule-I shall not apply for a period of seven years from the date of coming into force of these rules to the existing incumbents for promotion against.
- 8. Repeal.---The North-West Frontier Province Provincial Civil Service (Secretariat/Executive Group) Rules; 1997 shall stand

repealed after the retirement of existing incumberts of both the cadres. Separate, seniority, list of both the cadres shall be maintained under the existing rules and they shall be promoted at the ratio of 50: 50: ²[Provided that for the purpose of promotion of both the Secretariat Group and the Executive Group; of the said service in different pay scales.

(i) the incumbents shall continue to be governed by the said service rules till the retirement of the last such incumbent; and (ii) the last incumbent of either Group shall rank senior to the first incumbent of the Provincial Management Service.)





No.SOE.II(ED)2(14)2007: In exercise of the powers conferred by section 26 of the North-West Frontier Province Civil Servant Act, 1973 (N.-W.F.P. Act XVIII of 1973), the Chief Minister of the North-West Frontier Province is pleased to make the following rules, namely:

THE NORTH-WEST FRONTIER PROVINCE PROVINCIAL MANAGEMENT SERVICE RULES, 2007.

- **1.** Short title and commencement.---(1) These rules may be called the North-West Frontier Province Provincial Management Service Rules, 2007.
 - (2) These rules shall come into force at once.
- 2. <u>Definitions.</u>---In these rules, unless the context otherwise requires, the following expressions shall have the meanings hereby respectively assigned to them, that is to say-
 - (a) "appointing authority" means the appointing authority as specified in rule 5 of these rules;
 - (b) "Commission" means the North-West Frontier Province Public Service Commission;
 - (c) "Department" means the Establishment and Administration Department;
 - (d) "Departmental Examination" means the prescribed examination to be conducted by the Department for confirmation within probationary period or for promotion to higher post, as the case may be;
 - (e) "Departmental Training" means any training prescribed by Government, the successful completion whereof is necessary for promotion to BS-18 and BS-19;
 - (f) "Schedule" means the Schedule appended to these rules;
 - (g) "Service" means the Provincial Management Service;

- (h) "Secretariat" means the North-West Frontier Province Civil Secretariat as defined in rule 2(r) of the North-West Frontier Province Government Rules of Business, 1985; and
- "share" means the share specified for distribution between All Pakistan Unified Group and Provincial Officers as per Schedule-III.
- 3. <u>Nomenclature of the posts.</u>—The Service shall consist of the posts as specified in Schedule-I.
- **4.** <u>Method of recruitment.</u>---(1) The method of recruitment, minimum qualification, age limit and other matters related thereto for the Service shall be as given in Schedule-I.
- (2) Fifty per cent of posts in BPS-17 shall be filled in by initial recruitment through Commission and remaining by promotion. Ten percent of Secretariat posts in BPS-17 to 19 shall be reserved for officers of technical departments on reciprocal basis. Government may reserve twenty per cent posts for leave, deputation and training etc in each pay scale.
- (3) Posts specified in Schedule-II shall be filled in by Officers borne on Provincial Management Service and All Pakistan Unified Group in the ratio prescribed in Schedule-III.
- ¹4-A. <u>Training</u>.— On appointment to the post borne on the service in BS-17, whether by initial recruitment or by promotion, every officer so appointed shall successfully complete one and a half year's mandatory training including one year training at the Provincial Services Academy as per Module specified in Schedule-IV and six months training attachment as specified in Schedule-V. The training will be followed by Departmental Examination to be conducted by the Provincial Services Academy as specified in Schedule-VI.
- **5.** Appointing Authority.—The Chief Minister, N.-W.F.P. shall be the appointing authority for posts borne on the Provincial Management Service specified in Schedule-I.

Act No. XVIII of 1973).
- 7. <u>Transitional:-</u> The condition of graduation as laid down in para 2(a) and (b) of column-5 against serial No. 1 of Schedule-I shall not apply for a period of seven years from the date of coming into force of these rules to the existing incumbents for promotion against BS-17 posts.
- 8. Repeal.---The North-West Frontier Province Provincial Civil Service (Secretariat/Executive Group) Rules, 1997 shall stand



In view of above Para wise comments of above mentioned grounds and facts, it is humbly requested that the appeal of the appellant is baseless and carries no grounds may please be dismissed.

PRELIMINARY OBJECTIONS.

- 1. The Appellant has got no locus standi to bring the amendment service appeal.
- 2. The Appellant is estopped by his own conduct to bring the present amendment Appeal as the respondents has already filed the comments before the Service Tribunal.
- 3. The amended appeal is not maintainable in its present form.
- 4. The appellant has no cause of action to file the instant amendment appeal.

COMMENTS ON BEHALF OF RESPONDENTS NO.

- 1. Pertains to record, hence no comments.
- 2. Pertain to records. Beside, at this stage, the appellant has no locus standi to bring the instant amendment appeal as the respondent has already filed comments before the Service Tribunal in the service appeal. Therefore, amended appeal at this belated stage cannot be entertained after expiry of 2 years.
- 3. Pertains to record, hence no comments.
- 4. As in preceding para.
- 5. As in para-2 above.
- 6. Pertain to records of the Establishment Department. However, seniority list attached with the appeal pertains to the employees of Civil Secretariat and appellant neither can claim promotion on the basis of seniority of civil secretariat nor can claims to be inducted in the seniority list of civil secretariat being employee of the District.
- 7. Pertains to record.
- 8. Pertain to the record of Establishment Department. His name cannot be included in the seniority list of Civil Secretariat as he is employee of the District Mardan.
- 9. The appellant should have to approach SMBR being Competent Authority; rather he straight away filed representation directly to Chief Secretary, Khyber Pakhtunkhwa.
- 10. Pertains to Establishment Department
- 11. As in para 8 above.

12. In correct, promotion cannot be claimed as a matter of right as question of suitability of promotion is within the exclusive domain of the Government authority. As per Supreme Court judgment 2005 SCMR 1742 wherein it was held that "Promotion is neither a vested right nor it can be claimed with a retrospective effect whenever there is a change of grade or post for the better, there is an element of selection involved which is promotion and it is not earned automatically, but under an order of the competent authority to be passed after consideration of comparative suitability and the entitlement of those incumbents.

Likewise Apex Supreme Court of Pakistan in 2000 SCMR 1056, 2001 SCMR 1446: held that it is the domain of government to determine question of suitability and fitness of an employee for promotion.

Question of suitability for promotion is within the exclusive domain of the government authority.

GROUNDS.

- A. In correct. The appellant cannot claim seniority in the list of civil secretariat as he is employee of District/Division. Rest as per para-12 of the facts.
- B. As in preceding para.
- C. Incorrect. As per para-12 of the facts.
- D. As per para-12 of the facts.
- E. Incorrect. As per para-A above of the grounds.
- F. Respondents also have the right to submit further clarification at the time of arguments.

In view of the above, as well as on the grounds that at this stage, the appellant has no locus standi to file the instant amendment appeal as the respondents has already filed comments before the Service Tribunal in the service appeal, therefore, amended appeal after expiry of 2 years, after filing the comments of respondent, carries no grounds and not maintainable which may be dismissed.
