This order will dispose off appeal of Ex-Constable Babar Hussain No. 2287 of Swat District for reinstatement in service.

Brief facts of the case are that Constable Babar Hussain No.2287 while posted to Police Station Mingora was alleged of gross misconduct as it was reported that the appellant was habitual absentee and did not take interest in his job. An index showing 210 days absence of the delinquent Constable on various occasions was sent to DPO office by SDPO City with the request to take strict action against the delinquent Constable. He was issued Show Cause Notice to explain his position but the reply to the show cause notice was found unsatisfactory. He was also called in orderly room and heard him in person but he failed to produce any cogent reason in his defense. Perusal of the record had revealed that the delinquent Constable was habitual absentee. He has addictee to chronic absenteeism and did not give up his indiscipline attitude despite repeated warnings. He has earlier been issued several Show Cause Notice and subsequently warned to mend his ways and become an efficient Police Officer but no avail. His conduct was detrimental to discipline and his further retention in Police was bound to negatively affected attitude of other personnel. Being found guilty of the charges leveled against him, he was awarded major punishment of dismissal from service vide OB No.125 dated 02/08/2019.

He was called in Orderly Room on 23/10/2019 and heard him in person. In his short service about 5/6 years, 210 days absence from his lawful duty in discipline force clearly indicate that he is not fit for Police service. Apart from this, he was once reinstated into service on compassionate ground by the then RPO Malakand, but that sympathy also could not mend his way. The appellant also failed to produce any cogent reason in his defence. Therefore his appeal for reinstatement in service is hereby filed.


