

JOINT PARAWISE COMMENTS ON BEHALF OF RESPONDENTS No: 3.

Respectfully Sheweth,

The Respondent No. 3 submit as under:

PRELIMINARY OBJECTIONS.

- 1 *That* the Appellant has got no cause of action.
- 2 *That* the appellant is not an aggrieved person within the meaning of Article 212 of the constitution of Islamic Republic of Pakistan.
- 3 *That* the appellant has concealed material facts from this Honorable Tribunal.
- 4 *That* the Appellant has not come to this Honorable Court with clean hands.
- 5 *That* the appeal in hand is based on mala fide intentions for illegal service benefits.
- 6 *That* the matter in hand is barred by law in view of the law of limitation Act 1908.
- 7 *That* the case is bad for mis-joinder and non-joinder of the necessary parties.
- 8 *That* the impugned Notification dated 22-02-2019 is within legal parameter and liable to be maintained in favor of the Department.
- 9 *That* the appellant is not entitled for promotion to the post of SST (B/C) BPS-16 w.e.f 28-10-2014 instead of w.e.f 22-02-2019.
- 10 *That* no Departmental Appeal has been filed by the appellant to the appellate authority against the Notification dated 22-02-2019 by the appellant, hence, got finality under the law.

ON FACTS.

- 1 That Para-1 is pertain to the service record of the appellant against the CT post appointed vide Notification dated 07-10-1989 *attached as Annexure-A.*
- 2 That Para-2 is also pertains to the service record of the appellant against the SCT in BPS-16 (P) promoted vide Notification dated 21-02-2013 *attached as Annexure-B.*
- 3 That Para-3 is correct that vide Notification dated 28-10-2014, the Respondent was allowed promotions & the eligible candidate full filling the criteria of seniority cum fitness by leaving the appellant on the grounds that he could not made out his case for promotion in the above Notification dated 28-10-2014, and due to the lack of prescribed length of service and even seniority cum fitness in the Respondent Department for his promotion to the post of SST (B/C) BPS-16 with reference to the Notification NO. SO (PE)/4-5/SSRE/meeting/2013/Teaching Cadre dated 24-07-2014. *(Copy of the Notification dated 28-10-2014 is Annexure-C).*
- 4 That Para-4 is incorrect as no Departmental Appeal has been filed by the appellant against the Notification dated 28-10-2014 by the appellant to the appellate authority, hence, got finality against the appellant under the rules.
- 5 That Para-5 is correct that vide Notification dated 22-02-2019, the appellant has been promoted to the post of SST (B/C) BPS-16 on the basis of his seniority under section-8 of Civil Servant Act 1973 and fitness basis in the Respondent Department. *Copy of the Notification dated 22-02-2019 is attached as Annexure-D.*
- 6 That para-6 is also incorrect as no Departmental Appeal against the Notification dated 22-02-2019 has been filed by the appellant till date, hence, got finality under the Law & Limitation Act 1906 against the appellant therefore the appeal in hand is liable to be dismissed on the following grounds inter alia:

ON GROUNDS.

- A. Incorrect & not admitted, the Notification dated 22-02-2019 is in accordance with Law, Rules and promotion policy in terms of reserved quota notified vide Notification dated 24-07-2014.
- B. Incorrect & not admitted. The act of the Department with regard to the Notification dated 22-02-2019 is in line with the provisions of Articles 4 & 25 of the constitution of 1973.
- C. Incorrect & not admitted. The appellant was not in the promotion zone and criteria in terms of the promotion Rules dated 24-07-2014 at the time of the issuance of the Notification dated 28-10-2014 by the Department.

- C. Incorrect & not admitted. The appellant was not in the promotion zone and criteria in terms of the promotion Rules dated 24-07-2014 at the time of the issuance of the Notification dated 28-10-2014 by the Department.
- D. Incorrect & not admitted, the plea of the appellant is against the facts and policy under reference, hence, denied.
- E. Incorrect & not admitted, the Notification dated 22-02-2019 is in accordance with the provisions Section-9 of Civil Servant Act 1973 and even Rules-7 of APT Rules 1989.
- F. Incorrect & not admitted. The appellant is not entitled for promotion as SST (Bio/Chm) BPS-16 post w.e.f. 22-02-2019 in view of his seniority cum fitness in the Department.
- G. Incorrect & not admitted, the appellant has no valid cause of action to file the titled appeal before this Learned Tribunal. Therefore, the Respondents No. 1-3 also seek leave of this Honorable Tribunal to submit additional record, grounds and case law on the date fixed.

PAYERS:

Therefore, in view of the above made submissions, the appeal in hand may kindly be rejected in favor of the Department in the interest of justice.

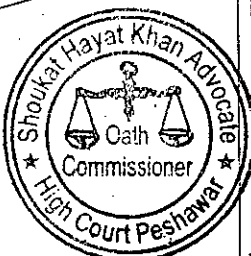


