


3. The Departmental Promotion Committee considered the agenda point and made the following decisions in the case: -


S#	NAME	RECOMMENDATIONS

6. ✓	Imran Ahmed	Recommended for promotion as Assistant Director I.T (BS-17) on regular basis.



5. Meeting ended with a vote of thanks from and to the Chair.


