### Factual Objections

- 1. Para No. 1 is correct.
- 2. Para No. 2 pertains to record.
- 3. Para No. 3 pertains to record. .
- 4. Reply of Para No. 4 is that the appellant / Ali Mar Khan Ex-Driver filed Civil Suit No. 292/1 of 2020 dated 09/12/2020 in the court of Civil Judge-II, Karak for claiming his D.A bills Rs. 217513/ and Rs. 27807/- In response of the above mentioned civil suit, the present respondents No. 3 & 4 have submitted written statement stated therein that none payment of the D.A Bills as claims by the appellant is more than 03 years old hence required sanction of investigation of

arrears and as per KPK Delegation of Financial Powers Rules, 2018 the respondent No. 3/ DEO (Male), Karak has no competency to proceed the D.A bills which are more than 03 years old, therefore, his D.A bills/claims were sent by the respondent No. 3/DEO (M), Karak letter vide letter No. 1252-53 dated 24/03/2021 is annexed as **Annexure "A"**).

The case D.A bills of appellant was under process before the Director Elementary Education Department KP, Peshawar and during the pendency of the above titled suit the then District Education Officer (Male), Karak Mr. Sheraz Ahmad was summoned by the court of learned Civil Judge-II, Karak and verbally directed to solve the matter in dispute. (Photocopy of civil suit, written statement is available on page No. 95 to 99 of the above titled appeal).

The then District Education Officer (Male), Karak Mr. Sheraz Ahmad constituted inquiry committee consist of Faridullah Shah Principal BPS-19 HSS Jandari Karak and Abdul Haleem Principal BPS-19 GHSS Jehangiri Karak to probe into the matter of pending D.A bill in respect of appellant, vide office order bearing Endst: No. 923-24 dated 22/02/2022 is annexed as Annexure "C").

The inquiry committee submitted his inquiry report to then District Education Officer (Male), Karak/ Sheraz Ahmad which is self explanatory and as per recommendations, the appellant is reluctant to submit affidavit to the effect that the claims has not already been drawn, however, in light of the recommendations of inquiry committee, the DA bills were sent to Ex- District Education Officer (Male), Karak Mr. Taus Khan and Mr. Abdus Salam now retired for the concerned period for counter-signature vide letter No. 155 dated 09/04/2022 and letter No. 156 dated 09/04/2022. (Photocopy of inquiry report and letters for counter-signatures are attached as Annexure "D & E" respectively).

The Ex-District Education Officer (Male), Karak now Principal Paharpur re-send the revised tour programs of his concerned period in respect of appellant vide letter No. 215 dated 17/05/2022 but the retired DEO





### Facts & Findings:-

- 1. Mr. Ali Mar Khan Ex-driver of the DEO (M) office Karak was retired from service on 03/03/2018(AN).
- 2. As per his statement, his TA/DA bills for period 08/2015 to 02/2018 are pending in the DEO (M) office Karak.
- 3. In this regard he has filed a suit in the Honorable Court of Senior Civil Judge Karak.

#### Conclusion:-

After through observation of the case, we the committee members came to the conclusion

- 1. His pending TA/DA bills for various periods are not counter signed by the DEO, s of the concerned periods. Proper counter signature by the DEO, s of the concerned periods is required.
- 2. Routine budget under Head A03805-TA/DA for the current financial year (2021-2022) is not sufficient to meet out his claims.
- 3. His pending TA/DA bills need investigation sanction from the competent authorities.
