Appeal u/s 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974 against the impugned final seniority list issued by the office of respondent No.3 in respect of CT-IT Teacher Mansehra (BPS-12) against which departmental appeal dated 03.12.2023 was filed before the respondent No.3 i.e. DEO (male) Mansehra, but the same has not been responded despite lapse of statutory period of 90 days, hence presents the instant Service Appeal within 30 days, which is well within time.

#### Prayer:

acceptance of this appeal, On impugned seniority list of CT-IT Teachers (BPS-12) be (male) prepared accordance with proviso to Section-4 Sub Section-2 of Appointment and Regularization of Services Act, 2017 and in the light of recently delivered judgment dated 31.05.2023 S.A.No.2069/2019 titled Abid Noor v/s Director E&SE by declaring the appellant senior to private respondents No.4 to 11.

Any other relief which this Hon'ble Tribunal deems appropriate may kindly be granted

#### Respectfully Sheweth;

Brief facts giving rise to the instant service appeal are as under:-

1) That the appellant was appointed vide order endorsement No.PM-IT/E&SE/1-3/500-IT-Labs/Rectt/Lab-Male/ 2016 dated 19.07.2016 as Computer Lab. Incharge (BPS-7) on contract basis.

(Copy of appointment order dated 19.07.2016 is attached as Annex: "A").

2) That the services of appellant and private respondents No.4 to 11 were regularized vide notification Endst:No.12808-44 dated 10.09.2018 issued by respondent No.3.

(Copy of regularization order is attached as Annex: "B").

That the services of appellant and private respondents No.4 to 11 were regularized in terms of section-3 of Khyber Pakhtunkhwa Employees of Elementary and Secondary Education Department (Appointment and Regularization Services) Act, 2017.

(Copy of appointment and regularization of services Act, 2017 is attached as Annex: "C").

4) That as per proviso to Section-4 Sub Section 2 of Act 2017 speaks about "<u>Determination of Seniority</u>" which states and the same is reproduced in verbatim for the ready reference of this Honourable Tribunal.

#### Section-4 "Determination of Seniority 1.....

"2 The seniority inter-se of those employees, whose services are regularized under this Act within the Cadre, shall be determined on the basis of their continuous service in Cadre:

Provided that if the date of continuous service in the case of two or more employees is the same, the employee older in age shall rank senior to the younger one"

- 5) That It is pertinent to mention that the date of birth of the appellant is 01.01.1990 who is senior in age than private respondents No.4 to 11, whom date of birth are as under:
  - i) Gul Khan, DOB 13.01.1992 (respondent No.4)
  - ii) Gulfaraz, DOB 03.05.1990 (respondent No.5)
  - iii) Masood Ahmad DOB 01.01.1992 (respondent No.6)
  - iv) Majid Hussain DOB 05.01.1991 (respondent No.7)
  - v) Zaid Iqbal DOB 20.12.1991 (respondent No.8)
  - vi) Shaffat Ahmad DOB 16.02.1995 (respondent No.9)
  - vii) Bilal Ahmad DOB 02.04.1990 (respondent NO.10)
  - viii) Fayzan DOB 02.03.1991 (respondent No.11).
- That as per final seniority list of CT-IT teachers (Male) the appellant is appearing at serial No.22 while the private respondents No.4 to 11 are appearing at Sr. No.7,8,11,12,16,19, 20 and 21.

It is pertinent to mention that the final seniority list was received on 01.12.2023 by the appellant without formerly communicating the same to him through proper channel.

### (Copy of seniority list of CT-IT Teachers is attached as Annex: "D").

7) That the appellant preferred his departmental appeal dated 03.12.2023 before respondent No.3 i.e. DEO (Male) Mansehra KP, Peshawar to fix his seniority in accordance with the proviso to section 4 (2) Regularization Act, 2017, but the same has not been responded till date, despite lapse of statutory period of 90 days.

### (Copy of departmental appeal dated 03.12.2023 is attached as Annexure "E").

8) That the appellant feeling aggrieved against the seniority list as referred to in Para No.6 being shown Junior to the employees/ respondents No.4 to 11 as mentioned in the para-5 above, hence constrained to file the instant Service Appeal for correction of seniority list and enlisting the name of the

appellant at his due place, on the following amongst other grounds.

#### **GROUNDS OF APPEAL:**

- a) That the impugned seniority list is against the law, facts and material available on record.
- b) That as per <u>Proviso to Section-4 Sub Section 2 of Appointment and Regularization of Services Act, 2017</u> the appellant claim is fully justified and entitled to be ranked senior to respondents No.4 to 11, because the appellant is senior in age in terms of the ibid section.
- c) That the official respondents failed to apply their independent judicious mind to proviso to Section-4 Sub Section-2 of Appointment and Regularization Services Act, 2017, which provides that an employee who is senior/ older in age shall rank senior than employees whom date of continuous service in the case of two or more employees is the same
- d) That legally speaking, the respondents are bound to prepare a correct seniority list of CT-IT Teachers (BPS-12) in terms of the ibid Act.
- e) That the Hon'ble Services Tribunal, recently delivered judgment dated 31.05.2023 in S.A.No.2069/2019 titled Abid Noor v/s Director E&SE and others vide which the appeal was allowed in terms of proviso to section 4 (2) Regularization Act, 2017 by placing the appellant senior on the basis of his age to private respondents who were younger in age to him (Copy of judgment will be produced at the time of arguments)
- f) That according to section 5 of the Act ibid the provisions of section 4(2) shall have an overriding effect and the provision

of any other law or rules to the extent of such inconsistency with the said Act shall cease to have effect.

g) That the additional grounds will be raised at the time of arguments with the kind permission of this Hon'ble Tribunal.

Keeping in view, what has been stated above, it is, therefore, humbly prayed that the impugned seniority list of CIT-IT Teachers (male) (BPS-12) be prepared in accordance with proviso to Section -4 Sub Section-2 of Appointment and Regularization of Services Act, 2017 and in the light of recently delivered judgment dated 31.05.2023 in S.A.No.2069/2019 titled Abid Noor v/s Director E&SE by declaring the appellant senior to private respondents No.4 to 11.

Any other relief which this Hon'ble Tribunal deems appropriate may kindly be granted.

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of Khyber Pakhtunkhwa, (Extraordinary), dated the 8th January, 2018).

### ACT

to provide for the appointment and regularization of the services of certain employees appointed on adhoc or contract basis or appointed in certain projects in the Elementary and Secondary Education Department in the Province of the Khyber Pakhtunkhwa.

WHEREAS it is expedient to provide for the appointment and regularization of the services of certain employees appointed on adhoc or contract basis or appointed in certain projects in the Elementary and Secondary Education Department in the Province of the Khyber Pakhtunkhwa, in the public interest;

It is hereby enacted as follows:

- Short title, application and commencement.—(1) This Act may be called the Khyber Pakhtunkhwa Employees of the Elementary and Secondary Education Department (Appointment and Regularization of Services) Act, 2017.
- It shall apply to all the employees in the Elementary and Secondary Education Department, as defined in clause (c) of sub-section (1) of section 2 of this Act.
- It shall come into force at once and it shall be deemed to have taken effect from the date of the initial appointment of the employees as referred to in clause (c) of subclause (1) of section 2 of this Act.
- 2. **Definitions.**—(1) In this Act, unless the context otherwise requires,-
  - "Commission" means the Khyber Pakhtunkhwa Public Service (a) Commission:
  - "contract appointment" means appointment of a duly qualified person (b) for a specific period made otherwise than in accordance with the prescribed method of recruitment;
  - (c) "employees" mean duly qualified persons,-

- (i) who are appointed as teachers on adhoc or contract basis by the Government after 2013 through National Testing Service but does not include the teachers engaged on work charge basis or who are paid out of contingencies;
- (ii) who are appointed in the projects on contract basis in accordance with the project policy; and
- (iii) who are appointed as Junior Clerk in the Elementary and Secondary Education Department by Government after 2013 through National Testing Service;
- (d) "Government" means the Government of the Khyber Pakhtunkhwa;
- (e) "law or rule" means the law or rule for the time being in force governing the selection and appointment of civil servants;
- (f) "project" means,-
  - (i) IT/Computer Teachers in Computer Labs Projects in Khyber Pakhtunkhwa (Phase-II);
  - (ii) establishment of five hundreds (500) IT Labs in Government High and Secondary Schools in Khyber Pakhtunkhwa; and
  - (iii) establishment of five hundreds (500) IT Labs in Government High Schools in Khyber Pakhtunkhwa (Phase-III); and
- (g) "teacher" means a teacher of primary, middle, secondary or higher secondary school.
- (2) The expressions "adhoc appointment" shall have the same meaning as respectively assigned to them in the Khyber Pakhtunkhwa Civil Servants Act, 1973 (Khyber Pakhtunkhwa Act No. XVIII of 1973).
- 3. Regularization of services of employees.—(1) Notwithstanding anything contained in any other law or rules, the employees, who hold posts till the commencement of this Act <sup>1</sup>[or till 30<sup>th</sup> June 2017, in respect of the project as mentioned in sub-clause (i) of clause (f) of sub-section (1) of section 2 of this Act, as the case may be], shall be deemed to have been validly appointed on regular basis from the day of the initial appointment; provided that-
  - (i) they possess the same qualification and experience required for a regular post;

(ii) they have not resigned from their services or terminated from services on account of misconduct, inefficiency or any other ground, before the commencement of this Act <sup>1</sup>[:]

<sup>2</sup>[Provided that expiry of the project as mentioned in sub-clause (i) of clause (f) of sub-section (1) of section 2 of this Act, shall not be deemed a ground for non-appointment of an employee on regular basis under this Act; and]

- (iii) the service promotion quota of all service cadres shall not be affected.
- (2) The services of the employees shall be deemed to have been regularized only on the publication of their names in the official Gazette.
- Determination of seniority.—(1) The employees whose service are regularized under this Act or in the process of attaining service at the commencement of this Act, shall rank junior to all other employees belonging to the same Cadre, who are in service on regular basis on the commencement of this Act, and shall also rank junior to such other persons, if any, who, in pursuance of the recommendation of the Commission made before the commencement of this Act, are to be appointed to the Cadre, irrespective of their actual date of appointment.
- The seniority inter-se of those employees, whose services are regularized under this Act within the Cadre, shall be determined on the basis of their continuous service in Cadre:
- V Provided that if the date of continuous service in the case of two or more employees is the same, the employee older in age shall rank senior to the younger one.
- 5. Overriding effect.— Notwithstanding anything to the contrary contained in any other law or rules for the time being in force, the provisions of this Act shall have an overriding effect and the provisions of any such law or rules to the extent of inconsistency to this Act shall cease to have effect.
