24. The justification provided by the Department vide Para 19/N was based on the ground realities and in accordance with the discussion made in the SSRC meetings which held twice, wherein Establishment Department being member of the forum agreed with the proposal. Furthermore, the Establishment Department has raised observations only on the rules framed for the post in BS-21 vide para 12/N which was accordingly amended as per the advice of the Establishment Department.

25. The Administrative Department is of the view that considerable time has been lapsed in the approval of the rules which were not only recommended by SSRC but also vetted by Law Department resultantly a lot of incumbents stood retired from service without getting their due right of promotion. The uncertainty in approval of rules have created sense of deprivation and frustration amongst the college fraternity which may results in administrative issues for the Department.

It is pertinent to mention that this delay has also affected the colleges 26. working under the ambit of this Department due to the shortage of the faculty as Department is unable to process the requisitions to KPPSC till the process attain finality. Moreover, it is also worth mentioning that the condition of initial recruitment shall be exclusively applied to newly created posts and shall have no bearing upon the existing posts. In the instant scenario only a specific quantum of existing posts of teaching cadre have been upgraded to corresponding next grades, alongwith the incumbents holding the same, hence the increase in number of posts of BS-20 shall not be treated as vacant, therefore, initially reserving 20% to be filled in by KPPSC is not a viable approach. Furthermore, the department has significant number of MS/MPhil and Ph.D faculty in the seniority having requisite experience in the field of teaching who if promoted shall fulfill the desired gap. The process of the recruitment through KPPSC is also time consuming as KPPSC normally requires 2 to 3 years in filling up the posts and the Department could not afford to wait such long due to the shortage of the staff in the colleges.

27. Foregoing in view, The Administrative Department reiterates its stance made vide Para 19/N as it contains all the justification required in the matter and, the rules submitted vide Para 15 of the note are duly recommended by the SSRC and
