





- 4. That the appellant preferred departmental appeal for his promotion as inspector on 14-02-2021 which was regretted vide Order/Letter dated 30-08-2021, however copy of the same was not communicated to the appellant and the appellant obtained copy of the same with his own efforts on 07-02-2024. **(Copy of departmental appeal & Order/Letter dated 30-08-2021 is enclosed as Annexure B & C).**
- 5. That the impugned Order/Letter dated 30-08-2021 is against the law, facts and principles of justice on grounds inter-alia as follows:-

**G R O U N D S :-**

- A. That the impugned Order/Letter dated 30-08-2021 is illegal, unlawful, without lawful authority and void ab-initio.
- B. That mandatory provisions of law and rules have badly been violated by the respondents and the appellant has not been treated according to law and rules in violation of Article 4 and 25 of the Constitution and law of the land.
- C. That the appellant the appellant was confirmed as Sub Inspector on 24-10-2017 and his name was brought on Promotion List "F" on 11-01-2019 but even then was not promoted as Inspector despite the fact that was perfectly fit, eligible and coming up to the criteria.
- D. That Police Rules are very much clear on the point which also provide for promotion and confirmation after two years' probation in rank, while the appellant is not promoted as Inspector.
- E. That there is no omission or commission on part of the appellant as he performed his duties whenever and wherever he was posted and also did the courses whenever he was selected and given such opportunity, thus has been deprived of his due legal rights for no fault.
- F. That the appellant never requested for out of turn promotion rather he was entitled for promotion as

Inspector which was not allowed to him for reasons best known to respondents.

G. That the appellant got retired from service upon reaching the age of superannuation vide Notification dated 04-02-2022. **(Copy of Order dated 04-02-2022 is enclosed as Annexure D).**

H. That the appellant served for about 41 years with unblemished service record.

I. That the appellant seeks the permission of this honorable tribunal for further/additional grounds at the time of arguments.

**It is therefore prayed that appeal of the appellant may kindly be accepted as prayed for in the heading of the appeal.**

**Any other relief deemed appropriate and not specifically asked for, may also be granted in favor of the appellant.**
