The appellant was promoted as Officiating Sub Inspector in the year 2015 and thereafter was confirmed as Sub Inspector w.e.f. 24-10-2017 vide Order dated 02-11-2017.
- 3. That the name of the appellant along with others was brought on Promotion List "F" vide Notification dated 11-01-2019 however he was not promoted to the rank of Inspector. (Copy

- **A.** That the impugned Order/Letter dated 30-08-2021 is illegal, unlawful, without lawful authority and void abinitio.
- **B.** That mandatory provisions of law and rules have badly been violated by the respondents and the appellant has not been treated according to law and rules in violation of Article 4 and 25 of the Constitution and law of the land.


