Respectfully Sheweth;

- 1. That the titled appeal is pending adjudication before this august Tribunal, and was pleased to issue order dated: 17.06.2016, vide which respondents were directed to maintain status quo and date: 26.07.2016 is fixed therein for onwards proceedings.
- 2. That applicant in compliance of order supra, deposited security and process fee, on 17.06.2016 and furnished attested copy of the

order dated: 17.06.2016, along with application for implementation whereof, but in spite of the factum of legal opinion, sought by the secretary Social Sector/ respondent no. 4, from Deputy Secretary Litigation, who opined in the following words;

"In the instant case, the Hon'ble Tribunal, vide order dated: 17.06.2016, granted injunctions in favor of the petitioner, namely; Dr. Zakir Hussain and ordered status quo in his favor, therefore, the Court order may be implemented in its true letter & spirit, to avoid further complications into the matter, as the Court order is very much clear"

Astonishingly, the concerned quarters, mis-constructed the order of this august Court and overlooked the legal opinion sought by the competent authority, without care and caution of its legal consequences and instead to issue subsequent order with regard to the impugned notification of transfer of applicant, allowed respondent no. 6, to unilaterally assume charge and managed the same, prior to the date of status quo order and tried their best to jeopardize the matter, which resulted into another representation, addressed to the Secretary Establishment/ A.I & C, FATA, for appropriate directions/ orders, but the episode was culminated as follows;

"In view of Para 20/N (status quo as of 17.06.2016 shall be maintained), file may kindly be processed into directorate of Health Services FATA for framing para wise comments please"

With the above observations/ decision, the matter was kept in abeyance in order to show their muscles to applicant and to defeat purpose of the lawful order dated: 17.06.2016 of this Hon'ble Tribunal, which resulted into instant application.

That respondents are bent upon to create illegal hurdles in smooth performance of official duties of applicant, for extraneous considerations and malafide intentions, rather it has come to the knowledge of applicant through reliable source that respondent no. 6, was facilitated to prepare charge assumption report in back date i.e. 26.05.2016, otherwise, how come, the notification of transfer dated: 25.05.2016, communicated to applicant on 30.05.2016 (Monday), could be materialized unilaterally, that too, on the subsequent day of its issuance, without proper charge assumption/ relinquish reports, on the officially recommended proforma, which tantamount to forgery and scandalizing the lawful verdict of this Hon'ble Tribunal and may not go unchecked, in actional and protect.
- **4. That** this Hon'ble Tribunal has got ample jurisdiction, particularly under rule 27 of the Service Tribunals Rules, 1974, to implement the decisions of the KP Tribunal and to prevent abuse of its process, therefore, proprietary demands to issue appropriate process against the respondents/ delinquents, in accordance with law, in order to give effect to the order dated: 17.06.2016 in letter

& spirit and to allow applicant to continue service in his place of actual posting and to declare the so called charge assumption report of respondent no. 6, capricious, illegal and against the normal course of law/ procedure/ practice, hence be annulled, in the best interest of justice.

- 5. 





Respectfully Sheweth;

- **1.** *That* the titled C.O.C is pending adjudication before this hon'ble Tribunal and fixed today i.e. 25.08.2016, for onward proceedings.
- 2. That applicant approached respondents immediately after issuance of status-quo granting order dated: 17.06.2016, with implementation whereof, but the then application for administration, without care & caution, mis-constructed simple order of this august Tribunal, which resulted into titled C.O.C Petition, however, the entire Administration of FATA Secretariat has been shuffled and most of the delinquents have either been transferred or sent on long leave, who were replaced by the fresh administration, therefore, it would be fitness of things to first communicate the order of this august Tribunal, so as to provide them opportunity to implement the order *ibid* in letter and spirit, it is worth to mention, that applicant was telephonically called for meeting after order dated: 26.07.2016 in the titled C.O.C petition and assured to applicant in meeting, that his grievances would be

redressed at the earliest, hence the instant application, with permission to withdraw the titled C.O.C petition for the time being and if respondent failed to honor their words, to file a fresh one.

3. *That* there is no legal bar to grant desired permission to applicant, being subordinate to the respondents and particularly, in view of their verbal assurance for redressal of his grievances, he has left with no option, but to prefer instant application, rather it would further strengthen his bonafide.

It is, therefore, most humbly prayed, that on acceptance of instant application, applicant may be granted permission to withdraw the titled C.O.C petition for the time being and be disposed of being not pressed, in view of fresh development, occasioned due to assumption of the charge by new administration and their verbal assurance, rendered to the applicant, of the redressal of his grievances at the earliest and may be allowed to file a fresh one, if need be, in the best interest of justice.


