JUDGMENT

GUL ZEB KHAN, MEMBER: -The appellant Mst Nincy Begum, through instant appeal under Section-4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974 has impugned the order dated 27.10.2015 passed by the respondent no. 1 whereby the appellant was transferred/adjusted to GGHS Ambar Swabi. Against the impugned order dated 27.10.2015, the appellant filed a departmental appeal on

02.11.2015 which was not responded within the statutory period of 90 days and hence the instant service appeal.

- 2. Facts of the present appeal are that the appellant was initially appointed in the management cadre as ASDEO through Public Service Commission and was posted at circle Thand Koi Sub-Division Swabi. Subsequently, she filed an application before respondent No. 1 for her transfer to the teaching cadre due to some unavoidable circumstances and domestic problems. She was thereafter transferred from the post of ASDEO (F) circle Thand Koi District Swabi on her own request and adjusted against the vacant post of SST (G) at GGHS Yousafi District Swabi vide order dated 09.10.2015. Vide order dated 27.10.2015 the appellant was again transferred from GGHS Yousafi to GGHS Ambar Swabi and Respondent No. 5 was posted in her place. That feeling aggrieved from the said impugned order dated 27.10.2015, the appellant filed a departmental appeal 02.11.2015 which was not responded within the stipulated period, hence, the present service appeal on 03.02.2016.
- 3. The learned counsel for the appellant argued that the impugned order dated 27.10.2015 was illegal, unlawful, without lawful authority and needs to be set-aside as the Respondent No. 1 in the first instance considered the genuine domestic problems of the appellant and transferred her vide order dated 09.10.2015 at GGHS Yousafi District Swabi, but subsequently the Respondent No. 1, vide order dated 27.10.2015, again transferred her to GGHS Ambar Swabi just for accommodating the private respondent no. 5 namely Mst. Shehnaz due to political influence, which was against the norms of justice. This transfer order is not only against the posting/transfer policy, but also premature as she has not completed three years tenure. Learned counsel for the appellant further argued that there was no complaint against the appellant and the impugned transfer order dated 27.10.2015 was passed against the appellant as a penalty. Besides the salary of the appellant was also stopped by the

Respondents for compelling her to withdraw her case. Learned counsel for the appellant prayed that on acceptance of the instant appeal, the impugned order dated 27.10.2015 passed by Respondent No. 1 may be set-aside and the appellant may graciously be allowed to continue her duties at GGHS Yousafi Swabi and the salaries of the appellant may also be ordered to be released accordingly.

4. On the other hand, the learned Deputy District Attorney for official Respondents No. 1 to 4 argued that the impugned transfer order dated 27.10.2015 was legally correct and liable to be maintained and the instant appeal was based on malafide intention just to put extra pressure on the Respondents for gaining illegal service benefits against SST (General) post. She was already favoured by the department by transferring her on her own request and personal grounds from management cadre to teaching cadre. He further argued that transfer & posting is the discretionary powers of the competent authority and in view of Section-10 of the Government of Khyber Pakhtunkhwa Civil Servants Act, 1973 a civil servant could be transferred anywhere in the province. Learned District Attorney prayed for dismissal of service appeal.



- 5. We have heard the arguments of learned counsel for the appellant as well as learned District Attorney for official Respondents No. 1 to 4 and have gone through the record available on file.
- 6. Perusal of the record reveals that the appellant herself submitted an application on 05.10.2015 for transferred from Thand Koi Sub-Division Swabi to GGHS Yousafi District Swabi which was acceded to and the Respondent No. 1 vide order dated 09.10.2015 transferred her from Thand Koi Sub-Division Swabi (Management Cadre) and adjusted at GGHS Yousafi District Swabi (Teaching Cadre). There is no documentary proof regarding any political pressure from any quarter for accommodating the private Respondent No. 5 namely Mst. Shehnaz vide order dated 27.10.2015 issued by the Respondent No. 1. This Tribunal observed that by now, the

normal tenure of the post is almost completed. According to Section-10 of the Khyber Pakhtunkhwa Civil Servants Act, 1973 a civil servant could be transferred anywhere in the province as it is the prerogative of the Government to transfer a civil servant to a place where his/her services were mostly required and no civil servant is permitted to work at his/her own choice of station.

7. In view of the foregoing, this Tribunal holds that the appellant has failed to make out any cogent reasons justifying the Tribunal interference in the matter. The appeal in hand is accordingly dismissed with the direction to department to make out fresh posting/transfer order in accordance with the policy in the best public interest. No order as to cost. File be consigned to the record room.

Counsel for the appellant present. Learned counsel for the appellant argued that the appellant was serving as ASDEO at Swabi when transferred on her own request vide order dated 9.10.2015 to GGHS Yousafi Swabi. That surprisingly vide impugned order dated 27.10.2015 appellant was adjusted at GGHS Ambar Swabi whereagainst she preferred departmental appeal on 2.11.2015 wherein no comments were furnished by the competent authority despite repeated directions by the appellate authority and, after lapse of statutory period, appellant constrained to prefer the instant appeal.

That the appellant was transferred to GGHS Yousafi Swabi against the position of SST (General) keeping in view her domestic issues and as such further transfer orders of the appellant vide order 27.10.2015 are against facts and not tenable in the eye of law.





- 6. That there is no any complaint, inquiry and explanation whatsoever been pending against the appellant, but infact the order dated 09/10/2015 of Director E&S Education was against the newly created vacant post.
- 7. That the appellant submitted her arrival report and the present impugned order is a premature one as she has not completed the tenure of 3 years in the said school, thus the impugned order be declared illegal and to be set aside.
- 8. That the present G.G.H.S Ambar, Swabi, is too much faraway from the house of appellant and the continuation of her duty will creates more and more problems.



It is, therefore, most humbly submitted, that the impugned order dated 27/10/2015 may kindly be set aside and the order dated 09/10/2015 may graciously be maintained, in the best interest of justice.

INTERIM RELIEF:

By way of interim relief, the operation of the impugned order dated 27/10/2015 may kindly be suspended, till the final decision of the instant appeal.

preliminary objections The raised answering respondents are erroneous and frivolous, having no factual and legal backing. The appellant has got a very prima-facie case and locus standi.
