JUDGMENT

NIAZ MUHAMMAD KHAN, CHAIRMAN: - This judgment shall also dispose of another connected appeal No. 157/2016 as in both the appeals common questions of law and facts are involved.

2. Arguments of the learned counsel for the parties heard and record perused.

FACTS

3. The appellant was initially inducted as Junior Clerk on 28.02.1991 in Revenue Department and then was promoted as Senior Clerk on 31.05.1995. As a consequence of devolution policy in 2001 he became surplus and then adjusted as Senior Clerk in the office of EDO (E&SE) Buner on 31.12.2001. A seniority list was issued in the year 2003 in which the appellant was shown at S.No. 10 and respondent No. 3 was shown at Sr. No. 11. On 12.10.2015 promotion orders were



issued wherein respondent No. 3 who was junior to the appellant was promoted alongwith many other juniors of other Districts. Against this order, the appellant filed a departmental appeal on 21.10.2015 which was rejected on 23.12.2015. In the meantime a seniority list was also issued on 11.09.2015 against which the appellant filed departmental appeal on 02.12.2015. Both these appeals were decided through a single order dated 23.12.2015. Thereafter, the appellant filed the present service appeals after obtaining the copies of the same, on 22.2.2016. One appeal is against promotion order and the second against seniority list.

ARGUMENTS

- 4. The learned counsel for the appellant argued that the appellant was shown senior to respondent No. 3 in the seniority list issued in the year, 2003 and his seniority was disturbed in 2014 without any notice to the appellant. He relied upon two judgments entitled "Sultan Ahmad Vs. Federation of Pakistan, Ministry of Railways through Chairman, Railways Board, Islamabad and others" reported as 2001-PLC(C.S)720 and "Tariq Mansoor Vs. the Member Finance/Additional Finance Secretary, Government of Pakistan, Ministry of Railways, Islamabad and others" reported as 1993-PLC (C.S) 195.
- 5. On merits he argued that the appellant was put in surplus pool in the year, 2001 and the departmental appeal of the appellant was decided in accordance with policy of surplus civil servants issued on 08.06.2001. That this policy was amended later on through an amendment in Rule 17 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989. That in accordance with this amendment in sub rule 3 of Rule 17 seniority of the appellant should have been from regular appointment and not from the date of adjustment from surplus pool.

6. On the other hand the learned District Attorney argued that the appellant was rightly placed junior to respondent No. 3 and the department had rightly interpreted policy of 08.06.2001. That the amendment referred to by the learned counsel for the appellant concerned only to merger/restructuring of the department and not the surplus pool.

CONCLUSION

- The wordings added in sub rule 3 of Rule 17 speaks of merger/ 7. restructuring of the department and not of surplus pool. The matter of surplus pool was inserted in the shape of Section 11-A of the Khyber Pakhtunkhwa Civil Servants Act, 1973. In this Section there is no mention of the seniority inter-se however, if this section is read as whole it even allows the surplus civil servants to be adjusted in lower post if no equivalent post is available. It means that a civil servant cannot claim even his original post as a right and he can be adjusted in a lower post. However, the learned counsel for the appellant submitted that once the appellant was adjusted against post equivalent to the post of his parent department then he was entitled to have been given seniority from the date of his initial appointment and that seniority of 2003 was rightly prepared. This Tribunal without deciding the issue of seniority is of the view that if the appellant was wrongly placed in seniority list of 2003 it was incumbent upon the department to have given him a notice before change in the seniority list on any ground as per the judgments relied upon by the learned counsel for the appellant. This Tribunal has also observed that many other civil servants from S.No. 79 to 100 shall be affected if the present appellant is given seniority over respondent No. 3.
- 8. This Tribunal therefore, by accepting this appeal remit the appeal back to the authority responsible for making seniority list to give notices to the appellant,

respondent No. 3 and all those from S.No. 79 to 100 of the promotion order dated 12.10.2015 and decide the issue afresh keeping in view all the relevant rules and laws on the subject including limitation within a period of 90 days from the date of receipt of this judgment failing which the appellant shall have the right to revive these appeals by impleading all the above mentioned persons as respondents. Parties are left to bear their own costs. File be consigned to the record room.

That it was in the year 2001 when, on the basis of devolution policy, appellant was sent to surplus pool and therefore adjusted in the office of DEO Buner vide order dated 31.12.2001. That his name was enlisted at S.No.10 of the seniority list while the name of private respondent No.3, Barkat Ali, was enlisted at S.No.11 but vide impugned order dated 12.10.2015, 100 Senior Clerks including private respondent No.3 were promoted while appellant ignored despite of seniority and fitness constraining him to file departmental appeal on 21.10.2015 which was rejected on 23.12.2015 but communicated to appellant on 22.2.2016 and hence the instant service appeal on 12.2.2016.

That the appellant is entitled to promotion as office Assistant in preference to private respondent No.3 being senior and fit.

SERVICE **APPEAL** SECTION-4 OF UNDER THE PAKHTUNKHWA SERVICE TRIBUNALS ACT, 1974 AGAINST THE **NOTIFICATION** DATED 12.10.2015 ISSUED RESPONDENT NO.2 WHEREBY RESPONDENT NO.3 JUNIOR TO THE APPELLANT WAS PROMOTED TO THE POST OF ASSISTANT (BPS-16) IGNORING THE APPELLANT AGAINST WHICH APPELLANT PREFERRED DEPARTMENTAL REPRESENTATION ON 21.10.2015 WHICH WAS REJECTED VIDE IMPUGNED APPELLATE ORDER **DATED 23.12.2015 AND COMMUNICATED ON 22.01.2016.**

PRAYER:

South 16

On acceptance of the instant appeal, the impugned original Notification dated 12.10.2015 and the appellate order dated 23.12.2015 issued by Respondent No.2 may graciously be set aside to the extent of promotion of Respondent No.3 and non-promotion of the appellant and Respondents be directed to consider the appellant for promotion to the post of Assistant (BPS-16) w.e.f. 12.10.2015 with all consequential back benefits.

Respectfully Sheweth,

Facts giving rise to the present appeal are as under:-

- 1. That appellant initially joined the service at the office of the Deputy Commissioner, San Junior Clerk on 28.02.1991 and later on, was promoted to the post of Senior Clerk vide office order dated 31.05.1995 (Annex:-A). As per the Seniority List (Annex:-B) maintained at the office of the then Deputy Commissioner, Buner, as stood on 31.12.1998, appellant was placed at Serial No.10 of the list ibid.
- 2. That during the process of devolution way back in the year 2001, appellant was rendered surplus and was subsequently adjusted as Senior Clerk in the office of the then Executive District Officer (Education), Buner vide office order dated 31.12.2001 (Annex:-C). As per the Seniority List (Annex:-D) issued by the then Executive District Officer (S&L), District Buner, corrected upto 31.10.2003, appellant was placed at Serial No.10 while the name of Respondent No.3 is at Serial No.11. It is pertinent to mention here that Respondent No.3 did not raise any objection upon the seniority of the appellant being junior to the appellant and as such the Seniority List ibid, attained finality.
- 3. That the seniority position as aforesaid remained the same in the year 2014 as would be evident from the letter dated 02.04.2014 (Annex:-E) issued by Respondent No.2 calling for the ACRs/Non-Involvement Certificates for promotion to the post of Assistant (BPS-16) wherein the name of the appellant is at Serial No.158 while the names of Respondent No.3 is non-existent therein. The particulars of the appellant were forwarded to Respondent No.2 vide letter dated 18.04.2014 (Annex:-F), however, promotion could not be effected.
- 4. That again in the year 2015, the seniority of the appellant remained unchanged as would be evident from the letter dated 11.08.2015 (*Annex:-G*) requisitioning the ACRs and Non-Involvement Certificates wherein the name of the appellant is at Serial No.56 while that of Respondent No.3 is non-existent and the name of another junior to the appellant namely Muhammad Ishaq is at Serial No.92. Respondent No.3 did not challenge the above mentioned position of seniority of the appellant maintained in the year 2014/2015 and thus remained complacent acknowledging the seniority of appellant.

That vide impugned Notification dated 12.10.2015 (Annex:-H) issued by Respondent No.2 as many as 100 Senior Clerks were promoted to the posts of Assistant (BPS-16) wherein Respondent No.3 junior to the appellant was also promoted while appellant was ignored in violation of the law. Appellant being aggrieved of the promotion Notification ibid, preferred a Departmental Representation (Annex:-I) on 21.10.2015 but the same was rejected vide impugned appellate order dated 23.12.2015 (Annex:-J) communicated on 22.01.2016 through application, hence this appeal inter-alia on the following grounds:-

Grounds:

- A. That Respondents have not treated appellant in accordance with law, rules and policy on subject and acted in violation of Article 4 of the Constitution of Islamic Republic of Pakistan, 1973 and unlawfully issued the impugned Notification/order, which are unjust, unfair and hence not sustainable in the eye of law.
- B. That the seniority of the appellant viz-a-viz Respondent No.3 has been determined ever since his induction in the Education Department in the year 2001 and even the same position was discussed by the august Supreme Court of Pakistan in C.P.Nos. 85 to 86-P/2005 decided on 05.10.2006 (Annex:-L). The same remained unchallenged in the year 2014 and 2015 when the particulars of the proposed promotees were requisitioned by Respondent No.2. Respondent No.3 did not challenge the same during the long fifteen years, therefore his promotion through the impugned Notification is illegal and consequently impugned order is also against the law and hence not sustainable.
- C. That depriving a person from promotion amounts to major penalty inas much as the instant opportunity of promotion occurred after long 20 years but the same was also lost due to the unlawful and illegal approach of the Respondents towards the seniority position of the appellant and Respondent No.3 and hence the same has resulted in manifest in justice.
- D. That appellant has been condemned unheard as neither Show Cause Notice was issued to him soliciting the reasons for depriving him from his due right of promotion nor was he afforded an opportunity of personal hearing to explain his position and in either of the cases appellant has been treated against the principle of natural justice and thus the impugned Notification/order are void ab initio and

JUDGMENT

NASIR-UL-MULK, J.- The petitioners in both these petitions

for leave to appeal were serving as senior clerks on regular basis in the office of the Deputy Commissioner, District Buner, when upon the introduction of the devolution plan, the office of the Deputy Commissioner was abolished and its staff, including the petitioners, were brought into the surplus pool of

District Buner. In accordance with the policy of the Provincial Government

dated 13.8.2001, the petitioners were adjusted as senior clerks in the Education Department of District Buner by the office order dated

31.12.2001, while some other clerks of the office of the Deputy

(25)

Commissioner Buner, respondent Nos 4 to 7 herein, were by subsequent office order of 15.1.2002 adjusted from the District Surplus Pool in the office of District Coordination Officer, Buner (DCO). This later group of clerks was subsequently promoted as Assistants in the office of the District Coordination Officer, Buner, by order dated 22.12.2003. After making unsuccessful departmental appeal against the said promotion, the petitioners filed appeals before the NWFP Service Tribunal for setting aside the said promotion with the prayer that the petitioners be ordered to be adjusted against the vacant posts of senior clerk in the office of the District Officer Revenue & Estates, Buner. The Tribunal dismissed the appeals on 6.1.2005 on the ground that the petitioners having been permanently adjusted in the Education Department could not now claim adjustment in another department. These petitions for leave are now directed against the judgment of the Tribunal.

2. Mr. Attiq-ur-Rehman Qazi, learned ASC appeared for the petitioners. The only argument advanced by him is based on the violation of Para-5(c)(iv) of the adjustment policy of the Provincial Government dated 8.6.2001, that the very adjustment of the petitioners as senior clerks in the Education Department was in violation of the said para which bars adjustment to a post liable to be filled up by promotion. He, therefore contended that the petitioners could not be adjusted as senior clerks in the Education Department, as the said posts were liable to be filled by promotion. When confronted as to why the petitioners had not questioned the adjustment itself, which was made way back in the year 2001, the learned counsel argued that since the adjustment was void abinitio, the same could be set aside without the constraints of limitation.

In the appeals before the Service Tribunal, the petitioners have neither explicitly nor implicitly questioned their adjustment in the Education Department that was made way back on 31.12.2001. In their appeals, filed on 13.7.2004, they had only assailed the promotion of respondent Nos.4-7 on the ground that in their original department of the Deputy Commissioner, the said respondents were juniors to the petitioners. The petitioners could have succeeded only if their adjustment in the Education Department could be reversed. That process is not reversible as the petitioners have been permanently adjusted in the Department and from the order of Senior Member. Board of Revenue dated 6.5.2004, before whom the petitioners had first agitated their case, the names of the petitioners have even now been included in the seniority list of the Education Department and have been placed at serial Nos. 9 and 10 thereof. That the petitioners did not raise any objection to their inclusion of their names in the said seniority list when the same was circulated. The petitioners, therefore, cannot press into service para-5(c)(iv) as not only that they have impliedly agreed to and acquiesced in their adjustment in the Education Department but had also not challenged the same either before the Board of Revenue or before the Service Tribunal. In any case, even if the petitioners plea regarding wrong adjustment in the Education Department on the posts of senior clerks is accepted, the only consequence that would flow therefrom would be their reversal to the surplus pool but no direction can be given that they be adjusted in the office of the District Coordination Officer or further that they may be promoted to the post of assistants instead of respondent Nos.4 to 7.

4. Examining the case from any angle, we are of the considered view that the Service Tribunal had rightly dismissed the petitioners' appeals.

The Respondents submit as under:-

PRELIMINARY OBJECTIONS.

- 1 That the Appellant has got no cause of action locus / standi.
- 2 That the instant Service Appeal is badly time barred.
- That the Appellant has concealed material facts from this Honorable Tribunal in the instant Service Appeal.
- 4 That the appellant has not come to this Honorable Tribunal with clean hands.
- That the Appellant is not entitled for the relief he has sought from this Honorable Tribunal.
- 6 That the instant Service Appeal is against the prevailing law & rules.
- 7 That the instant appeal is based on malafide intentions just to put extra pressure on the Respondents for gaining illegal service benefits.
- 8 That the Appellant has been treated as per law, rules & up-gradation policy.
- 9 That the Appeal is not maintainable in its present form.
- That the appeal is bad for mis-joinder & non-joinder of the necessary parties.
- That the Appellant is not competent to file the instant appeal against the respondents.
- That the Notification dated 12/09/2015 & appellate order dated 23/12/2015 are legally competent & is liable to be maintained.
- 13 That rules-8(1) of Civil Servants Act 1973& seniority rules, 1993 are not applicable upon the case of the appellant.

ON FACTS

That Para-I, is correct to the extent that initially the appellant was appointed against the Junior Clerk post vide order dated 28/2/1991, and promoted to the post of Senior Clerk on 31/8/1995. But later on due to introduction of Devolution of powers plan year 2001, vide which the scheme of District Governments has been introduced, the appellant was declared, as surplus and his status against the post he held was re-determined in

accordance to the principles as prescribed in the surplus pool policy read with rules-6 (b) of Esta Code (Revised Edition) 2011(page-102). Therefore, the appeal for the grant of seniority & promotion against the Assistant(PBS-16) post of the appellant has been rejected by the Respondent No: 2 vide Notification No: 2085-89 dated 23/12/2015(Copy of the said Notification are Annexures-A&B).

- 2 That Para-2 is incorrect & denied. The statement of the appellant is misleading and against the factual position as stated in Para-I of the instant reply. Therefore, the plea of the appellant is liable to be dismissed of being baseless & unlawful.
- 3 That Para-3 is correct to the extent that the DEO (Female) Bunir, has submitted the required data / information to the Respondent No: 2 but it does not means that the appellant has accrued vested right for promotion against the Office Assistant (BPS16) post, being an employee of surplus pool. Hence, rejected for the grant of promotion of being the Junior most in the said cadre by the Respondent No: 2 vide the impugned Notification dated 23/10/2015(Copy of the same is already attached).
- 4 That Para-4 is incorrect & denied. The plea of the appellant is not well grounded as evident from Paras 1& 2 of the impugned Notification dated 23/10/2015, issued by the Respondent No: 2, wherein the Departmental Appeal of the appellant has been rejected of being not eligible & entitled for the grant of seniority & on the basis of the same, the promotion against the Office Assistant (BPS-16) post of being the Surplus Pool employee of the office of the Deputy Commissioner, Bunir & the junior most in his cadre. There fore, his wrong seniority alongwith Mr. Ubaidur Rehman S/Clerk office of the SDEO(F) Bunir has been re-determined in accordance with the Principle of Surplus Pool policy. Therefore, the seniority pertaining to the Senior Clerk issued vide Notification dated 12/10/2015, has been withdrawn to the extent of the appellant & the above said official & both have been adjusted back against their original posts of Senior Clerk in their respective status with the conditions that they will be promoted against the Office Assistant (BPS-16) post on their respective turns & on the basis of inter, seniority of the Surplus Pool employees in the Respondent Department.
- 5 That Para-5 is incorrect & misleading. Detailed reply of this Para has already been given in Para-4. Hence needs no further comments. Hence the Respondents further submit on the following grounds inter alia: -

ON GROUNDS.

- A Incorrect & denied. The appellant has been treated as per Law, Rule & Surplus Pool Policy in the instant case having no question of violation of the provision of Article-4 of 1973 Constitution of Pakistan.
- B Incorrect & denied. Detailed reply of the ground has been given in the foregoing Paras. Hence needs no further comments.
- C Incorrect & denied. The appellant is the junior most employee of the Respondent Department & has been adjusted from the Surplus Pool of the being an Ex-employee of the Deputy Commissioner Bunir. Hence has been treated in accordance with the Surplus Pool Policy in the instant case by the Respondent No: 2 in the interest of justice.
- D Incorrect & denied. The impugned seniority list & Notification are within the legal sphere & are liable to be maintained in favour of the Respondent in the interest of justice.
