That after medical examination including height of the appellant recorded as 5.4" he resumed his duty but vide impugned order dated 05.04.2016 the appointment order of the appellant was withdrawn on the plea that his height was below the prescribed standard by 2" where-against he preferred departmental appeal on 18.04.2016 which was not responded and hence the instant service appeal on 10.08.2016.

That the appellant was condemned unheard as no notice etc. or opportunity of hearing was extended to him before passing the impugned order.

Points urged need consideration. Admit. Subject to deposit of security and process fee within 10 days, notices be issued to the respondents for written reply/comments for 16.02.2017 before S.B at camp court, Abbottabad.

SERVICE APPEAL UNDER SECTION 4 OF KPK SERVICE TRIBUNAL ACT, 1974 FOR DECLARATION TO THE EFFECT THAT THE APPELLANT WAS APPOINTED AS WILDLIFE WATCHER (BPS-07) WILDLIFE SUBDIVISION, HARIPUR AGAINST IN SERVICE

DECEASED EMPLOYEE'S SON QUOTA VIDE APPOINTMENT ORDER NO. 1473-78/WL-ATD DATED 25/01/2016. THE APPELLANT TOOK OVER THE CHARGE OF THE POST AFTER GETTING MEDICAL CERTIFICATE AND RECEIVED SALARY FOR THE MONTH OF **FEBRUARY** AND **MARCH** BUT RESPONDENT NO. 4 WITHOUT ISSUING EXPLANATION, SHOW CAUSE NOTICE AND OPPORTUNITY OF PERSONAL HEARING DISMISSED **APPELLANT** THE FROM SERVICE ON THE PLEA THAT THE HEIGHT OF THE APPELLANT IS 5'.4" WHICH IS 02 INCH LESS THAN THE REQUIRED CRITERIA VIDE IMPUGNED WITHDRAWAL ORDER NO. 1953-58/WL-ATD DATED 05/04/2016, WHICH IS PERVERSE, DISCRIMINATORY, AGAINST THE LAW AND THE IMPUGNED WITHDRAWAL ORDER IS LIABLE TO BE SET ASIDE.

PRAYER: ON ACCEPTANCE OF THE INSTANT APPEAL, IMPUGNED WITHDRAWAL ORDER MAY GRACIOUSLY

BE DECLARED ILLEGAL, VOID AND RESPONDENTS' DEPARTMENT MAY BE DIRECTED TO REINSTATE THE APPELLANT FROM THE DATE OF WITHDRAWAL ORDER I.E 05/04/2016 **ONWARDS** WITH ALL SERVICE BACK BENEFITS. ANY OTHER RELIEF WHICH THIS HONOURABLE TRIBUNAL DEEMS APPROPRIATE IN THE CIRCUMSTANCES OF THE CASE MAY ALSO BE GRANTED.

Respectfully Sheweth;-

- 1. That father of the appellant was serving as Wildlife Watcher, in Sub-Division, Haripur and died during service on 06/09/2015.

  Copy of death certificate of the father of the appellant is attached as Annexure "A".
- 2. That the appellant is F.Sc qualified and applied to the respondents' department for appointment against the deceased in service employee's son quota therefore,

respondents' department issued appointment order of the appellant as Wildlife Watcher, in Wildlife Sub-Division, Haripur vide appointment order No. 1473-78/WL-Atd Dated 25/01/2016. Copy of appointment order dated 25/01/2016 is attached as Annexure "B".

- That as per condition No. 5 of the appointment order, the appellant appeared before Medical Board for obtaining medical fitness certificate at District Headquarter Hospital, Haripur on 26/01/2016 and obtained medical fitness certificate wherein the height of the appellant was shown as 5'.4" having 18 years of age and declared fit for the said job. Copy of medical certificate dated 26/01/2016 is attached as Annexure "C".
- 4. That, thereafter, the appellant took over the charge of the post and served as Wildlife Watcher with complete devotion and dedication to the entire satisfaction of his

superiors. In the meanwhile, the respondents' department paid salary to the appellant for the month of February and March, 2016. Copies of salary slips are attached as Annexure "D".

- 5. That after a period of near about 2½ months, respondent No.4 directed the appellant to appear for medical re-examination before Medical Officer Police Line, Abbottabad vide letter NO.1856/WL-Atd dated 28/03/2016. Copy of letter of respondent No. 4 dated 28/03/2016 is attached as Annexure "E".
- 6. That as per direction, the appellant appeared before the Medical Officer Police Line Abbottabad wherein the height of the appellant was again shown in the fitness certificate as 5'.4" vide medical certificate dated 11/04/2016. Copy of medical certificate dated 11/04/2016 is attached as Annexure "F".

- 7. That on the basis of the said certificate, respondent No.4 without following the codal formalities i.e explanation, show cause notice, opportunity of personal hearing, appointment order of the appellant dated 25/01/2016 was withdrawn vide order No 1953-58/WL-Atd dated 05/04/2016. Copy of impugned withdrawal order dated 05/04/2016 is attached as Annexure "G".
- 8. That feeling aggrieved, the appellant filed departmental appeal to respondent No. 3 for setting aside of impugned withdrawal order dated 05/04/2016 on 18/04/2016 through registered post. Copies of departmental appeal and registered receipt dated 18/04/2016 are attached as Annexure "H" & "I". But respondent No. 3 did not bother to reply to the appellant so far.

Therefore, the instant service appeal is filed, inter-alia, on the following grounds;-

### GROUNDS:-

- a. That impugned withdrawal order dated 05/04/2016 is illegal, void, against the law, service rules and malafide, hence the impugned withdrawal order dated 05/04/2016 is liable to be set aside.
- explanation, show cause notice and without inquiry as well as affording personal hearing to the appellant, withdrew appointment order of the appellant on 05/04/2016, which is against the norms of justice and fair play.
- c. That the appellant once appeared before the medical authorities as mentioned in para-5 of the appointment order and the medical authorities declared the appellant fit

for service having 5'.4" height and on the basis of that medical fitness certificate, the appellant was allowed to take over the charge and also paid salary for 02 months. Thereafter, the withdrawal of appointment order of the appellant is absolutely against the law because the valuable rights of remaining in Govt. service had been accrued to the appellant which could not be rescinded after its acceptance by the department.

- d. That the appellant is 18 years old and it is likelihood that he may gain 2 inch deficient in height till the age of 25 years, therefore, impugned withdrawal order dated 05/04/2016 is liable to be set aside.
- which is to be done in a particular manner that must be done in that manner and not otherwise. Hence, the

supposed to proceed after follow all the codal formalities which are sine qua non for withdrawal or removal from service. But, no such formality, as required by law, has been completed prior to the withdrawal order dated 05/04/2016 which is nullity in the eyes of law.

- f. That besides, it is also submitted that the appellant though having 02 inch less in his height but he is quite stout, energetic and fit to run and shuttle in the forest as Wildlife Watcher to run the show.
- g. That the appeal of the appellant is well within time and the Honourable Service Tribunal has jurisdiction to entertain the instant appeal.

It is, therefore, humbly prayed on acceptance of the instant appeal, impugned withdrawal order may graciously be declared illegal, void and respondents department may be directed to reinstate the appellant from the date of withdrawal order i.e 05/04/2016 onwards with all service back benefits. Any other relief which this Honourable Tribunal deems appropriate in the circumstances of the case may also be granted.
