**AND** FOR ACCEPTANCE OF DEPARTMENTAL APPEAL WHICH IS STILL PENDING WITH OUT RESPONSE.

### PRAER:-

ON ACCEPTANCE OF INSTANT SERVICE APPEAL, IMPUGNED NOTIFICATION/ORDER ISSUED BY RESPONDENT NO 2 ISSUED UNDER ENDST NO 491-92/EB/F.NO.11/VOL-III DATED 19/01/2016 MAY PLEASE BE SET-ASIDE AND AMOUNT REFUNDED/DEDUCTED FROM THE SALARY OF APPELLANT, MAY BE ORDERED THE REFUND OF SAME.

### **FACTS**

- 1) That appellant is a Primary school teacher, In the year 2015 he was appointed as Invigilator in SSC Annual examination 2015 by controller of Examination BISE Abbottabad. He relieved from his school and relieving certificate was duly countersigned by SDEO (Male) Abbottabad (respondent no3) and he performed his duty from 18/03/2015 to 07/04/2015. Copies of letter issued by controller BISE Abbottabad, relieving chit and duty certificate are annexed as **Annexure** "A" "B" & "C".
- 2) That during the SSC exam: duty period of appellant, Assistant District Education Officer visited the school and marked him as "I have no information this teacher" while on the same page of attendance register it was also entered as "SSC Exam duty" against 18/03/2015 and this was the

sole reason, where personal grudges of ADEO are started against appellant. Copy of page of attendance register for the month of March 2015 is annexed as **Annexure "D"**.

- That after the SSC exam: under the influence of said ADEO, the series of show cause notices were started against Appellant and appellant replied the same through proper channel and mentioned all the resons and personal grudges of ADEO, but these replies were never presented before the competent authority and disappeared from the office of respondent no 02 (the competent authority). Copy of show cause notices and replies are annexed as Annexure "E", & "F".
- 4) That factually there is no slight irregularity in the SSC Exam: duty and relieving chit was duly countersigned by respondent No 03 which is higher authority then ADEO therefore in the meanwhile proceedings of SSC Exam: duty was stoped/left & filed with out any findings.
- personal grudges of ADEO, he made another issue against appellant & he was pre-mature transferred from GPS Nathia Gali to GPS Keri Raiki (present station) by the respondent no 2, wherupon appellant filed application for cancellation of transfer order and also requested for Earned leave for ten days which was not properly examined and the matter of leave was converted in to absent. Copy of cancellation of transfer application is annexed as **Annexure "G"**.
- 6) That another series of show cause notices were started, and false medical certificate was attached with the leave case of appellant and the said Medical certificate was attributed with appellant to damage his service rights, appellant was being

submitted his replies but here too these replies were also not presented before competent authority. Copies of show cause notices & replies are annexed as **Annexure "H"& "I"**.

- That applellant on 26/11/2015 submitted detailed application relating to whole case created by ADEO and requested for natural justice, but in vain and with out holding any regular inquiry and adopting prescribed procedure law, respondent No 2 issued inmugned Notification/order dated 19/01/216. Copies of application dated 26/11/2015 & Impugned Notification/order are annexed as Annexure "J" & "K".
- appeal dated 17/02/2016 through registered post to respondent no 1 which is still pending with out any response after passing the statutory period of 90 days, Copy of departmental appeal and receipt of registered post is annexed as **Annexure "L" & "M"**. Hence this appeal inters alia on the following ground, and appellant's appeal is within 120 days from the submission of his departmental appeal.

### **Grounds**

- a) That no formal inquiry was conducted in the case which was much necessary to reach the conclusion of the case, there was no such special circumstances available in the case which was referred in the KPK Govt: Servants (E & D) Rules, 2011.
- b) That application of rule 07 of the KPK Govt: Servants
  (E & D) Rules, 2011 is against the facts and circumstances of the case as well as with out holding of formal inquiry it is not clear just surmises that what

were the material/grounds, under which the whole process was initiated and the very illegal and unlawful notification was issued.

- c) That during the formal inquiry proceedings, accused uses/exercises his full opportunity to cross the witnesses of the case as well as documents, for the purpose of placing on record and for focus the very real and factual position.
- d) That there is adopted no prescribed procedure in the case and all is done with the wishes and pleasure of ADEO which is proved from the available record and the impugned action is pre-plan and under personal grudges of ADEO, which is against law.
- e) That the action of respondents is admittedly arbitrary capricious unjust and against all norms of justice and against the law.
- f) That it is an admitted fact that under question illegal.

  Action fell in the matter of great public importance, and tried to engage the appellant in to litigation.
- g) That the issuing authority did not consider that what was the requirements of initiating show cause notice against appellant? and under the law complaint of ADEO was not legal and genuine, because there was much unfavourable & opponent actions of ADEO were available against appellant.
- h) That the contents of impugned Notification is totally against with each other, in one para it is mentioned that appellant was absent with out any information and in

the next para it was admitted that application for ten days was submitted.

i) That in the impugned notification is proved the plea of appellant that all is done by the ADEO, because in the Notification it is admitted all proceedings were initiated on the reports & informations of said ADEO, no independent means of information was never mentioned in all proceedings.

It is, therefore, respectfully prayed that on acceptance of instant service appeal, impugned Notification/order issued by respondent no 2 issued under Endst No 491-92/EB/F.NO.11/VOL-III dated 19/01/2016 may please be set-aside and amount refunded/deducted from the salary of appellant, may be ordered the refund of same.

Any other relief for which the appellant is entitled, and the same is not asked/prayed specifically, may very kindly be granted in favour of the appellant.



### Respectfully Sheweth:-

Comments on behalf of respondents are submitted as under:-

### **PRELIMINARY OBJECTIONS:-**

- 1. That the appellant has no cause of action to file the instant service appeal.
- 2. That the appellant has no locus standi.
- 3. That the appellant did not come to this Honorable Tribunal with clean hands.
- 4. That the appellant concealed and distorted the material facts from this Honorable Tribunal.
- 5. That the present appeal has been filed just to pressurize and blackmail the respondents.
- 6. That the instant service appeal is not maintainable in its present form.
- 7. That the instant appeal is hopelessly time barred.
- 8. That the appellant has suppressed the original facts from this Honorable Tribunal hence, not entitled for any relief & appeal is liable to dismissed without any further proceeding.

### Factual objections:-

- 1. That Para No. 1, relates to the service record of appellant hence, no comments.
- 2. That Para No. 2, is incorrect to the extent of personal grudge, remaining para pertains to record hence, no comments.
- That Para No. 3, is incorrect as stated. Record speaks itself which self explanatory.
- 4. That Para No. 4, of the instant appeal relates to record.
- 5. That Para No.5, of the instant appeal is incorrect hence, denied as per report of ASDEO Circle Nathia Gali dated 21-09-2015, appellant was transferred to GPS Keri Raiki vide letter No. 7199 dated 02-09-2015 but he failed to take over charge at GPS Keri Raiki & found absent from duty

- w.e.f 03-09-2015 to 21-09-2015. (Copy of the absent report dated 21-09-2015 is annexed as annexure "A").
- 6. That Para No. 6, of the instant appeal as composed is incorrect hence, denied. Appellant submitted an application without recommendation of ASDEO Circle Nathia Gali along with medical certificate/advise of Medical Officer, Ayub Teaching Hospital, Abbottabad for complete bed rest w.e.f 09-09-2015 to 18-09-2015 (10 days) without countersignature of Medical Superintendent. Furthermore, medical certificate provided by appellant was forwarded to Medical Superintendent Ayub Teaching Hospital Abbottabad for clarification/verification vide letter No. 7858 dated 23-09-2015. (Copy of application, medical certificate & clarification letter No. 7858 dated 23-09-2015 are annexed "B", "C" & "D").
- 7. That Para No. 7 of the instant appeal as composed is incorrect hence, denied. As per hospital Director Ayub Teaching Hospital letter No. 4258 dated 05-10-2015, medical certificate provided by appellant was found not genuine & not verified. Furthermore, on receipt of reply of show cause notice appellant was summoned for personal hearing on 02-11-2015 through SDEO (Male) Abbottabad vide letter No. 8691 dated 27-10-2015 but due to the engagement of the respondent No. 2 appellant was recalled for personal hearing on 20-11-2015 through SDEO (Male) Abbottabad vide letter No. 9005 dated 16-11-2015 & appellant availed the opportunity of personal hearing on 20-11-2015 & failed to defence the charges leveled against him & left the office without any intimation. Appellant was once again recalled for personal hearing 07-12-2015 vide letter No. 9376 dated 30-11-2015 & same opportunity has availed by the appellant on 07-12-2015 & he also produced an affidavit to the effect that he may please be forgiven which he has committed. (Copies of letter No. 4258 dated 05-10-2015, letter No. 8691 dated 27-10-2015, letter No. 8691 dated 27-10-2015, letter No. 9005 dated 16-11-2015, letter No. 9376 dated 30-11-2015 & affidavit are annexed as annexure "E", "F", "G", "H" & "I" respectively).
- 8. That Para No. 8, of the instant appeal is subject to cogent proof.

#### **GROUNDS:-**

- a. That ground a, as composed is incorrect hence, denied as there was no need to hold a formal inquiry in the case of appellant. As per report of ASDEO Circle Nathia Gali dated 21-09-2015, appellant remained absent from duty w.e.f 03-09-2015 to 21-09-2015 without any information/application.
- b. That ground b, as composed is incorrect hence, denied. Detailed reply has been given in ground a.
- c. In reply to ground c, it is submitted that there was no need to holding a formal inquiry as appellant himself remained willful absent w.e.f 03-09-2015 to 21-09-2015 & he badly failed to defend the charges leveled against him. Furthermore, the opportunity of personal hearing/defence was provided to appellant & he availed the same.
- d. The ground d, as composed is incorrect hence, denied.

- e. The ground e, as composed is incorrect hence, denied. As the act of the respondents is purely in accordance with law, rules & policy.
- That ground f, as composed is incorrect hence, denied.
- That ground g, as composed is incorrect hence, denied.
- h. The ground h, as composed is incorrect hence, denied. Furthermore, appellant submitted an application alongwith medical certificate which found not genuine & not verified by the Hospital Director of ATH Abbottabad.
- i. That ground i, as composed is incorrect hence, denied. As impugned notification was issued after adopting the due course of law.




