

DEPARTMENTAL APPEAL / REPRESENTATION ON DATED 14.11.2023 BEFORE THE RESPONDENT DEPARTMENT BUT AFTER PASSING OF STATUTORY PERIOD THERE WAS NO RESPONSE FROM THE RESPONDENTS DEPARTMENT.

Prayer in Appeal:

On acceptance of this Appeal, the impugned order dated 21.06.2022 may kindly be set aside to the extent of appellant and the appellant may kindly be considered as regular / confirmed employee on the post of Sub-Inspector and also grant/ award the seniority from the date of initial appointment along with whole consequential benefits for which the present appellant is entitled/eligible under the law.

Respectfully Sheweth:

1. That the appellant is a law abiding citizen of Islamic Republic of Pakistan, having fundamental rights which were guaranteed by the Constitution of Islamic Republic of Pakistan, 1973.
2. That the appellant was initially appointed as Subedar Khassadar on 18.09.2013 at responds department and after merging of FATA into KPK the appellant was adjusted/ absorbed as sub-Inspector on the basis of Khasadar Force Act, 2019 and rendered his services to the parent department with great zeal and zest.

3. That appellant also completed the whole training course according to Police Rules/Policy and Standing Order 03/2015 as noted below:-

- i. Basic Training at PTS Kohat 2022.
- ii. Basic Investigation Course at Police School of Inv: Peshawar w.e.f 15-26 Aug 2022.
- iii. Elite Tactical Course (08-weeks) at EPTC Nowshera w.e.f 14-10-2022.
- iv. UNDP Workshop on Management of Emergency at Islamabad w.e.f 16-19 May, 2023
- v. Public Dis-order & Riot Management Course at PDRM School Mardan 16-27 May 2022
- vi. E-Learning Course at Police School of I.T Peshawar w.e.f 06-10 Dec 2021
- vii. Advance Computer Course at Police School of I.T Peshawar w.e.f 03-14 Jan 2022
- viii. 5 Nos of Commendation Certificates were granted to appellant by his superior officers on various occasions due to his outstanding performance is entitled/eligible for confirmation as Inspector and also eligible/entitled for seniority from the date of initial appointment i.e. 18-09-2013.
- ix. Appellant had completed mandatory period according to Standing Order No. 21/2014 **annexure attached.**

4. That respondents Department is legally bound to confirm the present appellant as Sub-Inspector (BPS-14) and also grant/ award the seniority from the date of his initial appointment order i.e. 18.09.2013 but respondent

department still refusing and denying which is illegal norms of justice.

5. That respondent department also mentioned in their own notification/ order and Khasadar Force Act 2019 that whenever the Government Employee completed the whole training course shall be confirmed and also be regularized from the date of his initial appointment order but after passing of statutory period i.e. 03-years no step has been taken by the respondent department, which is illegal and also against the law.

6. That it is also pertains to mention here that the respondent department is legally bound to implement their own order notification/order/Act which is reproduce below:-
 - i) **Para-6 of Khasadar Force Rules 2019 "Seniority:-** *Members of the Khasadar Force, who are absorbed in the Police, in accordance with Government orders and instructions, shall take seniority in the Police from the date of the initial appointment upon recruitment in the Khasadar Force" annexure attached.*

 - ii) **Police Rules of 1934 Rule 12(2) (Seniority and probation.** - The seniority of Assistant Superintendents of Police is regulated by the orders passed from time to time by the Secretary of State and the Central Government. No Probationary Assistant Superintendent of Police shall be permanently appointed as an Assistant Superintendent of Police until he has passed the prescribed departmental examinations. A Probationary Assistant Superintendent of Police who does not qualify by passing these examinations within two years, or at the first examination after two years, from the date of

his joining the service, will be removed from Government service, provided that the Provincial Government shall have power to relax this rule in special cases, when the Probationary Assistant Superintendent of Police is likely to make a good police officer.

12.3. Direct Appointments of Inspectors and Assistant Sub-Inspectors. - Except as provided in Rules 12.1 and 12.4, direct appointments shall not be made except in the rank of Inspector, prosecuting Sub-Inspector and Assistant Sub-Inspector. Such appointments in the rank of Inspector and Assistant Sub-Inspector may be made up to a maximum of ten per cent and twenty-five per cent of vacancies, respectively.

iii) Police Rules-1934, Rule 13-18 (Probation :- (1) A person appointed to any post in the service shall remain on probation for a period of two years, if recruited by direct appointment and one year if appointed otherwise:

Provided that, -

- (a) any period, after such appointment, spent on deputation on a corresponding or a higher post shall count towards the period of probation ;
 - (b) in the case of an appointment by transfer, any period of work on an equivalent or higher rank, prior to appointment to the Service, may in the discretion of the appointing authority, be allowed to count towards the period of probation ;
 - (c) any period of officiating appointment to the service shall be reckoned as period spent on probation ; and
 - (d) any kind of leave not exceeding six months during or at the end of period of probation, shall be counted towards the period of probation.
- (2) If, in the opinion of the appointing authority, the work or conduct of a person during the period of probation is not satisfactory or if he has failed to pass the departmental ex-Promotions 405
1. Substituted vide Punjab Govt. Notification No. G.S.R. 14/C.A.V./61/Ss.7 and 46/Amd.(22)/2003 dated 28.2.2003. amination, if any prescribed in service Rules within a period not exceeding two and a half year, from the date of appointment, it may :-

- (a) If such person is recruited by direct appointment, dispense with his services, or revert him, to a post on which he held lien prior to his appointment to the service by direct appointment ; and
- (a) If such person is appointed otherwise,
 - (i) revert him to his former post ; or
 - (ii) deal with him in such other manner as the terms and conditions of the previous appointment permit.
- (3) On the completion of the period of probation of a person, the appointing authority may, -
 - (a) If his work and conduct has, in its opinion been satisfactory, -
 - (i) confirm such person, from the date of his appointment or from the date he completes his period of probation satisfactorily if he is not already confirmed ; or
 - (ii) declare that he has completed his probation satisfactorily, if he is already confirmed ; or
 - (b) If his work or conduct has not been, in its opinion, satisfactory, or if he has failed to pass the departmental examination, if any specified in the Service Rules, -
 - (i) dispense with his service, if appointed by direct appointment or if appointed otherwise revert him to his former post, or deal with him in such other manner as the terms and conditions of his previous appointment may permit; or
 - (ii) extend his period of probation and thereafter pass such order as it could have passed on the expiry of the period of probation as specified in sub-rule(1) ;
Provided that the total period of probation including extension, if any, shall not exceed three years.] Annexure Attached.
- iv) standing Order No.21/2014:-**One-Year Mandatory Tenure for Promotion as DSP**, An Inspector shall not be promoted as DSP unless, in addition to other requirements, he/she has completed one year tenure as Inspector, excluding the period of long leave, either in the Investigation Branch, CTD, Special Branch or any Police training institution. which has been completed by the appellant (transfer/posting orders of the said period are annexure for kind perusal).
- v) **Absorption Notification:-** the appellant was absorbed vide Home & Tribal Affairs Department Notification No.SO(Police)HD/SMY 2019 Merged Area/572-85 dated

21-06-2022 wherein also mentioned that the appellant alongwith his colleagues is hereby absorbed into KP Police w.e.f the date of their initial appointment, **copy annexure for perusal.**

in view of the above rules, *respondents refusing by not confirmation and also not awarding seniority from initial order which is illegal, against law and against the norms of justice.*

6. That same point of law has been decided by this august Tribunal in Service Appeal No. 12438/2020 and same appeal No. 573/2016 on dated 18.03.2019 and Appeal No. 800/2018 and also awarded/ granted the confirmation on the different posts i.e. ASI, SI & Inspector and also award/ grant seniority from the date of initial appointment order so, the appellant has also reliance on all these appeals which were already decided by this august tribunal of Khyber Pakhtunkhwa (all appeals/judgments are annexed).

7. That other colleague of the present appellant also approached before this august Tribunal Service Appeal No. 1227/2013 titled as "Waqar Ahamd, Inspector No. 101/P, PRO, CCPO Office, Peshawar Vs Provincial Police Officer, KPK Peshawar" on dated 02.08.2018, Service Appeal No. 102/2015 titled as "Fazal Dad Vs Provincial Police Officer, KPK Peshawar" and had been implemented order/ judgment with letter and spirit, so the present appellant also relies on these appeals which were decided by this august Tribunal and the appellant

is also entitled for the same relief. (All the relevant documents are annexed as Annexure A).

8. That whenever a point of law has been decided by the competent court of law and even if the appellant did not participate in the said litigation, then even the same relief shall be awarded to the present appellant. Therefore, the appellant is also entitled for the same relief which were already been granted by the KP Service Tribunal. Reliance on **2009 SCMR Pg# 1**.
9. That the present also verbally requested before the respondents departmental to decide the matter and grant/award the confirmation of seniority from the date of initial appointment order i.e. 18-09-2013 but respondents department are delaying the matter on one pretext or another, which is illegal and also against law.
11. That under the law appellant shall be confirmed on the said post and also be eligible for confirmation as regular employee and also grant/award the seniority from the date of initial appointment order. While, the present appellant is more than 09-years but still the responded department has not confirm on the said post, which is illegal, against law & also against the Police Rules 1934 and Policy.
12. That the appellant also submitted departmental appeal on dated 14.11.2023 but after passing of statutory period, there was no response from the respondents

department, hence the present appeal inter-alia on the following grounds:-

GROUND:

- A. That act of the respondents by not deciding the matter of appellant is illegal, without jurisdiction and lawful authority, against the principles of natural justice, without any reasons and reasons.
- B. That impugned order is illegal, unjust, violation of rules and also law applicable to the matter and against the fundamental rights of petitioner i.e. Article 2-A, 4, 10-A, 25 and 27 of the constitution of Islamic Republic of Pakistan.
- C. That the appellant rendered unblemished services in the respondent department without any criminal history but still the respondents are not confirming the appellant as Inspector and also not issue seniority from the date of initial appointment order which is illegal and against law.
- D. That the respondents issued the impugned order in a slip shot and arbitrary manner just to delay the promotion of appellant.
- E. That the order of respondent department is against the principle of natural justice, equity and fair play and is a colorful exercise of powers by respondents/department.
- F. That any other grounds would be adduced by the appellant during arguments on the instant appeal with permission of this Honorable Tribunal.

It is, therefore, most humbly prayed that on acceptance of this appeal the impugned order dated 21.06.2022 may kindly be set aside to the extent of appellant and the appellant may kindly be consider as regular / confirmed employee on the post of Sub-Inspector BS-14 also grant/ award the seniority from the date of initial appointment along with whole consequential benefits for which the appellant is entitled/eligible under the law.

STANDING ORDER NO. 03/2015

Mandatory Trainings in Specialised Schools

This Standing Order is issued under Article 10(3) of Police Order 2002 in pursuance of the Police Policy Board decision taken in its 18th meeting held on 13th August 2015.

2. **Aim:** - This Standing Order aims at enhancing the capacity of police officers in such essential skills that would enable them to work effectively and efficiently. KP Police have established a number of specialised schools that are imparting valuable training courses to lower and upper subordinates. It is therefore essential that officers take advantage of these training facilities.

Specific minimum tenure of upper subordinates in the specialised schools needs to be linked with promotion to the next rank.

3. **Mandatory Training for promotion of Upper Subordinates:** - An Upper Subordinate shall not be confirmed and promoted to the next higher rank unless he/she, in addition to other mandatory requirements, completes and qualifies training courses and obtain a total of nine (09) marks in one or more of the following schools:

- A. Police School of Investigation Peshawar.
- B. Police School of Intelligence-Abbotabad.
- C. Police School of Tactics Peshawar.
- D. Police School of Explosive Handling Nowshera.
- E. Police School of Information Technology Peshawar.
- F. Police School of Public Disorder and Riot Management Mardan.

4. A training course of one week duration at any of the above schools will carry one (1) mark while a two week course will carry two (2) marks. A candidate has to successfully complete and qualify each of the courses.

5. An upper Subordinate may choose different courses at any school but will not repeat the same course.

6. All the above mentioned Schools will keep a complete record of the participants of the courses and the marks obtained by each participant in those courses and it would be the responsibility of the Director of each school to share the record with DIG Training and AIG Establishment.

7. On the completion of any course, the Director of the respective School will also send a report in respect of each participant to the Head of the concerned District/ Region/Unit who will be responsible to ensure that the result of the course attended and marks obtained is entered in the service roll of the concerned upper subordinate.


8. Directors of each of the above Police Training Schools will issue the details of all courses that are to be offered in the next six months one month in advance. DIG Training will circulate the schedule etc of the courses among the various units.

9. Respective RPOs and DPOs will nominate officers for the above courses. However, once an officer is selected for a course, his name will not be cancelled. In case an officer nominated for a course does not join the course for which he is selected, he will stand suspended and closed to a Region other than where he is serving.

10. **Application:** - This standing Order will be effective with immediate effect. However, those upper subordinates who are to be promoted within six months of the notification of this order will earn two points prior to promotion while those that are to be promoted between 6 months and one year of the notification of the order will earn three marks prior to promotion.

11. **Power to remove difficulties:**-If any difficulty arises in giving effect to this order, the Provincial Police Officer may by notification make such provisions as deemed appropriate.


12. **Amendment:** - All previous Standing Orders on the subject, to the extent of the provisions of this order, shall stand amended.

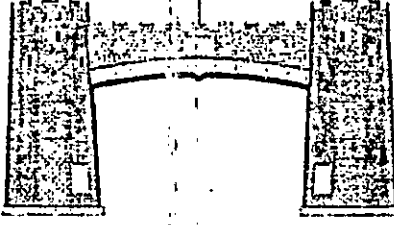

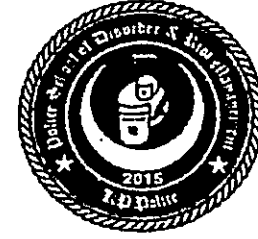

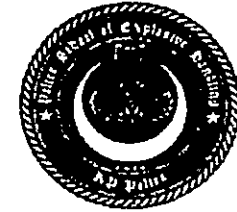

STANDING ORDER NO. 21/2014

Mandatory Tenure for Upper Subordinates in Investigation Branch,
CTD, Special Branch and Police Training Institutions

This Standing Order is issued under Article 10(3) of Police Order 2002 in pursuance of the Police Policy Board decision taken in its 12th meeting held on 9th September 2014.

2. **Aim:-** In order to improve the working of Investigation Branch, Counter Terrorism Department (CTD), Special Branch and the Police training institutions, good officers need be encouraged to work in these branches/units/departments. For this purpose, all upper subordinates may be posted on rotation basis in these branches for specific mandatory tenures.

Specific minimum tenure of upper subordinates in the above-mentioned branches/units/departments needs to be linked with promotion to the next rank.

3. **One-Year Mandatory Tenure for promotion as Inspector:-** An upper subordinate shall not be promoted as Inspector unless, in addition to other requirements, he/she has completed at least one year tenure as ASI or SI, excluding the period spent as long leave, either in the Investigation Branch, CTD, Special Branch or any Police training institution.

4. **One-Year Mandatory Tenure for Promotion as DSP:-** An Inspector shall not be promoted as DSP unless, in addition to other requirements, he/she has completed one year tenure as Inspector, excluding the period of long leave, either in the Investigation Branch, CTD, Special Branch or any Police training institution.

5. This policy shall take effect from 1st June 2015. Those officers who have been posted in the branches/units/departments mentioned in Sections 3 and 4 above but have not completed the requisite tenure till 1st June 2015 shall be considered for promotion but will be confirmed in the respective ranks only after completing the mandatory tenures.

6. In case of posting in the Investigation Branch, one-month orientation training shall be given to those officers who have not served in the Investigation Branch before. The orientation training shall include the following components:

- a. Preservation of Crime Scene (including preservation through photography);
- b. Collection of Evidence from the Crime Scene;
- c. Preparation of Case File;
- d. Cellular Forensics.

7. In accordance with Standing Order No. 6/2014, "period spent in the Investigation Branch by a Sub Inspector as Officer in Charge Investigation of Police Station shall be considered as holding an independent charge of Police Station, one year of such charge



being sufficient for confirmation as Sub Inspector in the substantive rank". This provision shall stand intact.

8. In accordance with Standing Order No.6/2007, for the purpose of promotion as Inspector, three-years posting in Investigation Branch is deemed equivalent to one year posting as SHO. Now onwards, for the same purpose, two-years posting in Investigation Branch shall be deemed equivalent to one-year posting as SHO. Standing Order No. 6/2007 shall stand amended accordingly.

9. **Power to remove difficulties:-** If any difficulty arises in giving effect to this order, the Provincial Police Officer may by notification, make such provisions as deemed appropriate.


10. **Amendment:-** All previous Standing Orders on the subject, to the extent of the provisions of this order, shall stand amended.

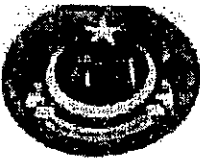

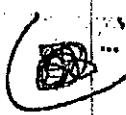

(d) "Schedule" means the Schedule, appended to these rules;

(2) Words and expressions used, but not defined in these rules shall have the same meanings as are respectively assigned to them in the Act.

3. Absorption.---The members of the Khasadar Force shall be permanently absorbed in the Police, against vacancies to be newly created in the Police Department for the purpose, in the following manner:

(a) A Scrutiny Committee, headed by the Commandant, and having one member each from District Administration and District Account Officer of the district concern, shall prepare the lists of all the members of the Khasadar Force after personal appearance and scrutiny of record for submission to the Provincial Police Officer;

(b) the lists, submitted to the Provincial Police Officer, under sub-rule (1), after proper sifting, shall be forwarded to Home and Tribal Affairs Department of Government with the recommendations for permanent absorption of members of the Khasadar Force in the Police into the respective ranks or cadres as per the Schedule; and

(c) the Home and Tribal Affairs Department of Government, after receiving the lists of all the members of Khasadar Force, shall issue notification of absorption of the Khasadar Force in the Police after approval of the Cabinet.

4. Remuneration or Incentives.--The Khasadar Force after absorption in the Police shall be entitled to the same benefits, remuneration and other incentives as are enjoyed by other members of the Police.

5. Training.--Special training modules shall be designed by the Training Wing of the Police for imparting requisite police training so that the members of the Khasadar Force are fully sensitized with all Police functions.

6. Seniority.--Members of the Khasadar Force, who are absorbed in the Police, in accordance with Government orders and instructions, shall take seniority in the Police from the date of the initial appointment upon recruitment in the Khasadar Force:

Provided that the officer inducted in one batch, upon induction, shall retain their inter se seniority as in the Khasadar Force:

7. Repeal and savings.--(1) All rules, orders or instructions, including the Federal Khasadar Force Service Rules, in force in respect of the Khasadar Force, immediately before the commencement of these rules, shall be deemed as repealed in so far those rules, orders or instructions are inconsistent with these rules.

(2) Notwithstanding the repeal of all rules, orders or instruction including the Federal Khasadar Force Service Rules, mentioned in sub-rule (1)-

(a) affecting the seniority and promotion, all promotions done seniority determined and orders made shall be deemed to have been done, determined and made in accordance with law. The repeal, shall not affect any right, privilege, obligation or liability acquired, accrued or incurred under the repealed rules, orders and instructions;
and

(b) shall not affect any investigation or legal proceedings in any Court of Law and shall be continued in the same manner as if the laws and rules have not been repealed.

8. Removing of difficulties.--(1) If any difficulty arises in giving effect to any provisions of these rules and notifications made thereunder, a Technical Committee, comprising of three members of the Police Department, to be notified by the Provincial Police Officer, headed by an Officer of Police, who shall not be below the rank of Deputy Inspector General of Police and two other members of Police Department, whose ranks shall not be less than Senior Superintendent of Police, may recommend to Government for giving effects to the provisions of these rules.

(2) Government, after considering such recommendations, submitted by the Technical Committee, under sub-rule (1), may, by notification, make such orders, not inconsistent with the provisions of the Act or these rules, as may appear to it to be necessary for the purpose of removing such difficulty.

THE KHYBER PAKHTUNKHWA KHASADAR FORCE ACT, 2019.
(KHYBER PAKHTUNKHWA ACT NO. XXXIV OF 2019).

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa, (Extraordinary), dated the 16th September, 2019).

ACT

to regulate and maintain the Khasadar Force previously working in the erstwhile Federally Administered Tribal Areas and now in the merged districts of the Province of the Khyber Pakhtunkhwa.

WHEREAS after Constitution (Twenty-fifth Amendment) Act, 2018 (Act No. XXXVII of 2018), the erstwhile Federally Administered Tribal Areas were merged in the Province of the Khyber Pakhtunkhwa, and the special provisions for the governance system in the said areas were omitted through said amendment, leading to the extension of the executive authority of the Province of the Khyber Pakhtunkhwa to the said areas;

AND WHEREAS the Khasadar Force, which was established in the erstwhile Federally Administered Tribal Areas through Executive Orders and instructions, for management of the said areas within the framework of territorial and collective responsibility, has now lost their legal status, for working in the merged districts and sub-divisions;

AND WHEREAS it is in public interest to allow the Khasadar Force to continue their functions for better public order, peace and security in the merged districts and sub-divisions and to achieve the objectives, it is expedient to give legal status to the Khasadar Force in the merged districts and sub-divisions, and to revisit their institutional structure and functional assignment for effective discipline, better performance and optimal utility:

It is hereby enacted as follows:

1. **Short title, application, extent and commencement.**---(1) This Act may be called the Khyber Pakhtunkhwa Khasadar Force Act, 2019.

(2) It shall apply to all the members of the Khasadar Force.

(3) It shall extend to the districts and sub-divisions of the Province of Khyber Pakhtunkhwa as enlisted in the Schedule.

(4) It shall come into force at once.

2. **Definitions.**---In this Act, unless the context otherwise requires,-

- (a) "Commandant" means the District Police Officer, as defined in the Khyber Pakhtunkhwa Police Act, 2017 (Khyber Pakhtunkhwa Act No. 11 of 2017);
- (b) "Department" means the Home and Tribal Affairs Department the Government of the Khyber Pakhtunkhwa;
- (c) "District Administration" means the Deputy Commissioner, Additional Deputy Commissioner, Assistant Commissioner, Additional Assistant Commissioner and their subordinate staff in the district;
- (d) "District Police Officer" means Head of the Police, under section 21 of the Khyber Pakhtunkhwa Police Act, 2017 (Khyber Pakhtunkhwa Act No. 11 of 2017);
- (e) "Government" means the Government of the Khyber Pakhtunkhwa;
- (f) "Khasadar Force" means the Khasadar Force, constituted through executive orders, for the erstwhile Federally Administered Tribal Areas and now re-constituted and maintained by Government under section 3 of this Act;
- (g) "prescribed" means prescribed by rules;
- (h) "public agency" means any department of Government, attached department, public authority, commission or autonomous body, setup under any statutory instrument, or public sector company or body corporate, owned, controlled or financed by Government;
- (i) "rules" mean rules made under this Act; and

(j) "Schedule" means Schedule appended to this Act.

3. **Re-constitution, regulation and maintenance of the Khasadar Force.**---(1) On commencement of this Act, the Khasadar Force, shall be re-constituted, regulated and maintained by Government in accordance with the provisions of this Act and shall be known as the Khyber Pakhtunkhwa Khasadar Force, consisting of all existing strength of its members.

(2) The Khasadar Force shall be organized in senior ranks and junior ranks officers and officials.

(3) The senior rank officer shall consist of Commandant, who shall be District Police Officer, having additional charge of the Commandant in the district, while the junior ranks shall consist of the following:

- (a) Subedar Major;
- (b) Subedar;
- (c) Naib Subedar;
- (d) Havaldar; and
- (e) Khasadar.

4. **Superintendence, administration and control of the Khasadar Force.**---(1) The overall power of superintendence of the Khasadar Force shall vest in Government.

(2) The general administration and operational control of the Khasadar Force shall vest with the Commandant in the district.

5. **Method of recruitment.**---Subject to other provisions of this Act, recruitment in the Khasadar Force shall be made in the prescribed manner:

Provided that initial recruitment shall be made only in the rank of Khasadar:

Provided further that Government shall specify committee for recruitment and promotion of members of the Khasadar Force:

Provided also that members of the Khasadar Force may be absorbed in the Khyber Pakhtunkhwa Police in accordance with prescribed procedure.

6. **Powers and duties of the Khasadar Force.**---(1) Notwithstanding anything contained, in any other law for the time being in force, the Khasadar Force shall have parallel policing powers as are assigned to the police under the Code.

(2) Without prejudice to the generality of the forgoing policing powers under subsection (1), the Khasadar Force shall perform such institutional or organizational functions and duties as are provided in the Khyber Pakhtunkhwa Police Act, 2017 (Khyber Pakhtunkhwa Act No. 11 of 2017).

7. **Postings, transfers and distribution of the Khasadar Force.**---(1) The Commandant shall be the authority for posting and transfer of members of the Khasadar Force within the district.

(2) Subject to the decision of the Department, a sufficient number of members of the Force shall be placed at the disposal of the District Administration for performing its legally mandated functions.

8. **Liability of Khasadar Force.**---It shall be the duty of every member of the Khasadar Force to obey and execute all lawful orders and instructions, issued to him by the Commandant.

9. **Assistance and support to Government functionaries.**---On the requisition of the District Administration, the Commandant shall provide assistance and support to the District Administration and Heads of all public agencies in the district, required for performing their official duties.

10. **Power to make rules.**---Government may make rules for carrying out the purposes of this Act.

11. **Act to override other laws.**---The provisions of this Act shall have overriding effect, notwithstanding anything contained in any other law, on the subject, for the time being in force.

12. **Actions taken in good faith.**---No suit, prosecution or other legal proceedings shall lie against Government, any authority exercising powers under this Act or any member of the Khasadar Force for anything done in good faith under this Act or any rule made thereunder or matters specified in pursuance of this Act.

Explanation: The phrase "good faith" shall have the same meaning as given to it in section 52 of the Pakistan Penal Code, 1860 (Act No. XLV of 1860).

13. **Removal of difficulty.**---(1) If any difficulty arises in giving effect to any of the provisions of this Act, the Department may notify a committee to take a decision, not inconsistent with the provisions of this Act, as may appear to it to be necessary for the purpose of removing the difficulty.

(2) Save as otherwise specifically provided, nothing in this Act, or any repeal effected thereby shall affect or be deemed to affect-

(a) the existing terms and conditions of service of the Khasadar Force unless amended through a substitute rule or instrument;

(b) the validity of anything done, action taken, investigations or proceedings commenced, orders issued, appointments made, directions given, proceedings taken or instruments executed or issued, under or in pursuance of any rule or regulatory instrument repealed or amended by this Act and any such thing, action, investigation, proceeding, order, appointment, direction, or instrument suit, right or claims shall, if in force at the time of commencement of this Act and not inconsistent with any of the provisions of this Act, shall continue to be in force, and have effect as if it were respectively done, taken, commenced, issued, made, directed, given, executed or issued under this Act; and

(c) anything done, action taken, rule made or notification or orders issued under the Khyber Pakhtunkhwa Khasadar Force Ordinance, 2019 (Khyber Pakhtunkhwa Ord. No. IV of 2019) shall be deemed valid and the same shall not be called in question in any Court of law.

JUDGMENT

ATIQ-UR-REHMAN WAZIR MEMBER (E):- Brief facts of the case are that consequent upon recommendations of Public Service Commission, the appellant was initially appointed as Assistant Sub Inspector (ASI) in Police Department vide order dated 15-12-2010. After completion of officiating period, the appellant was confirmed as ASI with effect from the date of his regular appointment against such post i.e. 10-02-2011. The respondents instead of his date of confirmation entered his name in E list on 08-05-2014 and on the basis of which a revised seniority list dated 27-07-2020 was drawn, which was bad for his future maneuver for promotion, hence he preferred a departmental appeal, which was filed vide order dated 20-05-2020. The appellant filed review petition

dated 23-06-2020, which was not responded within the statutory period, hence the instant service appeal with prayers that the Impugned order dated 20-05-2020 may be set aside and seniority list dated 27-07-2020 may be revised to the extent that the appellant may be placed at list E with effect from the date of appointment i.e. 10-02-2011 and in view whereof, his officiating promotion order dated 03-06-2016 to the rank of Sub. Inspector be revised and be given effect from the date of his eligibility and be confirmed as Sub Inspector under Rule-13(18) of Khyber Pakhtunkhwa Police Rules, 1934 with all consequential benefits.

PRAYER

02. Learned counsel for the appellant has contended that the appellant has neither been treated in accordance with law nor has he been extended equal protection of law, rather his legal vested rights have been violated; that as per rule, list E of all ASIs to be published in the police gazette annually in accordance with Rule-13:11 of Police Rules, 1934; that entry of the officers to such list shall be made from the date of confirmation, but the said list has neither been issued nor circulated to the officers concerned; that the impugned list has been prepared in deviation of rules, hence illegal, therefore, required to be rectified to meet the ends of justice; that Rule-12:2(3) of Khyber Pakhtunkhwa Police Rules, 1934 provides criteria for determining seniority of subordinate ranks of police force from the date of their confirmation, which is 10-02-2011 in case of the appellant, which however is recorded as 08-05-2014, which adversely affected seniority/promotion of the appellant; that similarly placed other colleagues of the appellant had approached Peshawar High Court in Writ Petition No. 3720-P/2018, which was disposed of vide judgment dated 24-04-2019 with direction to respondents to revise list E as per date of confirmation, which was rectified vide order dated 05-06-2020, therefore, the appellant having similar case, is also entitled for the same relief within the meaning of judgment of the Apex Court reported as 2009 SCMR.

03. Learned Deputy District Attorney for the respondents has contended that the judgment of Peshawar High Court dated 05-06-2020, as referred to by the learned counsel for the appellant was judgment in personam, hence was not applicable in case of the appellant as the appellant was not petitioner in the said writ petition; that name of the appellant was removed from list E vide order dated 01-06-2018 under rule-16(33) of Khyber Pakhtunkhwa Police Rules, 1934 and reverted back to the rank of ASI, but upon acceptance of his departmental appeal name of the appellant was restored on promotion list E with restoration of his officiating rank of Sub-Inspector with all back benefits vide order dated 23-10-2018; that a committee for the purpose was constituted to settle the issue of placement of officials on list E from the date of confirmation, but the appellant did not request to the committee for placing him on list E; that contention of the appellant to bring his name on list E with retrospective effect is not justified under the rule.

04. We have heard learned counsel for the parties and have perused the record. Criteria for placing names of upper sub-ordinates has been devised in Rule-12:2 of Khyber Pakhtunkhwa Police Rules, 1934, which is reproduced as under:

Attested

Rule-12:2 Seniority in the case of upper subordinates, will be reckoned in the first instance from date of first appointment, officers promoted from a lower rank being considered senior to persons appointed direct on the same date, and the seniority of officers appointed direct on the same date being reckoned according to age. Seniority shall, however, be finally settled by dates of confirmation, the seniority inter se of several officers confirmed on the same date being that allotted to them on first appointment. Provided that any officer whose promotion or confirmation is delayed by reason of his being on deputation outside his range or district shall, on being promoted or confirmed, regain the seniority which he originally held vis-à-vis any officers promoted or confirmed before him during his deputation.

05. We have noted that the issue of seniority based on list E and criteria for placing names of officials on list E was strongly agitated by the official concerned, for which a committee was constituted to settle the issue once and for all. The committee submitted its report vide order dated 31-08-2017 and in light of Rule-12:2 as well as judgments reported as 2002 PLC (C.S) 1403 and 1999 SCMR 1594, very clearly recommended that confirmation of PASIs would be made from the date of their regular appointment against their posts and their placement on list E would be from the date of confirmation and not with immediate effect. Such report was not implemented, until some of the batch-mates of the appellant filed Writ Petition No. 3720-P/2018 with prayers to implement the decision of the committee regarding fixation of seniority, whereas seniority list E be revised and the petitioner be brought and placed at their due place of seniority and also to ensure the circulation of the seniority list prepared in accordance with law and rules. The said writ petition was disposed of vide judgment dated 24-04-2019 with direction to the respondents to implement recommendations of the committee already submitted to them. In pursuance of the said judgment, confirmation as well as placement of the petitioners on list E was rectified and were confirmed from the date of their appointments vide order dated 05-06-2020. Case of the appellant is also the same but respondents did not bother to consider his case on the same analogy. To this effect, the Supreme Court of Pakistan in its judgment reported as 1996 SCMR 1185 have held that when a court decide a point of law relating to the terms of service of a civil servant which covers not only the case of civil servant who litigated, but also of other civil servants, who may have not taken legal proceedings, in such a case, the dictates and rule of good governance demand that the benefit of such judgment be extended to other civil servants, who may not be parties to the litigation instead of compelling them to approach the tribunal or any other legal forum. In view of the verdict of the apex court, the respondents were required to extend the same benefit to the appellant as well, which however was not

granted to the appellant which was not warranted. The issue of confirmation from the date of appointment has already been decided in similar cases vide judgment reported as 2007 PLC (C.S) 245 as well as judgment dated 07-12-2017 of this Tribunal in Service Appeal No. 573/2016 and judgment dated 18-03-2019 in Service Appeal No. 800/2018. In view of the clear judgments and report dated 31-08-2017 of the committee constituted for the purpose, case of the appellant squarely falls within the purview of similarly placed employees and the department cannot ignore the appellant from extending the benefit of that very judgments.

06. In view of the foregoing discussion, the instant appeal is accepted as prayed for. Parties are left to bear their own costs. File be consigned to record room.

04.12.2008 he was confirmed as SI w.e.f 25.11.2008. Learned counsel for the appellant while relying upon the judgment of this Tribunal passed in service appeal No. 736/2016 titled Amjad Ali Versus Government of Khyber Pakhtunkhwa through Secretary Home & Tribal Affairs Department Peshawar and others, argued that this Tribunal in a number of judgments held that confirmation of officiating police officials shall take place from the date of officiating promotion. Learned counsel for the appellant stressed that the appellant is also entitled to the same relief extended to Amjad Ali in Service Appeal No.736/2016.

2. Mr. Fazal Dad hereinafter referred to as the appellant has
preferred the instant service appeal under Section 4 of the
Khyber Pakhtunkhwa Service Tribunal Act, 1974 against final
order dated 10.08.2015 vide which his departmental appeal for
ante-date confirmation as Sub Inspector w.e.f. 30.07.2010 was
regretted and hence the instant service appeal on 28.08.2015

3. Brief facts of the case of the appellant are that the
appellant was initially appointed as Constable in the year 1986
and then promoted as Head Constable in the year 1996 and as
ASI in the year 2005 and then as S.I in the year 2008 and there-



after promoted as Inspector in the year 2013. That he was promoted as O/Mg, Sub Inspector vide notification dated 21.04.2008 however he was confirmed as S.I on 13.09.2012 while his colleagues including junior to him were confirmed on 30.07.2010 and were assigned seniority in the List "I" accordingly. That the appellant was not confirmed as Sub Inspector as he has not served as S.I.O. That the appellant submitted written application/departmental appeal but in vain and hence the instant service appeal.

4. Learned counsel for the appellant has argued that the appellant was not assigned the duty to serve as Incharge of Police Station. That the said omission is not attributable to the appellant as he was not afforded opportunity to serve as S.I.O by the high ups. In support of his claim reliance was placed on judgement of this Tribunal passed in service appeal No. 407/2011, titled "Mr. Nasir Khan Versus Provincial Police Officer, Khyber Pakhtunkhwa, Peshawar and others" wherein it was observed that it is the authority to give assignment of S.I.O to the appellant and when the authority fails to give such an opportunity then the rule of serving as independent S.I.O for one year would hold no ground. Similar view taken by this Tribunal in service appeal No. 1264/2012 decided on 31.01.2013 as well as appeal No. 37/2011 decided on 03.4.2013.

5. Learned Government Pleader has argued that the appeal

support of his arguments he has placed reliance on judgment of august Supreme Court of Pakistan passed in Civil Petition No. 566/2012 titled "Fariq Habib Khan and others versus the Provincial Police Officer, Khyber Pakhtunkhwa Peshawar and others"

6. We have heard arguments of learned counsel for the parties and perused the record.

7. The impugned final order was passed on 10.08.2015 while the appeal in hand was preferred on 28.08.2015 as such we hold that the appeal is within time. So far as the issue relating to confirmation of the appellant as Sub Inspector w.e.f. 30.07.2010 is concerned the same hold ground as it was not within the authority of the appellant to post himself as SIO of an independent Police Station. Had the relevant authority posted the appellant as SIO and had the appellant failed to perform as SIO despite such posting then the appellant would have not been found entitled to the relief claimed. Since the omission is on the part of the respondents as such the appellant cannot be deprived of his right to ante-date confirmation as Sub Inspector w.e.f. 30.07.2010 i.e. the date on which his colleagues were confirmed.

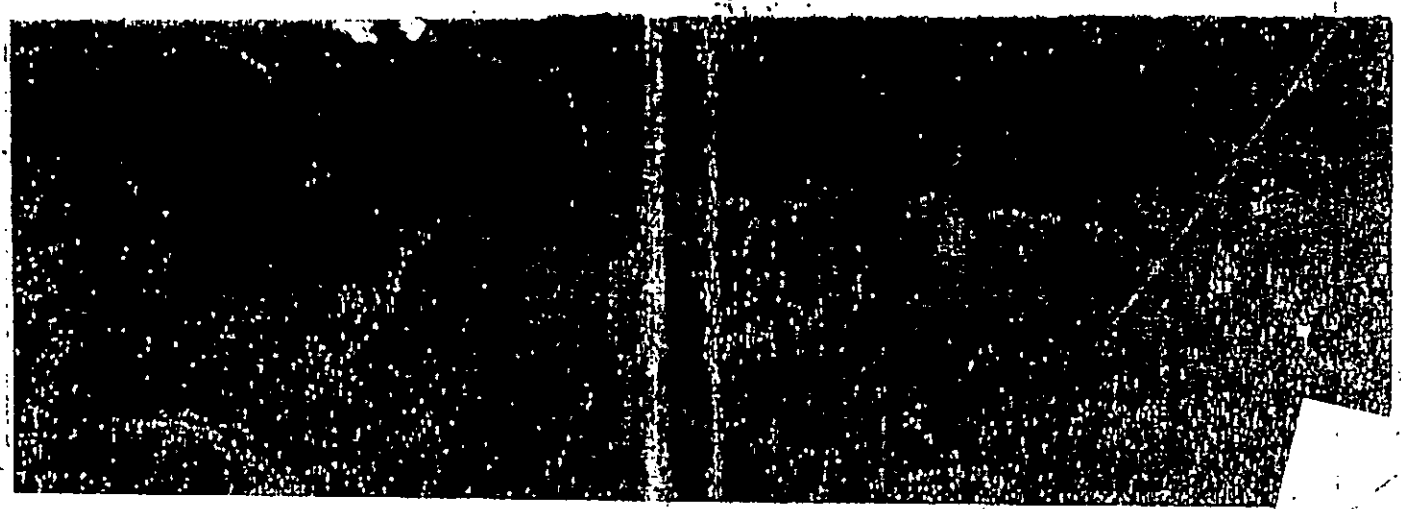
