



APPEAL UNDER SECTION 4 OF THE KHYBER
PAKHTUNKHWA SERVICE TRIBUNAL ACT 1974 AGAINST
THE INACTION OF THE RESPONDENTS BY NOT
CONVENING /SCHEDULED THE PROVINCIAL SELECTION
BOARD FOR PROMOTION OF THE APPELLANT TO THE
POST OF PROFESSOR (BPS-20) AND AGAINST NO
ACTION TAKEN ON THE DEPARTMENTAL APPEAL OF THE
APPELLANT WITHIN THE STATUTORY PERIOD.

Prayer:-

That on acceptance of the instant service appeal, the respondent may kindly be directed to convene/schedule the PSB for the grant of notional/proforma promotion to the appellant to the post of Professor (BPS-20). Any other remedy which this august Tribunal deem fit may also be awarded in favour of the appellant.

R/SHEWETH:

ON FACTS:

Brief facts giving rise to the present appeal are as under:-

- 1) That the appellant had served the respondent department in the Teaching Cadre since 02/01/1993 till superannuation dated 11/12/2023, quite efficient and upto the entire satisfaction of his superiors.
- 2) That as per final seniority list of Associate Professor (BPS-19) Male, College Cadre, the appellant was enlisted at Serial No 66, but later-on was enlisted at Serial No 65 after retirement of one of his senior colleague namely Mr. Nadir Khan. Copy of the seniority list is attached as annexure.....**A**
- 3) That as per record of the respondent department, total 71 posts of Professors (BPS-20) are lying vacant in the promotion zone, and as such the respondent department prepare Working Paper for promotions from the penal of Associate Professor (BPS-19) including the appellant. That accordingly the ibid working papers were send to the Provincial Selection Board by the respondent No 2 to the respondent No 3. Copy of the Working Paper is attached as annexure.....**B**
- 4) That in the ibid working paper, the name of the appellant was enlisted as Serial No 64 of the eligible employees of the respondent department and as such the appellant was hopeful for his promotion to the post of Professor (BPS-20).

- 5) That accordingly vide letter dated 05/09/2023, the PSB was scheduled/convened on 7th September, 2023 at 11:00 am. That in the said letter the Agenda regarding promotion of the Associate Professors (BPS-19) was mentioned at Serial No 47, but unfortunately when the PSB was held on the ibid date, the Agenda of the Associate Professor/appellant's promotion was not considered due to paucity of time. Copies of the letters are attached as annexure.....**C**
- 6) That due to the ibid reason, the appellant reached to the age of superannuation and was accordingly retired from service vide notification dated 12/12/2023 w.e.f. 11/12/2023 after noon without availing the benefit of promotion to the post of Professor (BPS-20). Copy of the retirement notification is attached as annexure.....**D**
- 7) That the appellant feeling aggrieved, filed departmental appeal for notional/proforma promotion to BPS-20 as Professor, but of no avail. Copy of the departmental appeal is attached as annexure.....**E**
- 8) That it is pertinent to the mention here that in the ibid PSB, the promotion of other employees of Teaching Cadre have been discussed and were accordingly recommended for promotion, but unfortunately the Agenda Item of the appellant's promotion was ignored without any reason and clear justification, though the said category i.e. Associate Professor BPS-19 were the senior most amongst the other employees/categories. Copies of notification is attached as annexure.....**F**
- 9) That the appellant highly aggrieved from the impugned inaction of the respondents, approached before the Honourable Peshawar High Court, Peshawar through WP No 210-P/2024, whereby the same has been dismissed vide order dated 19/02/2024 under the bar of Article 212(2) of the Constitution of Pakistan, 1973. Copy of memo of Writ Petition and order dated 19/02/2024 are attached as annexure.....**G&H**

- 10) That now the appellant feeling aggrieved from the inaction of the respondents and having no other remedy but to prefer the instant appeal on following grounds inter alia:-

GROUND:


- A) That impugned inaction of the respondent by not convening the PSB for the cadre of the appellant's promotion to the post of Professor (BPS-20) and not considering the appellant for notional/proforma promotion to the post of Professor BPS-20 is against law, facts, norms of natural justice and material on record hence liable to be set aside/ modified.
- B) That appellant has not been treated by the respondent department in accordance with law and rules on the subject noted above and as such respondents violated the Article 4 and 25 of the Constitution of Islamic Republic of Pakistan.
- C) That the appellant has been discriminated by the respondents, while not considering the appellant for proforma promotion to post of Professor (BPS-20).
- D) That under the fundamental rules and judgment of the Apex Court of Pakistan the appellant is eligible and entitled for proforma promotion to the post of Professor (BPS-20).
- E) That the impugned action and inaction of the respondents is violative of Article 38(e) of the Constitution of Pakistan 1973, therefore liable to be set aside.
- F) That the action and inaction of the respondents by not considering the appellant for promotion to the post of Professor (BPS-20) is violative of Section-9 of the Civil Servant Act, 1973 read with rule 7 of the APT rules, 1989.
- G) That the respondents acted in arbitrary and mala fide manner while not promoting the appellant on proforma basis.
- H) That the appellant is fully entitled for the grant of proforma promotion on the ground that prior to the retirement, the case of the appellant for promotion to the post of Professor (BPS-20) was sent to the PSB, but due to the inaction of the

respondents, the appellant was not promoted and as such the appellant attain the age of superannuation.

- I) That the appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may very graciously be accepted as prayed for, please.
