Counsel for the appellant present. Learned counsel for the appellant argued that the appellant is serving as PET at GHSS Ziarat Masoom for the last ten years. That keeping in view his entitlement he submitted an application to the higher authority seeking his transfer to GHS Samandar Katha Abbottabad. However the respondents, vide impugned order dated 30.07.2016, transferred private respondent No.4 Muhammad Saeed against the said post despite the fact that the appellant having preferential rights under the policy of the Provincial Government. That aggrieved from the said order appellant preferred departmental appeal on 12.08.2016 which was not responded and hence the instant service appeal on 05.12.2016.

That the appellant is entitled to transfer against the post of PET at GHS Samandar Katha Abbottabad and as such the impugned order is liable to be set aside.

Points urged need consideration. Admit. Subject to deposit of security and process fee within 10 days, notices be issued to the respondents for written reply/comments for 17.03.2017 before S.B. The appeal pertains to territorial limits of Hazara Division, therefore, the appeal is assigned to S.B at camp court A/Abad for the date fixed.

Respectfully Sheweth:

The appellant respectfully submits as under:-

Facts.

- 1- That the appellant was appointed as P.T.C. Teacher in the year, 1995, and he was posted on 14.3.1995 as Primary Teacher in G.P.S., Tukorin, District Abbottabad. (Copy of the appointment order is Annexure-A).
- 2- That the appellant was promoted as PET on 18.11.2006 (copy of the promotion order is Annexure-B).
- 3- That the appellant was transferred as PET post at the G.H.S.S. Ziyat Masoom District Abbottabad on 2.4.2009. (Copy of the transferred order is Annexure-C).
- 4- That the appellant was serving at about ten years in G.H.S.S. Ziyat Masoom, as PET teacher due to non-existence of vacancy in Samandar Katha School.
- 5- That the appellant had come to know about the vacant post/vacancy in G.H.S. Samandar Katha, and therefore, he has applied for the said post, but the respondent No.3 appointed another person Mohammad Saeed, respondent No.4, instead of appellant (copy of the departmental appeal and notices of Registered AD are Annexure C/1 to C/4).

6- That the appellant then given application in the shape of appeal to the respondents No.1 to 3, but in vain, and hence this appeal is submitted on the following grounds:-

Grounds of Appeal.

1- That the impugned order of the learned respondent No.3 is illegal, void, against facts, and policy of posting and is liable to be set aside.

2- That the appellant has not been treated in accordance with law and the respondents have acted in violation of Article 4 & 25 of the Constitution of the Islamic Republic of Pakistan, 1973 as well as the service law and rules.

3- That the appellant has served as almost 10 years in G.H.S.S. Ziyrat Masoom, and due to policy of posting he has completed his tenure at the said School. The appellant is still there in G.H.S.S. Ziyrat Masoom due to non-availability of posts. But when he come to know about the vacant post/seat of PET in his village School at G.H.S. Samandar Katha, he applied for transfer to the said post, the respondent No.3 ignored the appellant, and select/transfer respondent No.4, Mohammad Saeed on political influence. Further stated that Mohammad Saeed, respondent No.4 was promoted on 3.10.2014 to G.H.S. Lora and then was by the impugned ordered transferred to

G.H.S. Samandar Katha. Copy of the promotion letter and transferred letter is Annexure E & F.

4- That the respondent No.4 has not completed his tenure at G.H.S. Lora, he served only two years there, but inspite of this he was transferred to G.H.S. Samandar Katha.

5- That the respondents have failed to discharge their legal obligations to act fairly, justly, in accordance with the law, where by the right of the appellant have been denied by the respondents.

6- That the appellant have been given no chance of hearing, and his application in the form of departmental appeal is pending with the respondents since 12.8.2016, and the respondents have also not issue any notice in this regard, and acted illegally.

7- That the appellant is the local residence of Samandar Katha, and he has served at about 10 years in G.H.S.S. in Ziyrat Masoom, which is far away about 60/70 kilometers from his village and it is the right of the appellant to be transferred him to his native village school at the post of PET. Copy of the domicile certificate and NIC is Annexure-H.


8- That it is also inconvenient for the appellant to served in G.H.S.S. Ziyrat Masoom, but it will effect his family as well as his children's education.

It is, therefore, humbly prayed that by acceptance of this appeal, the impugned Order No.5942-48 dated 30.7.2016 and Notification No.7368-72 dated 3.10.2014 passed by the respondent No.3 may please be set aside and the appellant be transferred and posted as PET in G.H.S.


