JUDGMENT

AHMAD HASSAN, MEMBER.- Arguments of the learned counsel for the parties heard and record perused.

FACTS

2. The brief facts of the case are that the appellant was appointed as Patwari (BPS-5) on 15.03.1980. Thereafter, he was promoted as Kanungo. Upon acceptance of Review Petition on 07.07.2010 the appellant was appointed as Naib Tehsildar through administrative order on 23.07.2010. Through impugned order dated 09.09.2016 the order dated 23.07.2010 was withdrawn. That on 04.10.2016 he was appointed as Naib Tehsildar (BPS-14) on acting charge basis. Feeling aggrieved he



filed departmental appeal on 6.10.2016, which was rejected on 16.11.2016, hence, the instant service appeal.

ARGUMENTS

- 3. Learned counsel for the appellant argued that after acceptance of his Review Petition, he was regularized as Naib Tehsildar on 23.07.2010 through an administrative order. Subsequently, this order was withdrawn and he was directed to continue duty as Naib Tehsildar on current charge basis till further orders. Vide order dated 04.10.2016 he was appointed as Naib Tehsildar on acting charge basis. SMBR (Respondent No. 2) was competent to regularize his services as Naib Tehsildar through an administrative order. It was never challenged so it attained finality/acted upon, hence could not be withdrawn at this stage. As he was working as Naib Tehsildar since 2008, so should have been promoted on regular basis instated of acting charge appointment.
- 4. On the other hand learned Assistant Advocate General argued that order dated 23.07.2010 was issued in pursuance of approval by the then SMBR was illegal, hence, rightly withdrawn by the respondents. That order dated 09.09.2016 was issued by respondent No. 2 after affording proper opportunity of hearing to the appellant. That his case was placed before the Departmental Promotion Committee on 27.09.2016 and was cleared for appointment on acting charge basis as no regular post of Naib Tehsildar in the share of Kanungo of Kohat Division was not available at that time.

CONCLUSION

5. The appellant was appointed as Naib Tehsildar on regular basis through administrative order dated 23.07.2010. This order was withdrawn by the competent authority on 09.09.2016. Subsequently he was appointed as Naib Tehsildar on

acting charge basis vide order dated 04.10.2016. Section-5 of Khyber Pakhtunkhwa Civil Servants Act, 1973 provides that appointment to a civil service of the province or to a civil post in connection with the affairs of the province shall be made in the prescribed manner by the Governor or by a person authorized by the Governor in that behalf. Similarly, the procedure for promotion is laid down in Rule-5 & 6 of Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989. It is abundantly clear beyond doubt that there is no place for out of turn promotion through administrative order in the invogue rules. Learned counsel for the appellant was unable to provide any legal backing for the above illegal act. As such promotion of the appellant through administrative order was made in sheer violation of aforementioned rules, hence, illegal, unlawful and not tenable in the eyes of law. Moreover, at the time of promotion his name was appearing at serial no. 13 of the seniority list hence, being junior most was not even otherwise eligible for promotion. Reliance is also placed on case law reported as 2017 SCMR 192, SCMR 206 and 2016 SCMR 1525. The controversy related to promotion/appointment of officials through administrative order working under the administrative control of respondent No. 2 was deliberated at length in service appeal No. 94/2015 decided on 15.02.2018. Through this judgment detailed road map was drawn for dealing with appeals of similar nature including the appeal in hand. In para-17 of the said judgment in order to ensure fair trial, right of hearing was must before recalling any order. Learned counsel for the appellant in para-6 of the appeal and in para-5 of the departmental appeal had conceded that notices dated 15.12.2014 and 28.07.2015 were issued to him to prove his eligibility for promotion as Naib Tehsildar on regular basis. The competent authority withdrew order of his appointment on 09.09.2016 after affording opportunity of showing cause/hearing etc. We have no hesitation in concluding that opportunity of fair trial was extended

to him and action taken by the respondents was in consonance with the aforementioned para of the judgment of this Tribunal dated 15.02.2018.

- 6. In the circumstances in which regular promotions through administrative order was made by the then SMBR raised many questions. Element of speed money in getting undue favour could not be ruled out in these cases. It gives credence to our apprehensions that these illegal orders were obtained in which both the authority and beneficiary had colluded. The then SMBR is still an absconder. Future course of action for tackling such cases in para-18 of the said judgment.
- 7. His case for promotion as Naib Tehsildar was placed before Departmental Promotion Committee on 27.03.2016 and cleared for acting charge appointment, due to non-availability of regular post of Naib Tehsildar in share of Kanungo of Kohat Division. Learned counsel for the appellant was again confronted to produce any documentary evidence about availability of vacant post/eligibility of the appellant to be considered for regular promotion but was unable to defend his position.

8. As a sequel to above the appeal in hand is dismissed with no order as to costs. File be consigned to the record room.

Respectfully Sheweth:-

- 1. That the appellant has been appointed in the Department of respondents as Patwari in BPS-5 on 15.03.1980. (Copy of the service book is attached).
- That the appellant passed his Patwari examination in July 1985 and performed his duties with devotion and being senior most Patwari in District Hangu, promoted as Kanungo.

- 3. That the appellant has passed the examination of Naib Tehsildar on 27.12.2007 under Notification No.40008, dated 27.12.2007. (Copy attached).
- 4. That the appellant as senior most Kanungo in Kohat promoted Naib Tehsildar.
- 5. That the appellant as being senior most Kanungo and being successor of the examination of Naib Tehsildar, filed review petition to the respondent No.2, which was accepted on 07.07.2010 and the appellant has been promoted as regular Naib Tehsildar under order No.14486-91 vide dated 23.07.2010.
- 6. That the appellant was serving on Naib Tehsildar, was served notices on 15.12.2014 and 28.07.2015 by the respondent No.2, requesting his eligibility as being promoted Naib Tehsildar etc.
- 7. That later on, the order issued by the respondent No.2, vide dated 09.09.2016, through which, the regular appointment of the appellant has been withdrawn, and the appellant has been consider as Naib Tehsildar on current charge basis.

8. That on 04.10.2016, after recommendation of department committee, the appellant has appointed as Naib Tehsildar (BPS-14) on acting charge basis in Karak, hence this service appeal on the following amongst the other grounds:

GROUNDS:

- A. That the impugned orders vide dated 09.09.2016 and 04.10.2016 are against law and rules and are liable to be set aside.
- B. That the appellant is legally entitled for promotion as regular Naib Tehsildar since 23.07.2010.
- C. That the appellant is the most senior Kanungo, according to the seniority list issued by the department and also passed the examination of Naib Tehsildar since 27.12.2007.
- D. That the order of the regularization/promotion of the appellant passed on judicial side and the SMBR (respondent No.2) was competent to do so, it was never challenged by any one and had attain finality.
- E. That if is rather a bad practice that the orders of the predecessor is revised or violated, thus the

order of regularization of the appellant on 23.07.2010, is quite legal and in accordance with law.

- F. That the respondent No.2, is competent under the rules to issue promotion order, so the order was acted upon and seniority lists were issued, circulated and the appellant performed his duty as regular Naib Tehsildar about 5 years.
- G. That the appellant has not been treated in accordance with law and his rights secured and guaranteed under the law have been badly violated.
- H. That the appellant has been promoted as current change basis, which is against law and rules.
- 1. That the appellant has serving as Naib Tehsildar since 31.05.2008, while the meeting of the departmental promotion committee has held in the year 2016 and the appellant has been consider as current charge basis instead of, consider him as regular.
- J. That some other ground may be adduced at the time of arguments with the permission of this Honourable Court.

It is ,therefore humbly prayed that On acceptance of this appeal, the impugned orders dated 09.09.2016 and 04.10.2016 may kindly be set aside and the appellant be consider as regular Naib Tehsildar since 23.07.2010 as Senior most.





- 2. That the appellant has passed the examination of Naib Tehsildar on 27.12.2007 under Notification No.4008m dated 27.01.2007 and as being a Senior Kanungo in Kohat, he has been promoted as Naib Tehsildar, on 31.05.2008.
- 3. That the appellant then filed Review petition before the Senior Member Board of Revenue, which was accepted and he has been appointed as regular Naib Tehsildar through judicial Order No.144-86-91/Admin V/PF.AR vide dated 23.07.2010.



PRELIMINARY OBJECTIONS.

- 1. That the appellant has got no cause of action or locus standi.
- 2. That the appeal is bad for mis-joinder and non-joinder of necessary parties.
- 3. That appellant is estopped by his own conduct to institute the instant appeal.
- 4. That the appellant has not come to the Tribunal with clean hands.
- 5. That the Hon'ble Tribunal has no jurisdiction to adjudicate the matter.

ON FACTS

- 1, Pertains to record. Need no comments.
- 2. Pertains to record. Need no comments.
- 3. Incorrect. Passing of Departmental examination cannot make the appellant eligible for out of turn promotion.
- 4. Pertains to record. However appellants was not promoted but posted in own pay scale as Naib Tehsildar. Which is against Law, Rules and even injunction of Islam (2017 SCMR 192, 2017 SCMR 206, 2016 SCMR 1525) (Copies of Supreme Court Judgment are A,B and C).
- 5. Incorrect. Departmental appeal / review petition is filed against order that effect the terms and service conditions of an official and not for out of turn promotion while the services of the appellant was regularized as Naib Tehsildar without holding of Departmental Promotion Committee meeting which is mendatory under Khyber Pakhtunkhwa Civil Servants (Appointment Promotion & Transfer) Rules 1989.
- 6. Correct to the extent on the advice of Establishment Department a notice was served upon the appellant to explain his illegal promotion order.
- 7. Correct to the extent that the promotion of the appellant was made through Administrative order, therefore after affording proper opportunity of hearing his illegal promotion order was withdrawn on 09.09.2016 by the Competent Authority.
- 8. Correct to the extent that promotion case of the appellant was placed before the Departmental Promotion Committee on 27.09.2016 and the appellant has been selected / appointed on acting charge basis.

S.A COMMENTS



- A. Incorrect. The order dated 09.09.2016 and 04.10.2016 are according to law/rules.
- B. Incorrect. At the time to his illegal promotion, the appellant was junior most as his name was at S No .13 of the seniority list and was not eligible for promotion to the post of Naib Tehsildar.
- C. Incorrect. The appellant was junior most at that time Departmental Promotion Committee beside passing of Departmental examination cannot make eligible the appellant for out of turn promotion.
- D. The then Senior Member Board of Revenue has made illegal orders in exercise of self assumed judicial authority and not in exercise of powers under the Khyber Pakhtunkhwa Civil Servant (Appeal Rules) 1986, therefore his illegal promotion order was rightly withdrawn.
- E. Incorrect. Illegal and void order can any time be reviewed / withdrawn.
- F. Incorrect. The Senior Member Board of Revenue is Competent Authority to make promotion / appointment as Naib Tehsildar through holding proper Departmental Promotion Committee meeting.
- G. Incorrect. The appellant has been treated according to law/rules and no violation of any rules committed.
- H. Incorrect. The appellant was only posted on current charge basis.
- Incorrect. His promotion case was placed before the Departmental Promotion Committee on 27.03.2016 and
 the appellant has been appointed on acting charge basis due to non availability of regular post of
 Naib Tehsildar, in the share of Kanungo of Kohat Division.
- j. The Respondents will seek permission to advance additional ground at the time of arguments.

Keeping in view of the above the appeal of the appellant having no legal grounds may be dismissed with costs.
