


On the other hand the learned District Attorney argued that the appellant was considered in the earlier promotion but due to incomplete record his case was deferred and he was never superseded. That the department is willing to reconsider the appellant for promotion in accordance with rules.

It is an admitted position of law that this Tribunal has the jurisdiction in the matter of promotion only to the extent of directing the department to consider an eligible civil servant. The department is willing to consider the appellant for promotion in the next DPC which is due shortly as stated by the representative of the department namely Muhammad Saeed, S.S.

In the light of admission of representative of the department this appeal is disposed of in the terms that the case of the appellant should be considered by fulfilling all the formalities within a period of two months.

This Tribunal on the previous date ordered that the private respondents would be called for comments only when this Tribunal reaches the conclusion that their comments are must and their rights are being affected by this order. Since this Tribunal is not ordering the promotion of the appellant rather only affirm the minutes of the meeting in which the appellant was deferred and direct consideration of appellant for promotion only, the right of the private respondents are not affected at present. The private respondents, if aggrieved from the order of promotion of appellant would be at liberty to avail the legal remedy under the law. Parties are left to bear their own costs. File be consigned to the record room.



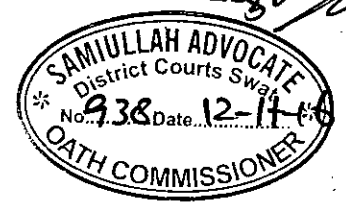

**PRAYER:**

ON ACCEPTANCE OF THIS SERVICE APPEAL, THE IMPUGNED OFFICE ORDER/NOTIFICATION UNDER ENDST: NO.2561-66 DATED 29.07.2016 OF THE RESPONDENT NO.3 MAY BE DECLARED VOID, AB-ANITIO AND AGAINST THE PREVAILING RULES AND POLICY AND THE RESPONDENT NO.3 MAY BE DIRECTED TO PROMOTE THE APPELLANT FROM SENIOR PRIMARY SCHOOL TEACHER (SPST) TO CT (BPS-15) ALONGWITH ALL BACK BENEFITS. MOREOVER, OPERATION OF THE SAID OFFICE ORDER/NOTIFICATION DATED 29/7/2016 OF THE RESPONDENT NO.3 MAY KINDLY BE SUSPENDED TILL THE DISPOSAL OF THIS SERVICE APPEAL.

**Respectfully Sheweth:**

Brief facts of the case give rise for filing the instant service appeal are as under:-

- 1) That the appellant has been inducted in the department of Education as Primary School Teacher, vide appointment order bearing Endst: No.1541-1703/Apptt:PTC/Swat dated 19.04.1999. (Copy of the order is attached as **Annexure "A"**).
- 2) That the appellant was submitted an application before respondent No.3 for providing attested photocopy of the seniority list which was provided to him wherein the appellant has been placed at serial No. 1742. (Copy of application and Seniority list is attached as **Annexure "B" & "C"** respectively.)
- 3) That the respondent No.3 issued the impugned notification/office order under bearing Endst: No.2561-66 dated 29.07.2016 due to which Senior Primary School Teachers (SPSTs) from serial No.1 to 75 have been promoted but without any justification and reason, the respondent No.3 not considered the appellant for promotion despite the fact that he being the most senior from the teachers at serial No.55 to 75/ respondents No.7 to 27. (Copy of impugned notification is attached as **Annexure "D"**)
- 4) That the appellant rendered services about 17 years' service in the department with the entire satisfaction of

the department heads. (Copy of the academic qualification and service book attached as **Annexure "E" & F, respectively**).

5) That aggrieved from the said impugned office order/notification dated 29/7/2016 regarding promotion from SPSTs to CT by the respondent No.3, appellant preferred a departmental appeal before respondent No.3 for considering the appellant for promotion on the basis of appellant qualification, seniority cum fitness for promotion in the light of policy and procedure framed for such like promotion. (Copy of the appeal is attached as **Annexure "G"**)

6) That the appeal of the appellant has not been considered by the respondent No.3 and neither heed has been given to the appeal of the appellant, hence, the instant appeal inter alia on the following grounds:

**GROUNDS:**

- i) That in the impugned Notification/Office Order dated 29/7/2016 Junior SPSTs have been promoted to CT (BPS-15) and the appellant has been ignored and deprived from his constitutional and fundamental right.
- ii) That the above quoted impugned office order/

notification of the respondent No.3 is against the norms of justice and illegal, improper and against the prevailing rules, laws pertaining to the promotion and facts.

- iii) That the appellant has a legitimate right to be promoted as per his qualification, length of service seniority cum fitness but contrary to his legitimate expectation the appellant has deprived from his constitutional right of promotion.
- iv) That the appellant has not been treated in accordance with law and the rules & regulation pertaining to promotion and the blue eyed persons has been promoted by the respondent No.3.
- v) That the respondent No.3 intentionally turned down the departmental appeal of the appellant and deprived the appellant from his promotion with malafide intention while the junior and less qualified Senior Primary School Teachers/ respondents No.7 to 27 have been promoted without any justification and rules.
- vi) That the appellant is a qualified one and fit for promotion and similarly have the right to promotion according to the seniority list and material on record but due to abuse of power exercised by the respondent No.3, the appellant has been deprived from promotion and no heed has been given to his departmental appeal as well.

as his seniority cum fitness.

- vii) That the right of the appellant has been infringed by the respondent No.3 and it seems to make a mockery of the appellant right despite the facts and figures and rules framed for such like promotion.
- viii) That there is no efficacious remedy available to the appellant except to file the instant appeal.
- ix) That the respondent No.3 passed the impugned notification dated 29.07.2016, while closed their eyes and intentionally deprived the appellant from promotion which is against the norms of justice and service rules as well as Civil Servant Act, 1973.

It is, therefore, humbly prayed that on acceptance of this service appeal, the impugned office orders/Notifications as quoted above may kindly be declared unlawful, against the rules and policy and illegal and the respondent No.3 may also be directed to promote the appellant from SPST to CT (BPS-15) in the light of material facts on record with all back benefits. Any other relief deemed appropriate may also be very kindly be awarded in favour of the appellant.
