APPELLANT WAS TOLD BY THE HEAD TEACHER OF DHARA BANDA AS WELL AS ASDEO (M) OGHI. THAT NO POST OF PST AT GPS DHARHA BANDA WAS VACANT. THEREAFTER, APPELLANT STARTED SHUTTLING BETWEEN THE OFFICE OF RESPONDENT NO. 3 FOR HIS ADJUSTMENT IN GOVERNMENT PRIMARY SCHOOL. RESPONDENT NO. 3 INSTEAD OF ADJUSTING THE APPELLANT DISMISSED HIM FROM SERVICE WITHOUT ANY EXPLANATION, REASON, JUSTIFICATION, SHOW-CAUSE NOTICE AND PROVIDING OPPORTUNITY OF PERSONAL HEARING VIDE DISMISSAL ORDER ENDST NO. 6593-99 DATED 02.06.2016 WHICH IS LIABLE TO BE SET-ASIDE.

MUHAMMAD AMIN KHAN KUNDI, MEMBER: - Learned counsel

Arguments heard and record perused.

- 2. Brief facts of the case as per present service appeal are that the appellant was serving in Education Department as Primary School Teacher. He was imposed major penalty of dismissal from service vide order dated 02.06.2016 by the competent authority on the allegation of absence from lawful duty. The appellant filed departmental appeal on 01.07.2016 which was not responded hence, the present service appeal on 21.10.2016.
- 3. Respondents were summoned who contested the appeal by filing written reply/comments.
- Learned counsel for the appellant contended that the appellant was serving in Education Department. It was further contended that the appellant was imposed major penalty of dismissal from service vide order dated 02.06.2016 on the allegation of absence from lawful duty. It was further contended that the appellant was not absent rather he was granted extra ordinary leave with effect from 01.01.2013 to 31.12.2014 by the competent authority. It was further contended that after expiry of the said sanctioned leave when the appellant submitted his arrival report on 01.01.2015 he was told by the Head Teacher that there is no vacant post of Primary School Teacher. That the appellant did his utmost struggle for adjustment as PST in any school on vacant post but instead of adjusting the appellant against the PST post in Primary School the respondent-department dismissed the appellant from service vide order dated 02.06.2016 without issuance of any show-cause notice, proper inquiry and affording opportunity of personal hearing therefore, the appellant was condemned unheard. It was further contended that the appellant has 22 years service in his credit but the same was not considered by the competent authority at the time of imposing of major penalty therefore, the impugned order is illegal and liable to be set-aside.

5. On the other hand, learned Deputy District Attorney for the respondents opposed the contention of learned counsel for the appellant and contended that the appellant was already granted leave with effect from 01.05.2011 to 28.08.2011 (120 days on full pay) 29.08.2011 to 04.05.2012 (250 days on full pay) and 05.05.2012 to 31.12.2012 (246 days without pay) but thereafter, the appellant did not submit arrival report and remained absent from duty. It was further contended that later on the appellant produced order of sanctioned extra ordinary leave with effect from 01.01.2013 to 31.12.2014 but the same was found fake and fact finding inquiry was also conducted by the inquiry committee and the inquiry committee also found the sanctioned order of extra with effect from 01.01.2013 to 31.12.2014 as fake and recommended that the said period be considered as absent from duty and taking action against the appellant and on the basis of inquiry report the competent authority has rightly dismissed the appellant from service. It was further contended that all the codal formalities were fulfilled before imposing the major penalty and prayed for dismissal of appeal.

6. Perusal of the record reveals that the appellant was serving in Education Department as Primary School Teacher. He was imposed major penalty of dismissal from service vide order dated 02.06.2016 on the allegation of absence from duty. The record further reveals that the competent authority has also mentioned in the impugned order dated 02.06.2016 that the appellant was issued show-cause notice vide letter No. 11099 dated 25.09.2014 on his posting address of the appellant but the same was returned with the remarks on envelope by the postman that the appellant is out of country. The record further reveals that the appellant has claimed that he was granted extra ordinary leave with effect from 01.01.2013 to 31.12.2014 and was not absent from duty but the inquiry committee has found the extra ordinary leave with effect from 01.01.2013 to 31.12.2014 as fake. The record further reveals that after

departmental appeal the District Education Officer Male Mansehra has also submitted comments dated 21.07.2016 to the departmental authority i.e Director Elementary and Secondary Education Khyber Pakhtunkhwa Peshawar wherein it was mentioned that the appellant was reported as absent from duty. The record further reveals that the respondents No. 1 to 3 also stated in comments that the appellant was allowed extra ordinary leave with effect from 05.05.2012 to 31.12.2012 without pay and the appellant also received his service book for the same purpose from the department and did not return the same as per findings of the inquiry committee and the inquiry committee has concluded that the appellant did not apply for any extension of leave and added his name fakely vide letter No. 409 dated 07.02.2013. Meaning thereby, that the appellant was absent from duty without lawful authority. However, the record also reveals that the appellant was appointed as Primary School Teacher vide order dated 25.03.1990 therefore, he was having more than twenty years service at his credit therefore, major punishment of dismissal from service appear to be harsh. As such for the purpose of safe administration of justice, we partially accept the present service appeal, modify the original impugned order and convert the major penalty of dismissal from service into major penalty of compulsory retirement from the date of issuance of punishment order i.e with effect from 02.06.2016. Parties are left to bear their own costs. File be consigned to the record room.

Tearned counsel for the appellant argued that the appellant was serving as PST at GPS Dharha Banda when applied for extra-ordinary leave which was sanctioned in favour of the appellant w.e.f. 1.1.2013 upto 31.12.2014. That on completion of leave the appellant reported for duty to his school at GPS Dharha Banda but he was not allowed on the plea that no vacancy for his adjustment was available where-after appellant was compelled to shuffle between different orders for resuming his duty and finally the appellant was dismissed from service vide impugned order dated 02.06.2016 on the allegations of wilful absence where-against his departmental appeal dated 01.07.2016 was not responded and hence the instant service appeal on 21.10.2016.

Respectfully Sheweth;-

- 1. That the appellant got appointment in respondents' department as PST teacher on 25/03/1990. Copy of appointment order is attached as annexure "A".
- 2. That the appellant served the department with complete devotion, dedication and to the entire satisfaction of his superiors.
- 3. That the appellant got extraordinary leave (leave without pay) on different dates as per law. Lastly the appellant got sanctioned extra ordinary leaves on 01/01/2013 to 31/12/2014. Copies of letter as well as page no:21 of service book showing the sanction

of extra ordinary leave, leave without pay are attached as annexure "B".

- 4. that the appellant, after expiry of his extra ordinary leave which was sanctioned by the competent authority reported Govt primary school Dharha Banda i.e. last attended, on 01/01/2015.
- 5. That the appellant tried to take over the charge of the post at GPS Dhara Banda but the head teacher wrote on the charge report of the appellant that there was no vacant post of PST in Bps-12. Therefore, the appellant submitted the charge report having remarks of head teacher to the ASDEO circle oghi for adjustment in any other school; The ASDEO further referred the case SDEO (M) Mansehra for further adjustment against PST post in BPS-12 in his union council on 05/01/2016. Copy of charge report having remarks of ASDEO is attached as annexure "C".

- for adjustment as PST in any school on vacant post. The appellant started shuttling between the offices of respondents department for doing the needful but of no avail.
- 7. That respondent no.3 instead of adjusting the appellant against vacant post of PST in primary school, dismissed the appellant from service vide impugned dismissal order Endst no.6593-99 dated 02/06/2016 without issuing show cause notice, proper inquiry and without affording opportunity of personal hearing which not maintainable at law as well as against the service rules. Copy of impugned dismissal order dated 02/06/2016 is attached as Annexure "D".
- 8. That the appellant feeling aggrieved from the impugned dismissal order, Endst no. 6593-99 dated 2/06/2016 filed departmental appeal to respondent no.2 on 01/07/2016. Copy of departmental appeal is attached as Annexure "E".

9. That respondent no.3 also submitted comments on departmental appeal of the appellant vides letter 8198 dated 21/07/2016. Copy of letter dated 21/07/2016 is attached as annexure "F".

Hence the instant service appeal is filed, inter-alia, on the following grounds,-

GROUNDS:-

- a. That impugned dismissal order dated 02/06/2016 is perverse, discriminatory, Malafide, against the law and liable to be set aside.
- b. that the appellant after expiry of extra ordinary leave, leave without pay reported in time to the school, as well as to ASDEO circle oghi for his adjustment as PST teacher against vacant post in any govt. primary school but the department did not adjust/ post the appellant against the

c.

said post in any school. It is worth to mention here that respondent no.3 was duty bound to adjust the appellant against the vacant post of PST forthwith but he failed to discharge his legal obligation which is Malafide on his part.

That the appellant has been dismissed from service on 02/06/2016 without reason, justification. The appellant touch remained in with the concerned authority for his adjustment in any school as PST teacher but respondent no.3 kept the appellant in dark and finally dismissed him from service That 02/06/2016. as per respondent no.3 was to issue show cause notice and provide opportunity of personal hearing prior issuance of dismissal order. Respondent no.3 without following the mandatory legal formalities issued impugned dismissal order to the

appellant which is liable to be set aside. Hence appellant is entitled to be reinstated in service with all back benefits.

- d. That this fact may not be left to fade in oblivion that dismissal order is arbitrary, one sided and exparte. Therefore, dismissal order has no legal sanctity and is nullity in the eye of law. That the appellant reported for resumption of charge in time but the respondents' department did not issue posting/adjustment order to the appellant which is the fault of the respondents' department and not the appellant.
- e. That the respondents' department has led the appellant to the place which is utterly unknown to the principle of jurisprudence, natural justice and cannon of ethics, as per law ,after expiry of extra ordinary leave, department was legally bound to issue

posting / adjustment order of the appellant as per prescribed procedure.

- f. That there is no other efficacious and prompt remedy available to the appellant except the invocation of jurisdiction of this Honourable

 Tribunal.
- g. That the appeal of the appellant is within time and honorable tribunal has jurisdiction to entertain the instant appeal.
- h. That other point shall be urged at the time of arguments.

It is ,therefore, humbly prayed that on acceptance of the instant appeal, impugned dismissal order no.6593-99 dated 02/06/2016 may graciously be set aside and respondent no.3 may be directed to reinstate the appellant in service w.e.f 01/01/2015 with all service back benefits. Any other relief which this Honourable tribunal deems

appropriate in the circumstances may also be granted to the appellant.



Respectfully Shewth:

PREIMINARY OBJECTIONS:

- 1. That the appellant has got no cause of action locus standi to file the present appeal.
- 2. That the appellant has concealed material facts from his Honorable Tribunal in the instant service appeal. Hence not entitled for any relief and appeal is liable to be dismissed without any further proceeding.
- 3. That the instant service appeal is based on malafide intentions.
- 4. That the appellant has not come to this Honorable Tribunal with clean hands.
- 5. That the appellant is not entitled for the relief he has sought from this Honorable Tribunal.
 - 6. That the instant service appeal is against the prevailing law and rules.
 - 7. That the instant service appeal is not maintainable in its present form.
 - 8. That the instant service appeal is bad for mis-joinder and non-joinder of the necessary parties.
 - That the dismissal order dated 25/09/2014 of the Respondent No. 3 is legally competent & liable to be maintained in favour of the Respondents.
- 10. That the dismissal order is the discretionary powers of the competent authority, and Government Employee is bound to obey the order of the respondent Department, hence appeal is liable to be dismissed on this score alone.

11. That the authority has passed the order dated 25/09/2014 in accordance with Law, hence appeal is liable to be dismissed.

ON FACTS:

- 1. That Para No.01 need no comments, being pertains to the Service Record of the Appellant
- 2. Para No.2 needs no comments because it relate to the service record of the Appellant.
- 3. That Para No.03 is incorrect, misleading and misconceived. As per inquiry conducted by Mr. Sher Muhammad Principal BPS-19 GHSS Gandhian and Mr. Qazi Ibad Ullah BPS-17 Head Master GHS Kolika Mansehra. The Appellant submitted for the first time leave application for the period w.e.f 01-05-2011 to 28-8-2011(120 days on full Pay),29-08-2011 to 4-5-2012 (250 days on full Pay) and 05-05-2012 to 31-12-2012(244 days without Pay) vide office No.8174-77 Dated 31-05-2011 DEO(M) Mansehra. The appellant also received his service book for the same purpose from the Department and did not return the same as per finding of the inquiry committee. The inquiry committee also concluded that the appellant did not apply for extension of leave and added his name fakely vide letter No.409 dated 7-02-2013.(Copy of inquiry report, leave sanction first time vide letter No.8174-77 dated 31-05-2011, Original leave sanction letter of Mr. Saeed ur Rehman and faked sanction leave vide bearing no 409 are annexed as annexure A,B C and D)
- **4.** Para No.4 is incorrect, because the appellant is already absent from his duty and he provided fake sanction of Earned leave.
- 5. That the appellant is absent from his duty.
- **6.** Para no.5 is incorrect because an absent teacher can't be adjusted under the rule .
- 7. Para no.5 is incorrect because appellant inquiry conducted properly and misuse & misreading with the department is being proved. Show cause notice is issued vide letter No.11100-5 dated 25/09/2014 on his posting address i.e GPS Dara Banda registered post, but return with remarks n the envelop by the postman that he was out of county. Due

to forgery & absentees he is dismissal from service and the charges against the accused teacher has been approved. In exercise of the powers conferred under the Khyber Pakhtunkhwa servant (Efficiency & Discipline) Rules,2011 .The competent authority (DEO) Mansehra is pleased to imposed major penalties "Dismissed from Government service" with immediate effect.

GROUNDS:-

- A. Incorrect and denied. Because inquiry has been conducted properly and misuse & misreading with the department is being proved. Show cause notice has been issued vide letter No.11100-5 dated 25/09/2014 on his posting address i.e GPS Dara Banda registered post, but return with remarks in the envelop by the postman that he was out of county. Due to forgery & absentees, he was dismissal from service and the charges against the accused teacher has been approved. In exercise of the powers conferred under the Khyber Pakhtunkhwa servant (Efficiency & Discipline) Rules,2011. The competent authority (DEO) Mansehra is pleased to impose major penalties "Dismissed from Government service" with immediate effect.
- B. Incorrect and denied. Show cause notice has been issued vide letter No.11100-5 dated 25/09/2014 on his posting address i.e GPS Dara Banda registered post, but return with remarks n the envelop by the postman that he was out of county. As per inquiry conducted by Mr. Sher Muhammad Principal BPS-19 GHSS Gandhian and Mr. Qazi Ibad Ullah BPS-17 Head Master GHS Kolika Mansehra.
 - C. Incorrect and denied. After observing all codal formalities and process he is dismissed from services.
 - D. Incorrect and denied .Need no comments.
 - E. Incorrect and denied,.. Because he was already absent from his duty.
 - F. Incorrect and denied. That the appellant has concealed material facts from his Honorable Tribunal in the instant service appeal. Hence not

PRAYERS.

In the view of above made submissions, it is requested that this Honorable Tribunal may very graciously be pleased to dismiss the instant service appeal with cost in favor of the Respondent Department in the interest of justice.

ABSENT REPORT IN R/O MR. AKHTAR MUNIR PST, GPS, DHARA BANDA (CIRCLE OGHI)

Memo:-

Reference your Letter No. 7316-17 dated 14.06.2014. on the subject noted above, we the undersigned visited GPS Dhara Banda and ASDEO (M) Office Oghi on 28.06.2014.

OBSERVATIONS: Questionnaires were given to the Head teacher, teachers and ASDEO concerned.

- 1 .STATEMENT OF MUHAMMAD SABIR HEAD TEACHER;— Statement of Muhammad Sabir H/teacher shows that Mr. Akhtar Munir PST of GPS. Dhara Banda went on leave on 01.05.2011 to 31.12.2012. His application moved through ASDEO Oghi circle and sanction was accorded by DEO (M) Mansehra On 31.05.2011. He further stated that On expiry of Earned leave, MR.Akhtar Munir did not submit his application for the extension of leave through proper channel. However, he Informed him telephonically that his E.O.leave for two years has been extended and a letter of the same be got from an unknown person. I got the copy of the sanction letter from the person pointed out by him. A copy of the letter kept in Office file and the other handed over to ASDEO Oghi circle (Copy attached as Annexure A.
- 2. <u>STATEMENT OF MR. JEHANGIR BADAR, PST</u>;— According to the statement of the teacher, Mr.Akhtar Munir handed over the sanction letter of E/leave for the period of 01.05.2011to 31.12.2012 He also Stated that after the expiry of the leave perid, Mr. Akhtar Munir told telephonically that a letter for extension in leave was kept with one of his relatives in Mansehra and requested that the letter be received from that person whose name he has been forgotten. We got the letter and a copy was sent to ASDEO Oghi circle. (Copy attached as Annexure B).
- 3. MR. MUSHTIAQ AHMAD CENTRE INCHARGE CIRCLE OGHI Stated with reference to his Office record that Mr. Akhtar Munir PST GPS Dhara Banda has been accorded E.O.L. w,e,f, 1.,5. 2011 to 31.12.2012 vide letter No 8174-77 dated 31.5. 20111. The centre Incharge further added that the teacher concerned did not contact for the extension in leave period and resultantly the then ASDEO sent his absent report through letter No. 277 dated 13.5.2013. Later on , a letter No. 2352-54 dated 5.03.2013 regarding the extension in the E.O.L. wef 1.1.2013 to 31.12.2014, received through H/Teacher GPS. Dhara Banda.

The DEO Office when contacted for the verification of extension in EOL for the period mentioned above, the Office response found in this respect unsatisfactory. The newly appointed ASDEO Oghi, Mr. Muhammad Nadeem submitted the absent report of the teacher in question vide his letter No 20 dated 27.5.2014 but no action has been taken. The centre in charge also stated that the service Book of the teacher was not returned to the circle office taken first time to apply for the leave adding that his Office had no record of the application for the extension of leave period and hence his pay was stopped w.e.f. 01.05.2011 (copy attached as Annexure C)

- 4. Record obtained from the DEO Office shows i.) The application for the extension of the leave was not submitted properly i.e. the application is without date and recommendations by the H/Teacher and ASDEO concerned.
 - ii). The teacher's name is absent in PUC record.

iii. The service Book, according to the dealing Assistant, was in the custody of the teacher.

FINDINGS:- On the basis of the statements of the teachers / ASDEO and the record provided by the DEO Office shows that ;-

- a) The application submitted for the first time for the period w.e.f. 01.05.2011 to 31.12.2012 fulfilled the proper procedure. However, the application for the extension of leave w.e.f. 01.01.2013 to 31.12.2014 has not been submitted by the teacher through proper channel
- b) Sanction letter for the extension of EOL seems to be amended faked (Annexture DoEnF)
- c) Service Book of the teacher is missing
- d) The Teacher's name has not been found in the PUC provided by the DEO office (Annexture s)

RECOMMENDATIONS:- On the basis of the statements of the Head teacher, Teachers & office record, it is recommended that the extension in leave period w.e.f. 01.01.2013 to 31.12.2014 be considered as absent from duty and necessary action in this direction may please be taken according to the rules.
