



The appeal is referred to your Honour under rule 7(c) of Khyber Pakhtunkhwa Rules 1974 for appropriate order please.







Appeal under section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974 and other promulgating rules against the order dated 04-07-2023 issued by respondent No. 4, vide which respondent No. 5 was illegal promoted/posted as junior clerk and the impugned order dated 04-07-2023 is void ab initio and liable to be set aside.

Respectfully submitted

- 1- That the appellant is posted as Behshti in Government girls Middle School JadidAbadiJhandola District Tank and the petitioner is performing his duties with great zest and zeal.
- 2- That the Government of Khyber Pakhtunkhwa, Established Department issued policy dated 18-07-2019 for promotion of

Class Four to the post of Junior Clerk subject to educational qualification for the post of Junior Clerk. Copy of the policy issued by the Establishment Department KPK is enclosed as annexure "A".

3- That respondent No. 4 prepared seniority list of the class four and petitioner is on serial No. 25 on the seniority list but holding 1st position for the purpose of promotion. Copy of the seniority list is enclosed as Annexure "B"

4- That respondent No. 5 was posted in the office of District Education Officer (M) Tank, but suddenly, respondent No. 4 called the respondent No. 5 from the office of the District Education Officer (M) Tank and appointed him against the post of junior Clerk on the basis of deceased son quota vide order dated 04-07-2023. Copy of the order dated 04-07-2023 is enclosed as annexure "C".

5- That the appellant feeling aggrieved from the impugned order dated 04-07-2023, submitted departmental appeal before the Director elementary and secondary education Peshawar but appeal of the appellant was not decided in the statutory period. Hence the instant appeal. Copy of the departmental appeal is enclosed as annexure "D".

Grounds;-


1- That the impugned order dated 04-07-2023 is against the law, facts and circumstances of the case and the same is liable to be set aside.

2- That respondent No. 5 is not entitled for appointment/promotion against the post of junior clerk as the respondent No. 5 does not belong to the officer of respondent No. 4 and respondent No. 4

was not entitled to appoint the respondent No. 5 against the post of junior clerk.

- 3- That it is very much clear from the seniority list that only the appellant qualifies the requirement for promotion amongst the class four having the required qualification and the petitioner is on serial No. 1 for the purpose of promotion and the appellant was illegally and mala fidely ignored for promotion just to adjust the blue eyed on the basis of personal likes and dislikes.
- 4- That the impugned order dated 04-07-2023 is totally against the policy given the Government of KPK and respondents were bound to promote the appellant against the post of junior clerk amongst the class four employees.
- 5- That counsel for the petitioner may kindly be allowed to raise additional grounds during the arguments


