#### Respectfully Sheweth,

The Honorable Service Tribunal Khyber Pakhtunkhwa vide order dated 18.01.2024 was pleased to direct "Despite commitment on previous date, implementation report on behalf of respondents are still awaited. Respondent No. 2 & 3 are directed to appear in person along with proper implementation on the next date positively, failing which coercive measure shall be initiated. Adjourned. To come up for implementation report on 20.02.2024 before S.B at Camp Court D.I.Khan. P.P given to the parties".

In this regard it is submitted that the petitioner / decree holder was initially appointed as Assistant Oral Master (BPS-09) on contract basis by the Erstwhile District Coordination Officer, D.I.Khan whose services were later on regularized and served the respondent department up till 28.02.2010 i.e. 05 years 06 months and 04 days. Although Finance Department Khyber Pakhtunkhwa vide circular dated 24.07.1986 (Annex-A) allows new scale of pay effect (BPS-16) & (BPS-17) to the teachers of Special Education Institutions who have:

a	Trained Graduate Teacher B.A/B.Sc, B.Ed with the adequate Knowledge in the Education of deaf to be certified by the Social Welfare Directorate.	B-17	
b	Un-trained Graduate and post-graduate Teachers (B.A/B.Sc.M.A/M.Sc) with adequate knowledge in the education of deaf to be certified by the Social Welfare Directorate.	B-16	These teachers must acquire B.Ed within a period of three years.

#### PROCEDURE:

There are various sanctioned posts of teachers having different nomenclature, job description, pay scales and prescribed qualification for initial recruitment. As a matter of facts some of the teachers have already the prescribed qualification pre-appointment while others possess the

)

requisite qualification post-appointment, for (new) scale of pay effect. Subsequently, applications along with attested educational certificates / degrees are submitted by the teachers for grant of (new) scales of pay effect to the Directorate of Social Welfare. It is worth mentioning that pre notifying the Assessment Committee vide order dated 24-10-2016 (Page 67) head of institution concerned had issued the Adequate Knowledge Certificate on behalf of Directorate whereas post constitution of the assessment committee regarding adequate knowledge in relevant field, adequate knowledge certificates are issued on the recommendation of the said committee and thus the Directorate submit working paper to the Administrative Department in case of (new) scales of pay effect (BPS-17) while the cases of (new) scale of pay effect (below BPS-17) are disposed of at Directorate level.

As far as the case of the petitioner / decree holder is concerned, it is stated that neither applied for new pay scale effect nor submitted academic documents along with adequate knowledge certificate at the time of his service herein in the respondent department.

Since graduation and adequate knowledge certificate for award of BPS-16 & graduation followed by B.Ed degree along with adequate knowledge for BPS-17 are pre-requisite as per law. Although the petitioner might have B.A / B.Ed qualification but had no adequate knowledge in the relevant field duly assessed by any expert.

Moreover, it is worth to add here that the spirit of the (new) pay scale effect is an award to the Special Education Teachers in lieu of imparting formal education to the Special Children in inclusive method while the petitioner has left the services to impart education to the special children, hence neither his expertise in the relevant field at this stage could be assessed nor could have been assessed while serving.

Keeping in view the above, this Directorate facing difficulties in way of the implementation of the judgment dated 04.12.2020 and therefore, humbly prayed that the instant implementation report may kindly be accepted.
