Learned District Attorney on behalf of the respondents present.</p> <p>2. The appellant has filed the present appeal under section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974 and made impugned the order dated 17.03.2016 whereby allegedly juniors to the appellant have been promoted from the post of SST to the post of SS while the appellant has been allegedly ignored.</p> <p>3. Learned counsel for the appellant contended that by ignoring the appellant from promotion to the post of SS, he has not been</p>

treated in accordance with law. Further argued that the appellant has a spotless service record and has also submitted his PER,s regularly. Learned counsel for the appellant also submitted affidavit of the appellant to the effect that the appellant submitted his PER,s to the DEO (Male) for onward submission. Learned counsel for the appellant stressed that the appellant is fully entitled to promotion from the date his junior colleagues were promoted.

4. As against that learned District Attorney while defending the impugned order also referred to the minutes of the meeting of departmental promotion committee held on 20.10.2015 and argued that the appellant was deffered for want of PER.

5. Arguments heard. File perused.

6. Perusal of the minutes of the meeting of departmental promotion committee held on 20.10.2015 would show that the departmental promotion committee deffered the promotion of many SET,s including the appellant for the reason of want of PER. It is the stance of the appellant in the court during arguments and an affidavit also submitted by him that he had submitted PER,s to his DEO (Male) for its onward submission to the Directorate of Peshawar. Hence in the given circumstances of the case the respondent department is directed to probe into the matter and in case it is found that the appellant was otherwise eligible to be promoted and had also submitted his PER,s to the Quarter concerned and that if the promotion of appellant was deffered

without any lapse on his part, then the respondent department is further directed to consider the appellant for promotion as SS from the due date. The present appeal is disposed of in the above terms Parties are left to bear their own costs. File be consigned to the record room.



Learned counsel for the appellant argued that the appellant is serving as SET (BPS-16) and was entitled to promotion to the post of Subject Specialist (BPS-17) but ignored vide impugned order dated 17.3.2016 on the ground that his qualification was not relevant to promotion as S.S (BPS-17) where-against he preferred departmental appeal on 01.06.2016 which was not responded and hence the instant service appeal on 30.09.2016.

That the appellant is holder of M.Sc degree in Fuel Technology which was equated as M.Sc. in Chemistry by the Academic Council of Peshawar University vide letter dated 21.10.1990 and as such the impugned order denying promotion to the appellant and promoting juniors to him is against facts and law and liable to be set aside.

Points urged need consideration. Admit. Subject to deposit of security and process fee within 10 days, notices be issued to the respondents for written reply/comments for 03.12.2016 before S.B.



Service Appeal under Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974, against the Promotion Notification dated 17.03.2016, whereby Juniors to the appellant has been promoted from the post of SST-16 to the post of SS BPS-17 while the appellant has been ignored, against which his departmental appeal dated 01.06.2016, has not been responded despite the lapse of 90 days statutory period.

On acceptance of this appeal the impugned dated 17.03.2016, may please be set aside/varied/modified and the respondents may please be directed to consider the appellant for promotion to the post of SS BPS-17, from the date when his juniors/colleagues have been promoted with all back/consequential benefits.

Respectfully Submitted:

1. That the appellant was initially appointed as SST BPS-16 in the respondent Department in the year 1999. Later the appellant was also upgraded to BPS-17. Ever since his appointment the appellant is performing his duties as assigned with zeal and devotion and without giving any chance of complaint whatsoever regarding his performance. As such he has at his credit a spotless service career at his credit. **(Copy of the appointment order is attached as Annexure A)**
2. That under the rules notified vide notification dated 24.07.2014, the next post in the channel of promotion to the post of SST is Subject Specialist (SS) BPS-17, under the Rules 50% promotion quota is reserved for SSTs BPS-16. Relevant para of the rules is reproduced below:

“(a) Fifty percent by promotion on the basis of seniority com-fitness, for the relevant subject from amongst the Secondary School Teachers (BPS-16), with at least five years service as such and having qualification mentioned in column No.3.

The rules have further prescribed the following qualification in Column 3 for the post of Subject Specialist BPS-17.

- i. *At least second class Master’s Degree or four years BS Degree in the relevant subject, and*
- ii. *Bachelor of Education or Master of Education (Industrial Art or Business Education) or M.A Education or equivalent qualification from a recognized University.*

(Copies of the Rules are attached as Annexure B)

3. That the appellant has acquired the qualification of MSc in Fuel Technology in the year 1990 from the University of Peshawar. It is pertinent to mention here that in the year 1990, on the closure of the department of Fuel Technology, the Academic Council of the University of Peshawar in its meeting held on 20.09.1990, allowed M.Sc Degree in Fuel Technology to be equivalent to M.Sc in Chemistry and the holders of the Degree were held eligible for teaching of Chemistry at the College level. To this effect an equivalency certificate dated 21.10.1990 was also issued. **(Copies of the M.Sc. Degree, minutes of the meeting dated 20.09.1990 and equivalency certificate dated 21.10.1990, are attached as Annexure C, D & E)**

4. That despite the above explained position, recently the respondents raised objection on the degree of the appellant being not relevant and were not considering him for promotion on this score, therefore the appellant duly applied to the University of Peshawar and the University vide letter dated 23.11.2015 forwarded the case of appellant to the Higher Education Commission Islamabad. **(Copy of the letter dated 23.11.2015 is attached as Annexure F)**
5. That the Higher Education Commission Islamabad vide letter dated 29.04.2016, informed the appellant that the Higher Education Commission recognizes the Master of Science in fuel Technology degree held by the appellant from university of Peshawar equivalent to Corresponding Master Degree in relevant field. **(Copy of the letter dated 29.04.2016 is attached as Annexure G)**
6. That recently the respondents promoted 737 male SST's (BPS-16) to the post of subject specialist (BPS-17), vide order dated 17.03.2016. Wherein the appellant was deprived of promotion and juniors to the appellant were considered and promoted. As per seniority list, name of the appellant is placed at Sr. No. 2849 and SST's up to the seniority No. 4096 were considered for promotion. The notification letter, however, never communicated to the appellant. **(Copy of the notification dated 17.03.2016 is attached as Annexure H)**
7. That the appellant got the knowledge of the said impugned notification dated 17.03.2016 in May 2016, where after the appellant filed his departmental appeal through proper channel on 01.06.2016, however the appeal has not been responded within the statutory period of ninety days, hence the instant appeal. **(Copy of the departmental appeal is attached as Annexure I)**
8. That the appellant prays for the acceptance of the instant appeal inter alia on the following grounds:

GROUND OF SERVICE APPEAL

- A. That the appellant has not been treated in accordance with law/ rules hence his rights secured and guaranteed under the law are badly violated.
- B. That the mandatory provisions of Section 9 of Khyber Pakhtunkhwa Civil Servant Act, 1973 read with Khyber Pakhtunkhwa Civil Servant (Appointment, Promotions and Transfer) Rules, 1989 and enabling instructions contained in the ESTA Code have not been adhered thus the appellant has been deprived of his legal and due rights.
- C. That the applicant has at his credit the qualification of M.Sc, (fuel technology) which has been given equivalence to M.Sc, Chemistry by the HEC, moreover he being amongst the senior as per seniority list of SST BPS-16, therefore perfectly eligible to be considered for promotion to the post of Subject specialist. The appellant waited that he would be considered for promotion to the post of Subject Specialist BPS-17 as and when posts in the promotion quota occurs but now he has been deprived of his accrued right of consideration for promotion to the post of Subject Specialist.
- D. That even otherwise the appellant was appointed as SST (Bio Chemistry), right from his appointment he has taught the Chemistry as subject and have sufficient experience, moreover the concerned University had also held the degree of MSc fuel Technology obtained by the appellant equivalent to MSs Chemistry, thus the objection of the respondents regarding the qualification of the appellant is baseless.
- E. That not considering the appellant for promotion on the ground that he does not possess the required qualification is illegal, against the policy, unlawful and violative upon his rights and is highly discriminatory.
- F. That the appellant has a clean and spotless service career at his credit thus deserves to be considered for promotion.

G. That the appellant also seeks permission of this Honorable Tribunal to rely on additional grounds at the time of hearing of the appeal.



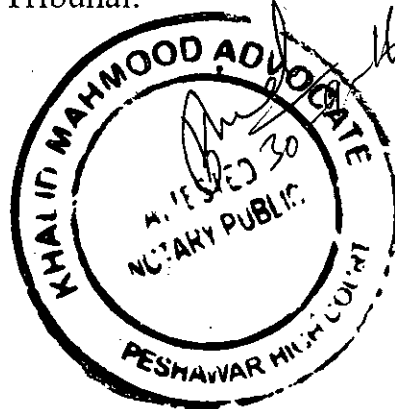

The meeting commenced with recitation from the Holy Quran by Dr. Mohammad Majid, Chairman, Department of Geology. The Vice-Chancellor welcomed the members of the Academic Council to its first meeting of the new session, and referred to the voluminous Agenda before them which necessitates holding of two meetings of the Academic Council every year. The Vice-Chancellor therefore announced that the next meeting of the Academic Council would be arranged in January/February, 1991 so that cases are settled in time.

The Vice-Chancellor then alluded to the Unfairmeans/Discipline Committee Rules which requires certain appropriate additions/alterations in order to empower the University authorities to impose fine and penalties on those found guilty of cheating in the Examination or those creating disturbance in the Examination Halls. The Academic Council agreed to this proposal and also authorised the Vice-Chancellor to allow re-checking of answer books on prescribed fee as and when deemed necessary. The Vice-Chancellor also referred to yet another important point for considering whether to admit boys at the various levels on the basis of their marks obtained in the earlier Board/University examination, or to arrange regular entry test/examination to all Departments/Colleges etc.

It was proposed that the matter be referred to the Faculty Boards to examine the problem and give its recommendations on the question of entry test/examination.

The Vice-Chancellor then referred to the closure of Fuel Technology Department and the question whether or not the degrees of this department be equated to degree in Chemistry, as such degree holders are requesting for. The Academic Council considered the issue with sympathy and allowed M.Sc. degree in Fuel Technology to be considered equivalent to B.Sc. in Chemistry and the holder of this degree be considered eligible for teaching of Chemistry at the college level. Another important issue brought forth by the Vice-Chancellor was regarding the quota system for admission in the colleges/Departments of the University, and the question whether these be abolished altogether. The Academic Council, after thorough discussion on the above mentioned problem, desired to consider all aspects of the issue before taking any final decision.

The Academic Council then discussed the Agenda itemwise as under:-

ITEM NO.1: PROCEEDINGS OF THE BOARD, FACULTY OF SCIENCE DATED 10-2-1990.

The case was discussed thoroughly and finally recommended the item to the Syndicate.

ITEM NO.2: PROCEEDING OF THE BOARD, FACULTY OF ARTS DATED, 17-2-1990.

As pointed out by Mr. Farid Khan, the Quorum was incomplete during the meeting, therefore the item was referred to the next meeting of the Board, Faculty of Arts. It was also resolved that the change in the nomenclature should have been routed through the Board of Studies in Archaeology.

ITEM NO. 3 : PROCEEDING OF THE BOARD, FACULTY OF SCIENCE DATED 1-7-1990.

The Board, after thoroughly examining the case, recommended the item for approval.

It was resolved that as far as the general recommendations for the improvement of Academics are concerned the respective Board of Studies should have regular monthly and yearly meetings and proceedings thereof be sent to the Vice-Chancellor for his information. It was also decided to include Directors of Centres in the Research Committee of the Faculty at S.No.11 of the recommendations and to add one more to it at S.No.22 for preparation of Brochures by the respective faculties, which should give details of the courses.

Item No. 4: PROCEEDING OF THE BOARD, FACULTY OF EDUCATION AND SOCIAL SCIENCES DATED 28-2-1990.

The item was discussed thoroughly and finally recommended to the Syndicate for consideration.

ITEM NO.5 : PROCEEDING OF THE BOARD, FACULTY OF ISLAMIC STUDIES AND ARABIC DATED 31-1-1990.

The item was recommended by the Academic Council.

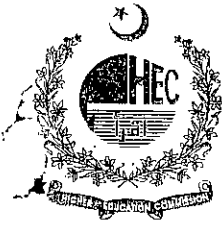



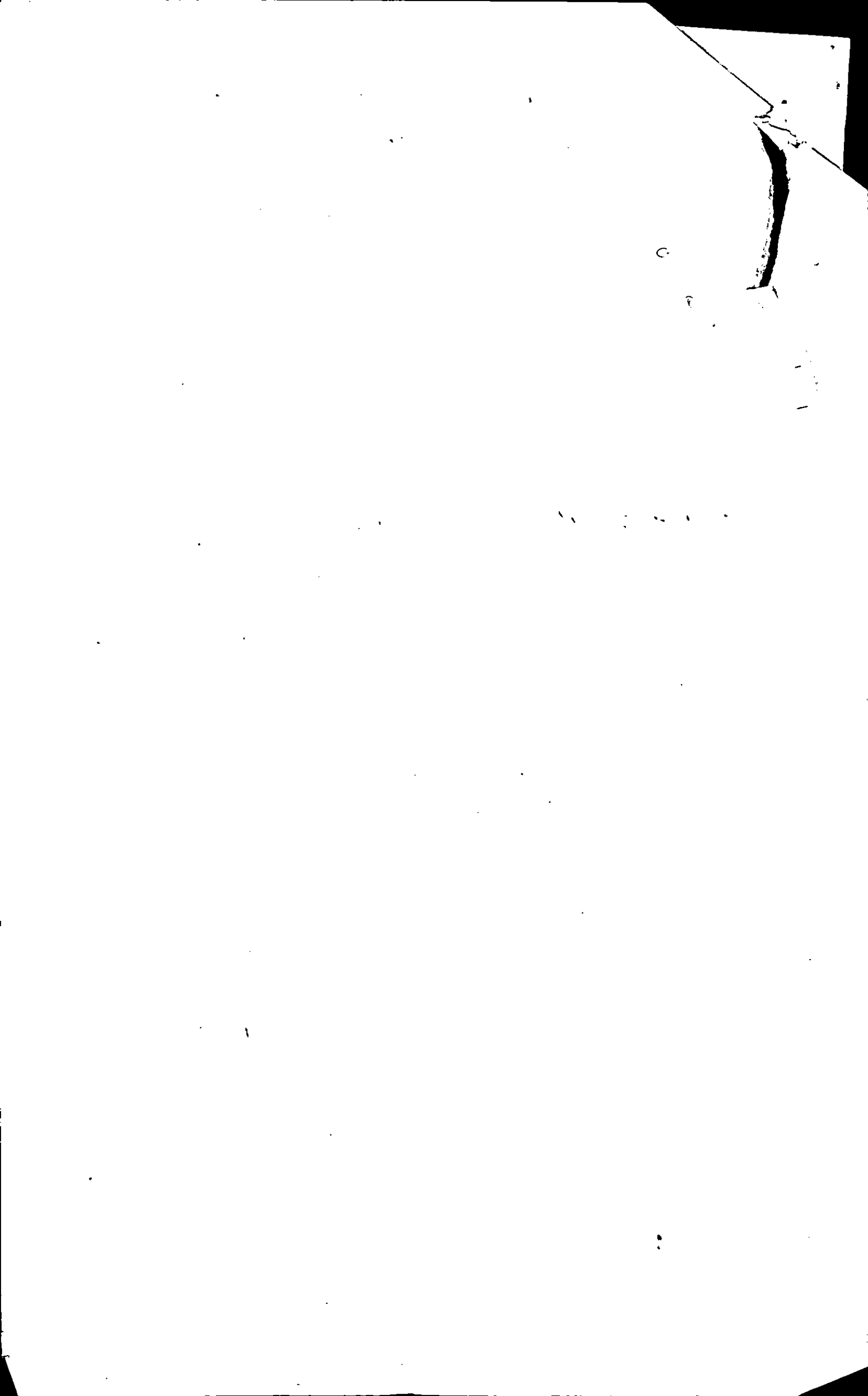

Respectfully Sheweth :-

The Respondents submit as under:-

PRELIMINARY OBJECTIONS.

- 1 That the Appellant has got no cause of action locus standi.
- 2 That the instant Service Appeal is badly time barred.
- 3 That the Appellant has concealed material facts from this Honorable Tribunal in the instant service appeal.
- 4 That the instant service appeal is against the relevant provisions of law.
- 5 That the appellant has not come to this Honorable Tribunal with clean hands.
- 6 That the instant appeal is liable to be dismissed for mis-joinder & non-joinder of the necessary parties to the present appeal.
- 7 That the appellant is estopped by his own conduct to file the instant appeal.
- 8 That the Appellant was considered & defend. Hence this Honorable Tribunal has no jurisdiction to adjudicate the matter.
- 9 That the impugned Notification dated 17/3/2016 is legally competent & liable to be maintained in favour of the Respondents in the interest of justice.
- 10 That the instant Appeal is barred by law.

ON FACTS .

- 1 That Para-I needs no comments being pertains to the service record of the appellant.
- 2 That Para-2 is correct to the extent that the Respondent Department has promoted the eligible SSTs against the Subject Specialist Post vide the impugned Notification dated 17/3/2016 in view of the Rules as notified vide Notification dated 24/7/2014, wherein 50% quota has reserved for promotion from SSTs to Subject Specialist in BPS-17 with the prescribed qualification of MA in the relevant subject alongwith B. Ed both at least in 2nd Division from dully recognized University of the country, wherein, the appellant has been rejected for the grant of promotion against the Subject Specialist Post in BPS-17 on

the grounds that the appellant has the qualification of M. Sc in Fuel Technology which is not relevant for the grant of promotion in BPS-17 against the SS Post as admitted by the appellant in Para-3 of his own appeal. Similarly the grant of Equivalence Certificate issued by the Higher Education Commission Government of Pakistan vide Certificate No: 8-61/HEC /A&A /2016 /3234 dated 29/4/2016, wherein, vide last Para it has been clearly mentioned the concerned University & employee Agency / Department shall determine the suitability in relation to the job requirement of the appellant. (Copies of the relevant documents are Annexure-A & B).

- 3 That Para-3 is incorrect & denied on the grounds that the appellant has the qualification of M. Sc in Fuel Technology which, is irrelevant subject in the Respondent Department neither the same is being taught at both High & Higher Secondary School, hence he has been rejected vide S/No: 2312 Seniority No: 2777 page-68 in the minutes of the meeting of the Departmental Promotion Committee held on 20/10/2015 a copy whereof, is already attached as Annexure-B. Hence the plea of the appellant in this Para is liable to be dismissed.
- 4 That Para-4 is correct to the extent that the Respondent Department vide Notification dated 17/3/2016, has allowed promotion to the eligible SSTs against the Subject Specialist Post in BPS-17, wherein, the appellant has not submitted the required documents including ACRs /PERs for the reason better known to him. Hence he has not been considered for promotion against the Subject Specialist Post in BPS-17(Regular) by the Respondent Department. It is further submitted that the appellant has applied for the grant of equivalence certificate on 23/11/2015 to the Higher Education Commission Govt: of Pakistan, whereas, the DPC meeting was held on 20/10/2015 in the Respondent Department. (Copy of the same is annexed as Annexure-C).
- 5 That Para-5 is incorrect & denied. The HEC Govt: of Pakistan vide letter dated 29/4/2016 has not grant equivalence certificate of M. Sc in Fuel Technology equivalent to M. Sc Chemistry in the Burdon of proof regarding suitability of the candidate in relation to the job requirements has been shifted upon the Respondent Department instead of the grant of equivalence Certificate in the above mentioned Subject / Degree.
- 6 That Para-6, is correct that vide the impugned Notification dated 17/3/2016 annexure-C, the Respondent Department has promoted 737(Male) SSTs BPS-16 to the Post of Subject Specialist in BPS-17 wherein the appellant has not been promoted in view of the above made submissions in the foregoing Paras of the instead reply on behalf of the Respondents but he was considered & differed which is evident from the minutes of Provincial Selection Board (PSB) already annexed.
- 7 That Para-7 is incorrect & misleading on the grounds that the case of the appellant is badly time barred & is liable to be dismissed under the relevant provisions of law.
- 8 legal. However, the Respondents further submit on the following ground inter alia :-

ON GROUNDS .

- A That ground-A, is incorrect & denied. The impugned Notification dated 17/3/2016 is legal & is liable to be maintained in favour of the Respondents. Because the appellant has not submitted the required documents for promotion against the Subject Specialist Post to the Respondent Department.
- B Incorrect & denied. Detailed reply has been given in the foregoing Paras of the instant reply, Hence needs no further comments.



7. Contents of para-7 of the appeal are correct, the reply submitted to the para is incorrect and misleading. The instant appeal is filed well within time.

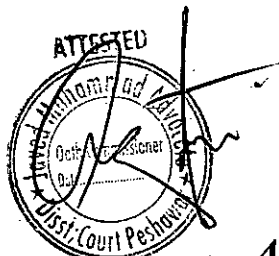
