





Prayer in Appeal:

On acceptance of the instant Appeal, the Appellant being Senior from the respondents No 4 to 8 and since his appointment his correct seniority list had been issued, but the fresh seniority list issued vide dated 13.12.2022, whereby the Appellant has been placed Junior from the respondents No 4 to 8 which is illegal and liable to be set aside, consequently the official respondents may kindly be directed to prepare Fresh Seniority List of the Foresters and place the appellant at appropriate position over and above

the private respondents according to the date of appointment and further the official respondents NO 1 to 3 be directed to place the case of the appellant for promotion to higher rank as per law and rules and fresh correct Seniority List be issued and placed the name of the appellant as senior from the respondents No 4 to 8.

Respectfully Sheweth:-

The Appellant humbly submits as under:-

1. That the Appellant is peaceful and law abiding citizen of Pakistan and is entitled for all the rights guaranteed by the Constitution of Islamic Republic of Pakistan, 1973.
2. That the appellant was appointed on dated 03.11.1994 and since then he is performing his duties with full zeal and zest and without giving any opportunity of being complained to his high ups. **(Copy of the appointment order is Annexure A)**
3. That the private respondents were also appointed on dated 20.06.1996 on temporary basis on similar terms and conditions on the same post. **(Copy of Appointment order of private respondent is attached as annexure B)**
4. That since the appointment of the appellant, he is performing his duty without any break in his service, the official respondents while issued Seniority List on year basis, whereby the appellant was continuously placed Senior from the private respondents. The date of appointment of the appellant is prior to the private respondents, hence they remained Junior from the appellant, which is crystal clear from the Seniority List issued by the official respondents on every year, **(Copies of the Seniority Lists of the year 2019-20-21 are attached as annexure C)**
5. That astonishingly when the tentative seniority list of foresters in respect of southern forest circle at Bannu issued by the official respondents on dated 20.11.2022, the name of appellant reflects at serial No 13 and the Junior from the appellant have been mentioned senior and placed their names above from the appellant, in this respect the appellant while submitted his objection over the issuance of tentative seniority list, which was replied by the respondents with amazing response. **(Copy of the**

tentative Seniority list and reply is attached as annexure D)

6. That surprisingly the official respondents while issued final seniority list of foresters vide dated 13.12.2022, according to which the name of the appellant has been mentioned at Serial No 15 and become more junior amongst the Foresters, inspite of the fact that the Appellant was appointed prior to all the private respondents, but malafidely and intentionally he has been placed Junior from the private respondents just to accommodate them for ulterior motives. **(Copy of the Final Seniority List dated 13.12.2022 is attached as annexure E)**
7. That the Appellant being the most senior incumbent amongst the Foresters and senior from the private respondents is eligible and entitled to be placed on top of the Seniority List under the Service Rules as the length of service mentioned above.
8. That thereafter the appellant preferred Departmental Appeal for rectification / correction of Final Seniority List issued by the Official Respondents, which has not yet been decided by the Official respondents after lapse of statutory period. **(Copy of Departmental Appeal is attached as annexure F)**
9. That feeling aggrieved from the act of Respondents, the Appellant having no other adequate and efficacious remedy, approaches this Honourable Tribunal on the following grounds inter-alia:-

GROUNDS:-

- A) That the Appellant is peaceful and law abiding citizen of Islamic Republic of Pakistan and is fully entitled to all the basic and fundamental rights as enshrined in the fundamental law of the state, interpreted and guaranteed by the law of the land.
- B) That it is evident from the bare perusal of the above mentioned facts that the appellant is appointed much before of the appointment of private respondents and in this respect since long the Seniority list of the Foresters have been issued on yearly basis, whereby the appellant name is reflect senior from the private respondents.

- C) That amazingly for first time when the official respondents have issued the tentative seniority list, the appellant surprisingly saw his name junior from the private respondents and preferred an objection over the said seniority list, which was properly replied by the official respondents, while mentioned illogical reasons, which is illegal, unlawful, without lawful authority and having no legal footings.
- D) That even then when the official respondents issued final seniority list the name of the appellant mentioned at Serial No 15 in the impugned seniority list behind his Juniors without mentioning any cogent reason for being issued such ridiculous Seniority List, which is liable to be set aside and to be declare null and void in the eyes of law.
- E) That the acts of the Respondents of not following the same criteria which has been safeguarded by the law and rules, while in the instant case the respondents have not yet considered the appeal of the Appellant, which is illegal, unlawful, unnatural, ab-initio, null and void in the eye of law, hence liable to be declared so.
- F) That it is worth to mentioned here that the impugned seniority list has been issued on malafide intention and with due diligence with the private respondents, as the higher scale positions are lying vacant with the respondents and they are intended to be consider the private respondents for promotion and to deprive the appellant from his lawful right of promotion.
- G) That it is pertinent to mention here that the Appellant was eligible and entitled for promotion but the respondents had illegally and unlawfully issued the incorrect seniority list, whereby Juniors most from the appellant are mentioned as Seniors just to accommodate them and to promote in the higher rank, which is illegal, unlawful, without lawful authority and is liable to be declared so.
- H) That the fundamental rights of the Appellant has blatantly violated by the Respondents and the Appellant has been discriminated and has been denied his due rights under the Constitution of Islamic Republic of Pakistan, 1973.
- I) That the Appellant is not treated in accordance with law, rules and Regulations.
- J) That the Appellant is appointed according to rules and on adopted procedure by the respondents and after his

appointment he has never ever given an opportunity of any complaint to the respondents and performed his duties with full devotions, the Appellant being eligible for Promotion being most Senior employee of the Respondents Department.

- K) That any other ground not raised here specifically may graciously be allowed to be raised at the time of arguments.

PRAYER:-

It is, therefore, most humbly prayed that, On acceptance of the instant Appeal, the Appellant being Senior from the respondents No 4 to 8 and since his appointment his correct seniority list had been issued, but the fresh seniority list issued vide dated 13.12.2022, whereby the Appellant has been placed Junior from the respondents No 4 to 8 which is illegal and liable to be set aside, consequently the official respondents may kindly be directed to prepare Fresh Seniority List of the Foresters and place the appellant at appropriate position over and above the private respondents according to the date of appointment and further the official respondents NO 1 to 3 be directed to place the case of the appellant for promotion to higher rank as per law and rules and fresh correct Seniority List be issued and placed the name of the appellant as senior from the respondents No 4 to 8.

Any other relief, not specifically asked for may also graciously be extended in favour of the Appellant in the circumstances of the case.
