



**KALIM ARSHAD KHAN CHAIRMAN:** Through this single judgment, all the above appeals, being similar in nature and almost with the same contentions, are going to be decided, therefore, all can conveniently be decided together.

2. The appellants' case in brief is that they were appointed as Auditors (BPS-14) in the Local Fund Audit through Khyber







Pakhtunkhwa Public Service Commission vide order dated 09.08.2018 against different quotas of minority, female and disabled; that private respondents, who were recommended by the Khyber Pakhtunkhwa Public Service Commission to the Government for the said post on 11.11.2020; that the private respondents, allegedly junior to the private respondents, were placed senior to the appellants in the final seniority list dated 22.04.2022; that feeling aggrieved, they filed objections against the seniority list dated 22.04.2022 but the same were rejected, hence, the instant service appeal.

3. On receipt of the appeals and their admission to full hearing, the respondents were summoned, who put appearance and contested the appeals by filing written replies raising therein numerous legal and factual objections. The defense setup was a total denial of the claim of the appellants.

4. We have heard learned counsel for the appellants, learned counsel for private respondents and learned Additional Advocate General for the respondents.

5. The learned counsel for the appellants reiterated the facts and grounds detailed in the memo and grounds of the appeals while the learned Additional Advocate General assisted by the learned counsel





6. The admitted fact of the cases are that vide advertisement No.03/2018 dated 09.02.2018, the Khyber Pakhtunkhwa Public Service Commission advertised posts of Auditors (BPS-14) as per the following breakup:

- (i). 49 posts were to be filled on merit vide serial No.48 of the advertisement.
- (ii). 9 posts were to be filled in Female Quota vide serial No.49.
- (iii). 4 posts were to be filled in Minority Quota.
- (iv). 01 (one) post had to be filled in Disable Quota vide serial No.51 of the advertisement.

7. The appellants applied against the seats reserved for Female, Minority, and Disabled quotas and sat through the ability test and qualified the same. They were then called for the interview and after their success in the interview, they were recommended by the Khyber Pakhtunkhwa Public Service Commission vide letter dated 09.08.2018 while the ability tests of private respondents were conducted separately

The appellants' claim is that they were senior to the private respondents because they were appointed earlier than the private respondents and further, that their ability tests as well as interviews were held separately, so they could not be said to be the selectees of the same selection process in order to consider the case of the private respondents under the provisions of Rule-17(a) of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989 and consideration of single merit list of the candidates of General Seats and other reserved quotas.

8. On the previous date, we had issued notice to the Khyber Pakhtunkhwa Public Service Commission to depute a well conversant officer to assist the Tribunal on the recommendations and inter-se merit order of the appellants and private respondents. Today, the representative namely Mehtab Gul, Law Officer put appearance and produced copy of letter No.PSC/SR/-VII/017928 dated 10.01.2022 addressed to the Secretary to Government of Khyber Pakhtunkhwa, Finance Department, whereby, the Secretary Finance was informed about the combined inter-se seniority of 63 selectees including the appellants and private respondents.

9. Rule 17(a) of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989 prescribes the method of determination of seniority of the seniority. The said Rule is reproduced as under:

**17. Seniority.---**(1) The seniority inter se of civil servants [appointed to a service, cadre or post] shall be determined.---


(a) in the case of persons appointed by initial recruitment, in accordance with the order of merit assigned by the Commission [or, as the case may be, the Departmental Selection Committee;] provided that persons selected for appointment to post in an earlier section shall rank senior to the persons selected in a later selection;

According to the above Rule, the inter-se seniority of civil servants is required to be determined, in case of persons appointed by initial recruitment, in accordance with the order of merit assigned by the Commission. The Commission vide letter dated 10.01.2022, has assigned the merit order and all the selectees/recommendees including the appellant as well as the private respondents and the impugned seniority list seem to be in accordance with the inter-se seniority assigned by the Commission. The department had issued tentative seniority list as stood on 31.12.2021, on which, the appellants had filed joint objections. Final seniority list was issued on 22.04.202 as it stood


on 31.12.2021 and position of the appellants and private respondents in the final seniority list notified on 22.04.2022 was in line with the inter-se seniority assigned by the Khyber Pakhtunkhwa Public Service Commission. Therefore, the department has acted in accordance with the provisions of Rule-17(a) of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989, pertaining to determination of seniority in accordance with merit order assigned by the Commission. As regards the contention of the appellants that they were selected separately because their ability tests and interviews were separately conducted, is a matter pertaining to the selection and not that of terms & conditions of service, therefore, cannot be agitated before the Tribunal. What the Tribunal is concerned, is the determination of seniority in accordance with provisions of Rule-17(a) of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989 and that appears to us to have correctly been determined in accordance with merit order/inter-se seniority assigned by the Commission vide letter dated 10.01.2022 and in accordance with the provisions of Rule-17(a) of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989.




