might be shifted to the cost centre under which the appellant might be adjusted for the purpose of drawl of pay via transfer entry to eradicate the negative balances in the reconciliation statement. It was then the Deputy Commissioner Mohmand, vide letter dated 06.06.2023, adjusted the appellant against the vacant post of Senior Clerk (BPS-14) in the office of Deputy Commissioner Mohmand under para-113 of GFR Vol-I for the purpose of pay. After adjustment of the appellant in the office of Deputy Commissioner and the other records of the appellant, all showing that he was employee of the office of Deputy Commissioner Mohmand and only confusion arose for drawl of salary from a wrong DDO Account, which also was rectified as per the above record. Now coming to the only grievance of the appellant, we observe that as the appellant has been adjusted by the Deputy Commissioner Mohmand as Senior Clerk in his own establishment, therefore, his name ought to have been included in the seniority list in accordance with rules and law. Order accordingly. Consign.

Service Appeal No. 417/2022 titled "Naseer Ahmad versus Government of Khyber Pakhtunkhwa through Secretary Food Department at Civil Secretariat Peshawar and others".

ORDER

22nd April, 2024 Kalim Arshad Khan, Chairman: Appellant alongwith his counsel present. Mr. Muhammad Jan, District Attorney for the respondents present.

- 2. The only grievance of the appellant is that his name was not included in the seniority list of the employees of Deputy Commissioner Office by the Deputy Commissioner Mohmand.
- The facts of the case are that the appellant was initially 3. appointed as Khassadar Moharrir on 18.11.1996 by the then Political Agent Mohmand. He was promoted vide order dated 27.11.2007 to the post of Junior Clerk by the same authority i.e Political Agent Mohmand. Again on 31.10.2018, the appellant was promoted as Senior Clerk by the Deputy Commissioner Mohmand. Vide letter dated 02.01.2023, the District Accounts Officer Mohmand pointed out that the salary of the appellant was drawn against DDO Account Head MG4004 which was an invalid Cost Centre causing impact to the budget and negative budgets occurring in the reconciliation statement. The District Accounts Officer had stopped the salary of the appellant and sent the matter to the Deputy Commissioner Mohmand for investigation at his level and factual position was to be intimated to the District Accounts Officer. Again a letter was written on 04.10.2023 by the District Accounts Officer Mohmand to the Finance Officer/Inquiry Officer Mohmand, wherein a request was made that salaries drawn under DDO account MG4004
