

APPEAL U/S 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT 1974.

Respectfully Sheweth:

- 1. That the appellant was appointed as Theology Teacher (TT) on 12-12-2005 and is working in the respondent's department since then.
- 2. That on 6/6/2012 the appellant was passed to attend the departments officials at government Centennial Model High School, Peshawar City for providing appointment letter documents and service book etc. Thus the appellant appeared before the officials of the departments and his above documents were checked and a seniority List of Theology Teachers (TTs) was prepared and the appellant was at S. No. 143 of that list.
- 3. That the again another seniority list was drafted and the petitioner was S. No. 148 in that seniority list. (Copy attached as Annexure "A").
- 4. That for making promotion of various Theology Teacher (TT) first meeting of the departmental

promotion committee was held on 21-2-2013 at, directorate of Elementary and Secondary Education Dabgari Garden Peshawar.

- 5. That on the basis of recommendation of the departmental promotion committee impugned Notification dated 21-2-2013 regarding promotions of 34 eligible Theology Teachers was issued, despite the fact, that total no of available / vacant posts were 55 and the appellant was not considered for promotion for the reasons best known to the respondents. (Copy as annexure "B").
- 6. That later on acceptance of appeal, the above mentioned notification was revised and three other Theology Teacher namely Abdul Baseer at Serial No. 18 of the Seniority List, Muhammad Yahya at Serial No. 114 of the Seniority List, Aurangzeb at Serial No. 134 of the Seniority List, were promoted to the post of Senior Theology Teachers (STTs) (BPS-16). (Copy as annexure "C").
- 7. That the appellant also filed departmental appeal / representation before the respondent No. 1 against that treatment meted out to him but to no avail. (Copy as annexure "D").

- 8. That on 24-5-2013 when the appellant contacted respondent No. 3 office the appellant was informed that on 27-5-2013, in the scheduled DPC meeting, the committee will consider those Theology Teachers who were deferred on their previous turn and the appellant was told that if those differed TT's do not come then the appellant would be considered. For this purpose a written statement from those deferred TTs were also taken. (Copy of the written statement are attached Annexure "E"),
- 9. That on 27-5-2013 the appellant again approached contacted the office of respondent No. 3 where he was told that as the departmental promotion committee has not accepted that statement of those deferred, candidate therefore, affidavit of those candidate were asked to be provided which was provided to respondent No. 3 accordingly. (Copy of affidavits are attached as Annexure "F").
- That besides the facts that Departmental Appeal/
 representation of appellant was pending/ under
 process before the respondents, another
 notification dated 28/05/2013 was issued vide the
 which some of the employees/ TTs were promoted
 to the post of STTs. (Copy as annexure "G"). but in
 this notification again the name of the appellant
 was\included.

11. That now as the departmental / representation has matured and the statutory period of 90 days has elapsed, without any response from the respondent, the appellant is filing the instant service appeal before this Hon'ble Tribunal on the following grounds inter alia:-

GROUNDS:-

- A. That the impugned notifications are illegal, unjust against the rules and regulation pertaining to the matter.
- B. That the appellant is fully qualified to be promoted to the post of STT.
- C. That the junior colleagues of the appellant has been placed Senior to the appellant as admittedly respondents No. 5 and 6 took charge on 01/01/2009 and 01/10/2007 respectively, but even then they have been placed as S. No. 59 and 81 of the Seniority List, merits to be rectified accordingly.
- D. That the seniority list on the basis of which departmental promotion committee recommended various seniority teacher also contains the name of

those Teology Teacher (TT) who have been transferred to Charsadda in January 2012 an example of which is at Serial No. 62.

- E. That on one hand candidate at serial No. 6 of the seniority list took charge on 11-4-2007 in this district (Peshawar) and on the other hand he died in June, 2012 but still his name is appearing in the Seniority List for the year 2012 as stood on 21-2-2013 which alone is sufficient reason for declaring the sonority list is unjust.
- F. That the candidate at Serial No. 44 namely Syed Bahramand date of appointment is 5/10/2005 but his date of appointment has been shown as 01/01/1992 in the Seniority List and has wrongly been placed at Serial No. 44.
- G. That the action and inaction/ conduct of the respondents regarding denial for consideration of appellant for promotion of STT is unjustified, void and illegal.
- H. That the respondent are not justified to deprive the appellant from his right of promotion.
- I. That the act/ treatment meted out to the appellant is harsh and bad in law and on facts.

It is, therefore, most humbly prayed that on acceptance of the instant appeal, the respondents be ordered be rectify the sonority lists of TTs and the respondents be also directed to consider/promote the appellant for promotion to the post of STT as his other colleagues were considered the promoted from the date when their notification for promotion was issued.

Any other relief which this Hon'ble Tribunal deem proper in the circumstances, may graciously be granted to the appellant.
