Rules 2011 and therefore major penalty in the shape of compulsory retirement with immediate effect was imposed against the appellant.

- 4. Learned counsel for the appellant has argued that the enquiry was not conducted in the mode and manners prescribed by rules. That no opportunity of hearing was afforded to the appellant. That the appellant was availing leave of 730 days including earned leave of 120 days on full pay and 620 days on half pay w.e.f. 01.07.2013. That the charges attributed to the appellant were not substantiated through a departmental enquiry and as such the impugned order is against facts and law and liable to be set aside.
- 5. Learned Government Pleader has argued that the appellant was a habitual absentee and involved in undesirable activities. That the competent authority has dispensed with formal enquiry and that the impugned order is in accordance with law and warrants no interference.
- 6. We have heard arguments of learned counsel for the parties and perused the record.
- 7. It is evident from the record that the appellant was available to the competent authority for enquiry. He was not associated with the enquiry proceedings. The nature of charges would suggest that a regular enquiry was essential for ascertaining the real facts and affording opportunity of hearing including defence of the appellant but the competent authority dispensed with the same. The order of the competent authority is not found in consonance with the settled procedures for taking such enquiry.
- 8. In view of the above we are constrained to accept the present

appeal set aside the impugned order dated 22.12.2014 and reinstate the appellant in service for the purpose of enquiry and direct that denovo enquiry be conducted against the appellant in the prescribed manners wherein opportunity of hearing including defence be afforded to the appellant in the mode and manners prescribed by rules. The enquiry shall be conducted and concluded within a period of 2 months from the date of receipt of this judgment. Parties are left to bear their own costs. File be consigned to the record room.

With reference to the Senior Superintendent of Police Swat Letter 2999/GB dated 03-07-2014, wherein it has alledged that Mr. Shah Wazir Khan was indebted to Muhammad Rafiq for huge amout and issued a cheque Rs. 800,000/= in the name of Mr. Muhammad Rafiq which was when presented to the United Bank Saidu Sharif Branch was not entertained/cashed due to non availability of sufficient balance in the account of accused official Mr. Shah Wazir Khan. The official concerned was on long leave and when case was registered by the Police he absconded and police authorities requested the undersigned for help in his arrest. Subsequently leave was cancelled and he was given a notice to this effect and he was directed to join duty but notice returned back without delivery due to his non availability.

This amounts to fraud and misconduct and wilful absence under section 3 of the Khyber Pakhtunkhwa, Govt: Servants E&D Rules 2011. The accused official is in the habit of taking loan from different sources and is always indebted. His previous record shows that he was removed from service because of wilful absence.

The illegation and offense are very much evident and I as competent authority do not consider to hold formal enquiry under Rule 10(1)-a of Khyber Pakhtunkhwa, Govt: Servants E&D Rules 2011. 





STATEMENT OF ALLIGATIONS:

With reference to the Senior Superintendent of Police Swat Letter 2999/GB dated 03-07-2014, wherein it has alledged that Mr. Shah Wazir Khan was indebted to Muhammad Rafiq for huge amout and issued a cheque Rs. 800,000/= in the name of Mr. Muhammad Rafiq which was when presented to the United Bank Saidu Sharif Branch was not entertained/cashed due to non availability of sufficient balance in the account of accused official Mr. Shah Wazir Khan. The official concerned was on long leave and when case was registered by the Police he absconded and police authorities requested the undersigned for help in his arrest. Subsequently leave was cancelled and he was given a notice to this effect and he was directed to join duty but notice returned back without delivery due to his non availability.

This amounts to fraud and misconduct and wilful absence under section 3 of the Khyber Pakhtunkhwa, Govt: Servants E&D Rules 2011. The accused official is in the habit of taking loan from different sources and is always indebted. His previous record shows that he was removed from service because of wilful absence.

The illegation and offense are very much evident and I as competent authority do not consider to hold formal enquiry under Rule 10(1)-a of Khyber Pakhtunkhwa, Govt: Servants E&D Rules 2011. Issue Show Cause under Rules to dispense with the enquiry as I am satisfied that the accused official has committeed the offense of gross misconduct under the rules ibid.






