Subject: MINUTES OF THE MEETING REGARDING PROMOTION OF SAIMA KHALIQ FROM PAY SCALE 19 TO 20 OF THE DISPUTED SENIORITY LIST HELD ON 21-07-2016

A meeting was held on 21-07-2016 in the office of the Special Secretary, Higher Education Department to review the promotion case of Ms. Saima Khaliq to BPS-20 as a follow up of the meeting held on 19-04-2016 and 23.06.2016 regarding disputed seniority of the Associate Professor (BPS-19) between the promotees and Public Service Commission recommendees.

Special Secretary, Higher Education Department presided over the meeting. The following attended.

Opening the discussion chair informed the participants that in the earlier meeting held on 19.04.2016 and 23.06.2016 it was observed that one Public Service Commission recommendee Mrs. Saima Khaliq had been promoted to BPS-20 amongst the batch of 20 officers. Although the seniority was disputed and that no promotion was to be processed unless the seniority was to take finality. It was earlier decided that the Public Service Commission recommendees were declared as junior to the promotees as per rules & regulations and among recommendees one Associate Professor (BPS-19) namely Ms. Saima Khaliq was promoted to the

Post of Professor (BPS-20) which became a question mark.

After perusal of record it was clear that Provincial Selection Board meeting was held on 13.03.2013. The seniority list was not challenged and the concerned lady qualified all the requirements of promotion hence she was promoted.

It was decided that the matter may be taken up with Establishment Department as other batch mates were now decided to be junior than the promotees.





A non agenda item regarding the appeal lodged by the female Associate Professors directly selected through Public Service Commission against the tentative seniority list issued by Directorate of Higher Education on 15.05.2016 was also discussed in the meeting. They taking the plea that in the tentative seniority list, the officers placed from S. No. 37 to S. No. 42 have been shown senior than the selectees as they have no right of seniority from the date of appointment on acting charge basis i.e 26.05.2010 and requested that they may be considered in effect from the date of their regular promotion i.e 25.11.2011 instead of 26.05.2010.

The issue was discussed threadbare and it was decided that the officers promoted on acting basis i.e from No. 37 to S. No. 42 in the tentative seniority list issued on 20.05.2016 by Directorate of Higher Education may be considered as junior than the officers directly appointed through Public Service Commission according to the rules and the Director, Higher Education is directed to revise the tentative seniority list issued on 20.05.2016 and re-circulate among all government colleges of female for the period of one month.

The meeting ended with mutual vote of thanks.

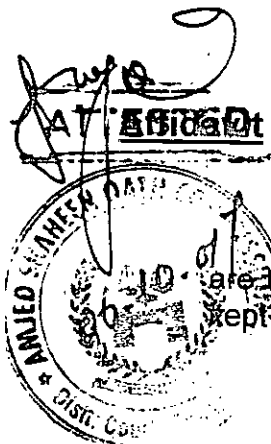

Dear Sir,

I am directed to refer to your office letter No. SO(C-I)HE/2-1/05/Shahen Begum/2281 dated 13.04.2017 on the subject cited above alongwith para wise reply to the observations contained Establishment Department dated are as under:

- Note for Chief Secretary submitted by Higher Education Department regarding seniority dispute between promotees and direct recruitees among Associate Professors(BPS-19) Female has been examined in light of the Services Tribunal judgment dated 13.08.2015. A committee constituted in line with the guideline of the Service Tribunal Judgment has drawn seniority and decided to circulate the same before getting approval of the final seniority. It is observed that though the Department has forwarded the seniority list in reference to the recommendation of the committee but the Note is silent as to whether the same has been circulated amongst the officers or not. Moreover, the note is also silent to the effect that the seniority is final, undisputed and no more subjudice in any court of law.

It is submitted that the Tentative Seniority List of Associate Professors (B-19) female were tentatively circulated among all the Principal/JMCs/coordinator colleges in Khyber Pakhtunkhwa through this office letter No. 14619-366 dated 20.05.2016 (Copy attached as Annexure-A), on the basis of issuance of tentative seniority some appeals received against the tentative seniority list of female during stipulated period which were sent your office vide this office letter No. 19451 dated 20.07.2016 with the request that these appeal may considered. A second meeting was scheduled on 21.07.2016 for settlement of these appeal. The committee considered the appeals, but as the minutes were received late, so the same was not circulated for the second time and this office was directed through letter No. SO(C-I)HE/2-1/05/Shahen Begum/2016/908 dated 06.12.2016 to submit the final seniority of Associate Professors (B-19) female. Thus this office has done the same and submit the Final Seniority list vide this office letter No. 35185 dated 22.12.2016.

As far as second part of query is concerned this seniority is finalized by the committee constituted on the direction of court, therefore, expert opinion of the litigation section may be sought as to whether the case is subjudice or otherwise.
