He is aggrieved with his transfer order dated 31.07.2013 vide which he was transferred from GPS Ladwan to GPS Nawagai No.4 and one Bakhat Zaman who was promoted was posted in the same school. He filed departmental appeal and as stated by the learned counsel for the appellant the same, has not yet been decided, hence this appeal under Secion-4 of the Khyber Pakhtunkhwa Service Tribunal Act 1974.</p> <p>3. Arguments hared and record perused.</p> <p>4. During the course of arguments its transpired that on his promotion Bakhat Zaman has also been further transferred from the said school GPS Ladwan to GPS Janak Banda vide order dated 30.10.2014. In this fresh scenario it further revealed that presently the appellant alone is working at GPS Ladwan on the strength of stay order by this Tribunal. The above factual situation in view this can not be denied that the appellant is disable, is having special rights of treatment per Government policy and the law. His departmental appeal has not yet been decided. Therefore, the case is remitted back to the department with the direction to decide the same within one month failing which the appeal be deemed to have been allowed. 





Respectfully Sheweth:

1. That initially the appellant joined the respondent/department since long and as such performing his duties with zeal and zest and till date no compliant what so ever has been recorded from any quarter :
2. That the provincial Govt introduced a policy through which various post of Teachers/Teaching cadre were up-graded and accordingly they were posted to various schools of district Bunir but the appellant due to his physical dis-ability moved an application to DDO Bunir to the extent that the appellant may kindly be posted/allow to continue his services at local station i-e GPS Ladwan where he ~~was~~ ^{had} performing ^{his} duties prior ^{to} the introduction of the said policy and as such sympathetic observations in favour of the appellant were recorded on the said application(Copy application is annexure-A)

3. That contrary to said observations and without considering physical disability of the appellant, the appellant was transferred to GPS Wahid Abad vide office order dated:21.02.2013(Copy of the order dated:21.02.2013 is annexure-B)
4. That against the said Transfer order, the appellant again made request to the concerned authority for sympathetic considerations and as such vide office order dated:26.03.2013 a corrigendum was issued through which partial modifications were made in the office order dated:21.02.2013 and as such the appellant transfer order was cancelled and the appellant ^{remained} continue his services at GPS Ladwan.(Copy of Office order dated:26.03.2013 is annexure-C)
5. That surprisingly after some time, again ~~the~~ without ~~earlier~~ caring for the earlier corrigendum and commitment which was made by the respondents No.1 with appellant, the appellant was Transferred to GPS Wahid Abad from GPS Ladwan vide impugned office order dated:31.07.2013.(Copy of impugned office order dated:31.07.2013 is annexure-D)

6. That against the said order the appellant filed departmental appeal before the competent authority which was not decided within the statutory period. So being aggrieved the appellant filed the instant appeal before this Hon;ble Tribunal on the following grounds amongst others inter alia:.(Copy of appeal is annexure-E)

GROUND:

- A. That the impugned Transfer order dated:31/07/2013 is against facts, law and procedure, hence, untenable being unjust and unfair.
- B. That the appellant was not treated in accordance with law and rules, thus acted in violation of the relevant laws laid down for the purpose.
- C. That subsequent transfer orders clearly showing the ill intention of the respondents and such like illegal actions and inactions are classical examples of political victimization because the appellant was penalized and transferred contrary to the commitments made by the department with appellant.

- D. That the appellant is physically disable and his right leg was amputated by the doctors so due to the nature of disability the appellant is unable to perform his duties away from his home. So on the ground of natural justice the appellant be allow to perform his duties at his home station i-e GPS Ladwan.(Copy of Medical Certificate is annexure-F)
- E. That any other ground may be adduced during the course of argument, with the kind permission of this Hon'ble Court.

It is, therefore, most humbly prayed that *on acceptance of this appeal the impugned Office Order dated:31/07.2013 may kindly be set aside and the appellant may kindly be allow to continue/perform his services against the post of PHST at GPS Ladwan District Bunir.*

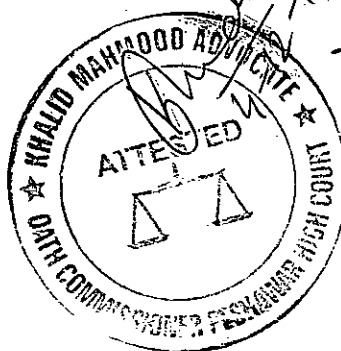


