

17) AND THE APPELLANT WAS DEFERRED/IGNORED/
NOT CONSIDERED AND AGAINST NOT TAKING
ACTION ON THE REVIEW PETITION OF THE
APPELLANT WITHIN THE STATUTORY PERIOD OF
NINETY DAYS.

PRAYER:

THAT ON THE ACCEPTANCE OF THIS APPEAL, THE
IMPUGNED NOTIFICATION 27.11.2023 MAY KINDLY BE
SET ASIDE TO THE EXTENT OF PRIVATE
RESPONDENT NO.2 AND THE RESPONDENT NO.1 MAY
KINDLY FURTHER BE DIRECTED TO CONSIDER THE
APPELLANT FOR PROMOTION TO THE RANK OF
DEPUTY SUPERINTENDENT OF POLICE (BS-17) WITH
EFFECT FROM 27.11.2023 WITH ALL BACK AND
CONSEQUENTIAL BENEFITS. ANY OTHER REMEDY,

WHICH THIS AUGUST TRIBUNAL DEEMS FIT AND APPROPRIATE THAT, MAY ALSO, BE AWARDED IN FAVOUR OF APPELLANT.

**RESPECTFULLY SHEWTH:
FACTS:**

1. That the appellant was appointed as ASI in the respondent department in the year 2006 and with the passage of time due to his excellent performance and after completing all his due and mandatory training and courses he was promoted to the rank of Inspector and was posted in CTD vide order dated 12.11.2014. **(Copy of order dated 12.11.2014 is attached as Annexure-A)**
2. That the appellant while serving as Inspector was dismissed from service on 09.11.2017 on the basis of baseless criminal case vide FIR No.492 u/s 419/420/471/171 PPC/15AA dated 29.07.2017 without conducting regular and proper inquiry. The appellant challenged the said order in this Honorable Tribunal in service appeal No.267/2018. The Honorable Tribunal decided the appeal of the appellant on 03.05.2019, reinstated the appellant into service with the direction of denovo inquiry. **(Copies of order dated 09.11.2017 and judgment dated 03.05.2019 are attached as Annexure-B&C)**
3. That after conducting denovo inquiry the appellant was again removed from service vide order dated 23.08.2019 and his departmental appeal was also rejected on 07.10.2019. The appellant again challenged the order dated 23.08.2019 and rejection order 07.10.2019 in this Honorable Tribunal in service appeal 1524/2019. The appeal was heard and decided by this Honorable Tribunal on 05.01.2022. The Honorable allowed the appeal of the appeal of the appellant, set aside the impugned orders dated 23.08.2019 and 07.10.2019 and the appellant was reinstated into service with all back benefits. **(Copies of orders dated 23.08.2019, order dated 07.10.2019 and judgment dated 05.01.2022 are attached as Annexure-D,E&F)**
4. That in compliance of judgment dated 05.01.2022, the appellant was reinstated into service with all back benefits vide order dated 04.02.2022. **(Copy of order dated 04.02.2022 is attached as Annexure-G)**
5. That the respondent department issued the final seniority list of Inspector (BPS-16) on 06.12.2022, wherein the name of the appellant was present at Sr. No.71 in that seniority list. **(Copy of seniority list is attached as Annexure-H)**

6. That Departmental Selection Committee meeting was held on 27.11.2023 for promotion to the rank of Deputy Superintendent of Police (BS-17) and colleagues and junior were recommended in that Departmental Selection Committee for promotion to the rank of Deputy Superintendent of Police (BS-17), but the appellant was differed/ ignored/ not considered in that Departmental Selection Committee and on the basis of that Departmental Selection Committee recommendation 85 Inspector (BPS-16) (Executive, FSL and Telecommunication) of Khyber Pakhtunkhwa Police were promoted to the rank of Deputy Superintendent of Police (BS-17) vide notification dated 27.11.2023. **(Copy of notification dated 27.11.2023 is attached as Annexure-I)**
7. That the appellant filed review on 07.12.2023 for promotion with effect from 27.11.2023 along with his colleagues and juniors, which was not responded within the statutory period of ninety days. **(Copy of review petition is attached as Annexure-J)**
8. That the appellant has no other remedy except to file the instant appeal in this Honorable Tribunal for redressal of his grievance on the following grounds amongst others.

GROUND:


- A) That not taking action on the review of the appellant and not promoting him to the rank of Deputy Superintendent of Police (BS-17) in notification dated 27.11.2023 along with his colleagues and juniors are against the law, rules, promotion policy, norms of justice and material on record, therefore not tenable and the notification dated 27.11.2023 is liable to be set aside to the extent of private respondent No.2 and the appellant is entitle to be considered for promotion to the rank of DSP (BPS-17) with effect from 27.11.2023 i.e the date when his colleagues and juniors were promoted to the rank of DSP (BPS-17).
- B) That the appellant was at Sr. No. 71 of the seniority list of Inspector (BPS-16), while 69 Inspectors who were promoted to the rank of DSP (BS-17) in notification dated 27.11.2023 were juniors to the appellant in that seniority list, which means that the appellant was senior to them but despite that the appellant was not promoted to the rank of DSP (BS-17) along with colleagues and juniors in the notification dated 27.11.2023, which is violation of law, rules and promotion policy.
- C) That the appellant was at Sr. No. 71 of the seniority list of Inspector (BPS-16) and 85 Inspectors (BPS-16) were recommended by DSC

for promotion to the rank of DSP (BS-17) and on the basis of that Departmental Selection Committee recommendation 85 Inspector (BPS-16) (Executive, FSL and Telecommunication) of Khyber Pakhtunkhwa Police were promoted to the rank of Deputy Superintendent of Police (BS-17) vide notification dated 27.11.2023, but the appellant was differed/ ignored/ not considered in that Departmental Selection Committee without giving any reason which is against the norms of justice and fair play.

- D) That the appellant was dismissed from service on baseless criminal case in which he was acquitted by the competent court of law and the appellant was also reinstated into service with all back benefits and as per superior court judgment that once an official was reinstated in service after exoneration of charges leveled against him, the period during which he remained either suspended or dismissed/removed could not be attributed as fault on his part. Absence of official during period of dismissal/removal was not voluntary on his part but it was due to the order of the authority which restrained from attending his job/duty. Therefore, his service record could neither be adversely affected nor could he be denied any benefits including promotion to which he would have been entitled had he not been removed/dismissed and as such the appellant is entitle to be promoted to the rank of DSP (BS-17) w.e.f 27.11.2023 along his colleagues and juniors on the basis of Apex Court judgment.
- E) That the appellant has good service record and is also eligible for promotion to the rank of DSP (BS-17), but he was not promoted to the rank of DSP (BS-17) along with his colleagues and juniors and as such the appellant is entitle to be promoted to the rank of DSP (BS-17) on 27.11.2023 i.e when his colleagues and juniors were promoted to the rank of DSP (BS-17).
- F) That not promoting the appellant to the rank of DSP (BS-17) on 27.11.2023 will affect his further promotion which will cause irreparable loss to the appellant in the shape of pension and other monetary benefits for no fault on his part.
- G) That the appellant seeks permission of this Honorable Tribunal to advance others grounds and proofs at the time of hearing.

It is, therefore most humbly prayed that on the acceptance of this appeal, the impugned notification 27.11.2023 may kindly be set aside to the extent of Private Respondent No.2 and the Respondent No.1 may kindly further be directed to consider the appellant for promotion to the rank of deputy superintendent of police (bs-17) with effect from 27.11.2023 with all back and consequential benefits. Any other remedy, which this august

tribunal deems fit and appropriate that, may also, be awarded in favour of appellant.

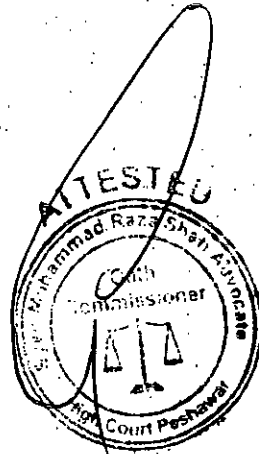

This order is passed today on 08-11-2017 to dispose of departmental proceedings initiated against Inspector Niaz Hussain (under suspension) while posted as SHO PS CTD Mardan Region.

Inspector Niaz Hussain presently under suspension and closed to CTD HQrs Peshawar was charge sheeted under the Khyber Pakhtunkhwa Police Rules 1975 (amended 2014) on the score of the following allegations:-

- i) That you are reportedly involved in the transportation and smuggling of Non Custom Paid (NCP) Vehicles vide FIR No. 492 u/s 419/420/468/471/171PPC/15AA, dated 29-07-2017 PS Lund Khwar District Mardan.
- ii) That on your direction your gunman namely Ashfaq Ali No. 182 received the NCP Vehicle from one Haji Hayat Khan r/o Bara Khyber Agency for transportation to Sakhakot.
- iii) That your performance as SHO CTD Mardan remained poor.


For conducting probe into the allegations leveled against Inspector Niaz Hussain an enquiry committee consisting of Mr. Fazl-e-Hamid SSP/Int & Sur CTD and Mr. Qasid Kamal DSP HQrs: CTD Khyber Pakhtunkhwa was constituted. The enquiry committee found the officer guilty as Inspector Niaz Hussain has close ties with criminal namely Munawar @ Adnan Ali through whom he used to smuggle NCP Vehicles, the enquiry committee recommended him for major punishment as dismissal from service.

Inspector Niaz Hussain was called and heard in person. His verbal and written reply to Final Show Cause Notice were perused. Enquiry papers were also perused in detail.

The enquiry committee have found the officer guilty of the charges of involvement in transportation and smuggling of Non Custom Paid Vehicle, thereby bringing a bad name to the reputation of the department. He is guilty of gross misconduct.

In the light of findings/recommendations of the Enquiry Committee and available record against Inspector Niaz Hussain the then SHO PS CTD Mardan, I, Mubarak Zeb, Deputy Inspector General of Police, CTD, Khyber Pakhtunkhwa being competent authority, hereby imposes the major punishment "Dismissal from service" with immediate effect.

(ii) That on his direction his gunman namely Ishfaq Ali No. 182 received the NCP vehicle from one Haji Hayat Khan r/o Bara Khyber Agency for transportation to Sakhakot.

(iii) That his performance as SHO CTD Mardan remained poor.

The appellant filed departmental appeal before the Inspector General of Khyber Pakhtunkhwa Peshawar on 15.11.2017 which was not responded within the stipulated period hence, the present service appeal on 26.02.2018.

3. Respondents were summoned who contested the appeal by filing of written reply/comments.

4. Learned counsel for the appellant contended that the appellant was serving as Inspector in Police Department. It was further contended that the appellant was imposed major penalty of dismissal from service vide order dated 09.11.2017 by the Deputy Inspector General of Police on the aforesaid allegations. It was further contended that the departmental proceeding against the appellant was initiated mainly on the grounds that he was involved in the aforesaid criminal case but the appellant was totally innocent in the said criminal case that is why that the prosecution submitted application for discharge of the appellant in the said criminal case before the competent court which was accepted and the appellant Naiz Hussain was discharged from the aforesaid criminal case vide detailed order dated 12.10.2017 passed by the Judicial Magistrate Takht Bahi. It was further contended that the appellant was serving in Police Department since 2003 but there was not complaint against the appellant nor any criminal proceeding or any departmental proceeding was

initiated till the present departmental proceeding. It was further contended that as per schedule first Police Rules, 1975 the competent authority of Inspector was DPO/SSP but in the present departmental proceeding, charge sheet, statement of allegation and show-cause notice was issued to the appellant by the Deputy Inspector General of Police and the impugned order was also passed by the Deputy Inspector General of Police instead of DPO/SSP therefore, the impugned order is illegal and void. It was further contended that the allegations against the appellant are baseless and without any proof. It was further contended that neither proper inquiry was conducted nor the appellant was associated in the so-called inquiry nor opportunity of cross examination, personal hearing and defence was provided to the appellant therefore, the appellant was condemned unheard which has rendered the whole proceeding illegal and liable to be set-aside and prayed for acceptance of appeal.

On the other hand, learned Assistant Advocate General for the respondents opposed the contention of learned counsel for the appellant and contended that the appellant was serving in Police Department as Inspector. It was further contended that the criminal proceeding has no bearing/effect on the departmental proceeding therefore, the discharge of the appellant from criminal case does not help the appellant in departmental proceeding. Police and as per schedule first of Police Rules, 1975 the competent authority of the inspector/appellant was DPO/SSP but the order of higher authority should always be maintained and the impugned order cannot be set-aside only on this ground and prayed for dismissal of appeal.

6. Perusal of the record reveals that the appellant was serving in Police Department as Inspector. The record further reveals that departmental proceeding was initiated against the appellant on the aforesaid allegation. The record further reveals that inquiry was conducted by the inquiry committee and the inquiry committee have recorded the statement of witnesses namely Zakir Khan S.I Incharge Chowki Umer Abad, Mazhar Ali ASI I.O case FIR No. 492 under sections 419/420/468/471/171PPC/15AA dated 29.07.2017 PS Lund Khwar District Mardan and Khan Muhammad ASI Muharrar PS CTD Mardan. Copy of the statement of the aforesaid witnesses were also furnished by the representative of the department at the time of arguments which shows that the statements of said witnesses were recorded by the inquiry committee during the inquiry proceeding on 09.08.2017 and 16.08.2017 but the appellant was neither provided opportunity of cross examination nor the statement of witnesses were recorded by the inquiry committee in the presence of the appellant therefore, the appellant was condemned unheard, as opportunity of cross examination to the appellant on the aforesaid witnesses was the fundamental right of the appellant therefore, the inquiry committee has violated the principle of natural justice and the appellant has been deprived from his defence through cross-examination which has rendered the whole proceeding illegal and liable to be set-aside. AS such, we partially accept the appeal, set-aside the impugned order, reinstate the appellant into service with the direction to the respondent-department to conduct de-novo inquiry in the mode and manner prescribed by rules.







In compliance with the Judgment of Honorable Service Tribunal announced in service appeal No 267/2018 and also conveyed by CPO, Peshawar vide his office Endst: No 2906/Legal dated 23.05.2019 so far relates to Ex- Inspector Niaz Hussain of this Unit who has been dismissed from his services on the following allegations vide this office order Endst: No 13146-53/PA dated 09.11.2017:-

- i. That he was reportedly involved in the transportation and smuggling of Non Custom Paid (NCP) Vehicles vide FIR No 492 u/s 419/420/468/471/171 PPC /15AA dated 29.07.2017 PS Lund Khwar District Mardan.
- ii. That on his direction his gunman namely Ashfaq Ali NO 182 received that NCP Vehicle from One Haji Khan r/o Bara Khyber Agency for transportation to Sakhakot.
- iii. That his performance as SHO CTD Mardan remained poor.

In consequence he was proceeded departmentally by issuing him Charge Sheet alongwith summary of allegation vide this office 8709-13/PA dated 01.08.2017 Dismissal from Services". Later On, he also submitted an appeal before Worthy Inspector General of Police, Khyber Pakhtunkhwa but the appeal was rejected vide this office order Endst: No S/1066-74/18 dated 22.03.2018.

Feeling aggrieved, the defaulter officer filed service appeal No 267/2018 in Service Tribunal Khyber Pakhtunkhwa. On 03.05.2019 Service Tribunal partial accepted the appeal and announced Judgment wherein it was directed that "the concerned DPO/SSP to issue charge sheet, statement of allegations as well as final show cause notice and pass order deem appropriate in the denovo enquiry?"

In consequence upon the judgment of Honorable Service Tribunal, the undersigned perused his previous service record and agreed with the recommendation of the enquiry officer stating therein that "Major Punishment" may be awarded to the said Inspector for keeping such like criminal mind/bad character Cosnible as "gunman" which shows his negligence and lack of supervision on his part.

Now, I SENIOR SUPERINTENDENT OF POLICE, CENTRAL ZONE CTD, PESHAWAR being a competent authority in exercise of the powers vested in me vide Police Rules, 1975 (amendment 2014) is hereby ordered to award him Major Punishment of Removal from Service.



JUDGMENT

ATIQ-UR-REHMAN WAZIR MEMBER (E):-

Brief facts of the case are that the appellant while serving as SHO of a police station, was charged in FIR Dated 29-07-2017 U/Ss 419/420/468/471/171PPC/15AA. The appellant was departmentally proceeded against on the same charges and was ultimately dismissed from service vide order dated 09-11-2017. The appellant filed departmental appeal followed by service appeal No 267/2018. This tribunal vide its judgment dated 03-05-2019 re-instated the appellant with direction to the respondents to conduct de-novo inquiry. Because of de-novo proceedings, the appellant was again removed from service vide impugned order dated 23-08-2019. The appellant filed departmental appeal against the impugned order, which was also rejected vide order dated 07-10-2019, but in the meanwhile the

appellant was acquitted of the charges by a competent court of law vide order dated 12-10-2017 hence the instant service appeal with prayers that the impugned orders dated 23-08-2019 and 07-10-2019 may be set aside and the appellant may be re-instated in service with all back benefits.

02. Learned counsel for the appellant has contended that the impugned orders are against law, fact and norms of natural justice, hence not tenable and liable to be set aside; that the appellant has not been treated in accordance with law, as such the respondents violated Article-4 and 25 of the Constitution; that the removal was solely made on the ground of negligence and lack of supervision on part of the appellant, but negligence does not come within the definition of misconduct, therefore on the ground of negligence major punishment cannot be awarded; that the appellant was not associated with the process of inquiry and the whole proceedings were conducted ex-parte, therefore the impugned orders are illegal and void ab initio; that no chance of personal hearing and personal defense has been afforded to the appellant and the whole inquiry proceedings were conducted in absence of the appellant; that no show cause notice has been served upon the appellant prior to issuance of the impugned orders; that no regular inquiry has been conducted, which is must before imposition of major penalty of dismissal; that the appellant was discharged from FIR vide judgment dated 12-10-2017, as the whole story of FIR against the appellant was false, frivolous and baseless; that once the appellant was acquitted of the criminal charges, he cannot be penalized for the same charges departmentally; that as per FR-54, where an accused civil servant is acquitted of the charges, he shall be re-instated in service, but the appellant was not treated in accordance with law; that in the de-novo inquiry the appellant has been exonerated from the charges by the inquiry officer, but the respondents without taking into consideration the inquiry report and recommendations, imposed major penalty of removal from service;

same, maximum penalty could not be imposed upon a civil servant. Reliance is placed on PLJ 2015 Tr.C. (Services) 197, PLJ 2015 Tr.C. (Services) 208 and PLJ 2015 Tr.C. (Services) 152. The respondents however did not honor their own rules and dismissed the appellants in violation of rules.

06. The appellant was re-instated for the purpose of de-novo inquiry and because of de-novo proceedings, the appellant was again removed from service in spite of the fact, that he was exonerated of the charges by competent court of law from the same charges, upon which he was proceeded against and was ultimately removed from service. It is pertinent to mention that prosecution itself sought discharge of the appellant from FIR on the ground that nothing tangible was proved against the appellant to connect the appellant with the commission of offense and upon request of prosecution, the appellant was discharged from FIR vide order dated 12-10-2017 by the competent court of law. In 2012 PLC (CS) 502, it has been held that if a person is acquitted of a charge, the presumption would be that he was innocent. Moreover, after acquittal of the appellant in the criminal case, there was no material available with the authorities to take action and impose major penalty. Reliance is placed on 2003 SCMR 207, 2002 SCMR 57 and 1993 PLC (CS) 460.

07. As per provisions contained in Section 16:3 of police rules, 1934, the respondents were bound to re-instate the appellant after earning acquittal from the same charges, upon which the appellant was dismissed from service, but the respondents despite his acquittal, removed him from service and did not take into consideration the verdict of the court as well as of Police Rules, 1934. The respondents also violated section-54 of Fundamental Rules by not re-instating the appellant after earning acquittal from the criminal charges. In a manner, the appellant was illegally kept away from performance of his duty. Needless to mention that the charges so leveled are based on presumption as nothing has been proved against the appellant, whereas an accused cannot be convicted on

presumptions. Prosecution has to prove the guilt of an accused beyond all reasonable doubt. Reliance is placed on 1991 SCMR 244 and 2002 PLC (CS) 503. Record is silent as to whether any de-novo inquiry was conducted as no inquiry report is available on file to ascertain as to how the appellant was proceeded against. In case of charge of misconduct, a regular inquiry was to be conducted, which had not been done in case of the appellant. In cases of awarding major penalty, a proper inquiry was to be conducted in accordance with law, wherein a full opportunity of defense was to be provided to the civil servant; otherwise, the whole proceedings would be illegal and nullity in the eye of law. Reliance is placed on 2004 SCMR 316. Respondents however cannot absolve themselves from proving the charge beyond any reasonable doubt and the burden shifted to the accused only when the prosecution succeeded in establishing the presumption of guilt. Reliance is placed on 2021 SCMR 408.

08. We are of the considered opinion that the appellants has not been treated in accordance with law and he was illegally kept away from performance of duty as he was acquitted of the same charges by the competent court of law as well as nothing was proved against him departmentally. In view of the foregoing, the instant appeal is accepted. The impugned orders dated 23-08-2019 and 07-10-2019 are set aside and the appellant is re-instated in service with all back benefits. Parties are left to bear their own costs. File be consigned to record room.

He submitted an appeal before Worthy Inspector General of Police, Peshawar, Peshawar but the appeal was rejected vide office order No. 87105-74 dated 23/08/2019.

Feeling aggrieved the defaulter officer filed service appeal No. 1524/2019 in service Tribunal Khyber Pakhtunkhwa. On 03-05-2019 Service Tribunal partial accepted the appeal and pronounced judgment wherein it was directed that "The concerned BPO/SSP to issue charge sheet statement of allegations as well as final show cause notice and pass order, if any appropriate in the de-jure enquiry."

In de-jure enquiry he was again recommended for removal from service. Accordingly he was again removed from service vide office order No. 1127-18/E/C(TD) dated 07/10/2019 by Senior Superintendent of Police, CTO Central Zone, Peshawar, Peshawar, Peshawar District, Khyber Pakhtunkhwa, which was also rejected in appeal No. 1524/2019 in service Tribunal dated 07/10/2019.

He preferred again service appeal No. 1524/2019 in service Tribunal of Peshawar, Peshawar, Peshawar. On 05-01-2022 Service Tribunal accepted the appeal and announced judgment wherein it was directed that "The impugned orders dated 23/08/2019 and 07/10/2019 are set aside and the appellant is re-instated in service with all back benefits."

Now I, JAVED IQBAL (PSP) DEPUTY INSPECTOR GENERAL OF POLICE, CTD, KHYBER PAKHTUNKHWA being a competent authority to exercise the powers vested in me vide Police Rules, 1975 (amendment 2014) is hereby ordering that the then Inspector Nazz Hussain as Inspector (BPS-16) from the date of his removal from service vide office order No. 1127-18/E/C(TD) dated 23/08/2019 with all back benefits.

- ii. That an you direction your gunman namely Ishaq Ali No 182 received the NCP Vehicles from one Haji Hayat Khan r/o Bara Khyber Agency for transportation to Sakhakot.
- iii. That your performance as SHO PS CTD Mardan remained poor.

He was proceeded departmentally issuing him Charge Sheet alongwith of allegation vide this office No 8709-13/PA/CTD dated 01-08-2017 and accordance of inquiry he was awarded major Punishment of Dismissal from service later on he submitted an appeal before Worthy Inspector General of Police CT Khyber Pakhtunkhwa was rejected vide office order No. 5/106-74 dated 22.03.2018.

Feeling aggrieved the defaulter office filed Service appeal No 267/2018 in Service Tribunal Khyber Pakhtunkhwa on 03.05.2019 Service Tribunal partial accepted the appeal and Judgment wherein it was directed that **"The concerned DPO/SSP for issue Charge sheet statement of allegations as well as final show cause notice and pass order deem appropriate in the denovo inquiry.**

In denov inquiry he was again recommended for awarding major punishment accordingly he was again removed from service order No. 1127-28/EC/CTD dated 23.08.2019 by Senior Superintendent of Police, CTD, Central Zone. He submitted an appeal to Worthy DIG/CTD Khyber Pakhtunkhwa which was also rejected/filled vide order No 12853-56/CTD dated 2019.

Again Service appeal No. 1524/2019 in Service Tribunal Khyber Pakhtunkhwa Peshawar Service Tribunal accepted the appeal and announced Judgment wherein it was **The imagined orders dated 23.08.2019 and 07.10.2019 are set aside be reinstated in service with all back benefits.**

1. In compliance with Order Sheet of Hon'ble Supreme Court of Pakistan dated 26.01.2023 in Suo Moto Contempt proceedings vide CrI.O. Petition No. 38/2021 against Chief Secretary Khyber Pakhtunkhwa and Inspector General of Police Khyber Pakhtunkhwa initiated for not having carried out demotions of Police Officers of Khyber Pakhtunkhwa Police in Out of Turn Promotions cases, Khyber Pakhtunkhwa Police issued Demotions/Repatriations Orders in respect of Police Officers/Officials falling under Out of Turn categories. The Peshawar High Court suspended such demotions Orders so issued in Out of Turn Promotion cases and granted relief to officers who were beneficiary of Cadetship Scheme, who got absorbed in KP Police from Other Provinces, Officials got absorbed from executive cadre to Telecommunication Cadre

Subject: **REPRESENTATION / APPLICATION / APPEAL FOR GIVING BASIC RIGHTS OF PROMOTION TO THE RANK OF DSP.**

Respected Sir,

Submitted that, I am writing this appeal to draw attention of your prestigious self to a matter of significant concern regarding the deferment of my name in the Departmental Promotion Committee (DPC) held in the central Police office on 27-11-2023, for the promotion to the Rank of DSP the reason cited for the deferment is the non-availability of four years of out-of-service Annual Confidential Reports (ACRs).

It is noteworthy that a similar deferral occurred in the DPC held on 08-12-2022, and my appeal from the previous year remains pending without acceptance or rejection by the competent authority. In light of these circumstances, I respectfully submit the following lines for your kind perusal and sympathetic consideration.

1. False FIR and Unjust Dismissal:

On 29-07-2017, a false FIR (u/s 419/420/468/471/PPC r/w 15AA) was filed against me while serving as Inspector CTD/SHO Mardan Region.

Subsequently, on 09-11-2017, I received a major penalty of dismissal from service, which was unjust considering the circumstances. (Copy of dismissal order attached as 'a')

2. Judicial Acquittal and Tribunal's Decision:

On 29-10-2017, the Learned Trial Court of Judicial Magistrate-Takht Bhai discharged me of all charges. (Copy of Order annexed as 'b')

Despite a favorable decision by the Hon'ble Khyber Pakhtunkhwa Service Tribunal Peshawar in Service appeal No. 267/2018, I face rejection of reinstatement orders on 23-08-2019 and 07-10-2019 by the Senior Superintendent of Police (CTD) Central Zone Peshawar and Deputy Inspector General of Police CTD Khyber Pakhtunkhwa respectively. (Copies of Orders dated 03-05-2019, 23-08-2019, and 07-10-2019 attached as 'c', 'd' and 'e')

3. Subsequent Appeals and Tribunal's Intervention:

On 01-11-2019, I filed another Departmental Appeal in the Court of Hon'ble Khyber Pakhtunkhwa Service Tribunal Peshawar.

The Hon'ble Court, in its order/Judgment (Appeal No. 1524/2019) dated 05-01-2022, set aside the orders dated 23-08-2019 and 07-10-2019, reinstating me in service with all back benefits.

4. **Seniority and Previous DPCs:**

As of 06-12-2022, I am listed at Serial No. 71 in the Final Revised Seniority List of Inspectors of KP Police for the Year 2022. (Copy of Seniority List annexed as 'g')

5. **Repetitive Deferral in DPCs:**

The DPC held on 08-12-2022, deferred my promotion to the rank of DSP due to the non-availability of four years of ACRs. (Copy of the order attached as 'b')

6. **Legal Safeguards and Tribunal's Decision:**

According to Para-4 of Service Appeal No. 700/2018 and section 16 (3) of Police Officer acquitted by a criminal court should not face departmental punishment on the same charges.

7. **Financial Benefits vs. Promotion Rights:**

Despite receiving the financial back benefits in accordance with the tribunal's judgment. The denial of my promotion as DSP infringes upon my basic right and constitutes a potential contempt of court.


8. **ACRs Unavailability During Out-of-Service period:**

I was deferred from the promotion as DSP due to the non-availability for four years of ACRs. However, I was out of service from 09-11-2017 to 05-02-2022. Consequently, obtaining ACRs for this period poses a practical challenge. I have approached the concerned authorities for the ACRs but given my out-of-service status during this time, this request has been met with refusal.

In light of the circumstances presented above, I earnestly request the relaxation of the ACR requirement of four years, considering the genuine nature of my case and the solid reasons provided. I kindly appeal for your support in ensuring that justice is served, and I am promoted to the rank of DSP alongside my colleagues.
