
2. The Tribunal attached the salaries of the respondents and directed the Accountant General Khyber Pakhtunkhwa to attach the salaries. But instead of complying with the court orders, is not attaching the salaries. Show cause notice be issued to the Accountant General, Secretary Finance, and Secretary Establishment in this regard. Vide order sheet dated 31<sup>st</sup> October, 2023 salaries of the respondents were directed to be attached alongwith direction to submit report in writing that salaries of the respondents were actually attached, whereas, salary slips of the District Education Officer Mohmand have been produced by the learned counsel for the petitioner, which show that salaries were not attached by the Accountant General Office and District Accounts Officer concerned. This means and shows that the order of the Tribunal has not been complied with. Manager Allied Bank Limited Shabqadar is directed to attach the account of the D.E.O. Mohmand till further orders. The Account number is provided in the salary slip copy of this order be sent to the Manager Allied Bank Shabqadar. Similarly, other accounts of the DEO Mohmand are also attached till further orders. The Accountant General Khyber Pakhtunkhwa be informed that despite directions the concerned offices under his control have not stopped/attached the salaries in compliance with the directions of the Tribunal contained in order dated 31.10.2023. (Copy of the order sheet be sent). District Accounts Officer Mohmand shall be issued notice to reply in writing why the order of the Tribunal was not complied with and salaries of the DEO Mohmand not attached. On 31<sup>st</sup> October, 2023 he was


