**SERVICE APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT 1974 AGAINST THE IMPUGNED FINAL SENIORITY LIST OF HEAD CONSTABLES /LHCs ON PROMOTION LIST "C" AS STOOD ON 31-03-2023; COMMUNICATED TO THE APPELLANT THROUGH RTI, KHBYBER PAKHTUNKHA LETTER DATED 24-06-2023, WHEREIN RESPONDENTS NO.5 TO 10 HAS BEEN PLACED SENIOR TO THE APPELLANT IN VOILATION OF RULE 13.8 OF THE POLICE RULE, 1934 AND AGAINST WHICH APPELLANT FILED DEPARTMENTTAL APPEAL DATED 23-07-2023, WHICH IS STILL PENDING WITH OUT DISPOSAL, HENCE THE STATUTORY PERIOD HAS ELAPSED THEREFORE THE INSTANT SERVICE APPEAL.**

**PRAYER:**

On acceptance of the instant service appeal, this Hon'ble Tribunal may graciously be pleased to:-

- i. **Declare** the impugned final seniority list of Head Constables /IHCs on promotion list "C" as stood on 31-03-2023, wherein respondents No.5 to 10 have been placed senior to the appellant in violation of Rule.13.8 of the Police Rules, 1934 as illegal, unlawful, without lawful authority, against fair play, discriminatory and norms of justice and set aside the same.
- ii. **Direct** the respondents to restore the original seniority position of the appellant assigned to him by the PTC as per rule 13-8 of the Police Rules, 1934, promote him to the post HC accordingly in preference to respondent No.5 to 10 along with all back benefits.
- iii. **Any other relief** as deemed appropriate under the circumstances of the case may also graciously be allowed to the appellant.

Respectfully Sheweth,

The facts given rise to the present service appeal are as under;

1. That the appellant is presently serving as LHC in the Police Force Kohat. The nomination of the appellant was made for promotion course (Lower School Course) on the strength of his enrolment from District Kohat. Appellant passed his Lower School Course in terms ending on 31-07-2014 with remarkable Marks at his credit. The same is evident from the result announced by the Commandant PTC, Hangu. **Annexure-A.**

2. That Rule 13.18 of the Police Rules, 1934 provide that seniority of constables, who have qualified "Lower School Course", shall be determine in accordance with merit position assigned to them (amongst the colleagues) by the Commandant PTC, Hangu. The relevant provision 13.8 are reproduced as under: (u)

*13.8.....Promotion of Head Constable shall be made in accordance with the principle described in sub-rules 13.1(1) and (2). The date of admission of List C shall not be material, but the order of merit in which examinations have been passed shall be taken into consideration in comprising qualifications. In case where other qualifications are equal, seniority in the police force shall be deciding factor. Selection grade constables who have not passed the Lower School Course at the Police Training School but are otherwise considered suitable may, with the approval of the Deputy Inspector-General, be promoted to Head Constable up to maximum of ten per cent of vacancies.*

3. That after passing Lower School Course and when they join their district; they are immediately brought on the List of LHC (Lance Head Constable) and their seniority are fixed in accordance with merit position assigned to them by PTC result in reference to their ending term of their course. Appellant has passed his Lower School Course in the term ending on 31-07-2014.

4. That it is pertinent to mention that respondent No.5 to 10 have passed their Lower School Course in term ending on 30-11-2014 therefore, in this view of the matter and in accordance with spirit and provision of Rule 13.8 of the Police Rules, 1934 and departmental practice thereon, appellant is senior to all the above named HCs.

5. That it is pertinent to mention here that respondent No.3 was under legal obligation to cause seniority of LHCs every year as per demands/ mandate of Section 8 CSA, 1973 and Rule 17 of APT Rules, 1989, but no such seniority list have ever been notified and circulated by respondents till 2023.
6. That appellant along with other colleagues applied for provision of Seniority List from the period 2014 to 2022, but no such seniority list was provided rather they were informed that no seniority list from 2014 and award has been notified/circulated. **Annexure-B.**
7. That appellant in order to avail all other legal remedy approached RTI (**Annexure-C**) and thereafter correspondence took place in between the office of respondent No.3 and RTI and resultantly appellant and his colleagues were provided Seniority list of the LHCs on promotion list "C" as stood on 31-03-2023. **Annexure-D.**
8. That treatment of the department by depriving the appellant from his due seniority position in the seniority list is/was highly unlawful and ineffective upon the rights of the appellant. Appellant is entitled to be placed in the seniority list of LHCs on promotion list-C, in accordance with merit list assigned to him by the Commandant PTC, Hangu on the basis of Lower School Course Examination Result in the term ending on 31-07-2014. This anomaly/error/illegality has deprived the appellant from promotion to the post of Head Constable on regular basis and further his entitlement to Promotion list of IHC and nomination to undergo Intermediate College



Course at PTC, Hangu and also to the Promotion List-D and also his enlistment for onward promotion. This anomaly/error/illegality will continue till the end of service career of the appellant therefore, it is necessary to rectify the error/illegality at this initial stage and provide the appellant fair opportunity of rising up in departmental hierarchy through legal means/merit. (6)

9. That appellant being aggrieved from the final seniority list preferred departmental appeal (**Annexure-E**), which is still pending without disposal, hence the instant service appeal inter alias on the following grounds.

A. That the appellant has not been treated by the respondents in accordance with law, rules and policy on the subject and acted in violation of Articles 4 and 10-A of the Constitution of Islamic Republic of Pakistan. Rule 13-8 of the Police Rules, 1934 provide that seniority of constable who has cleared their Lower School Course in one batch shall be in accordance with merit position assigned to them by the PTC. Appellant qualified his Lower School Course in term ending on 31-07-2014, therefore he was entitled for his seniority along with his other colleagues, who has passed their Lower School Course in term ending on 31-07-2014, but respondent instead of placing his seniority along with his term colleagues has placed him in the last term of 2014, which is not only against the spirit and provision of Rule 13.8 of Police Rules, 1934 but also against the fundamental rights guaranteed under Article 4, 10A, 25 & 27 of the Constitution of Pakistan, 1973.

B. That as per mandate of law, initially a tentative seniority list is notified and objection is called upon from all concerned, who may feel aggrieved

from their seniority position, but in the instant case all proceeding were initiated secretly and at the back of the appellant as no tentative seniority list was issued and appellant was condemned unheard which is the violation of the well-known principle of law "Audi altram Partem". This principle of law was always deemed to have embedded in every statute even though there was no specific or express provision in this regard. (7)

....An adverse order passed against a person without affording him an opportunity of personal hearing was to be treated as void order. Reliance is placed on 2006 PLC (CS) 1140. As no proper personal hearing has been afforded to the appellant before the issuing of the impugned order, whereby appellant was not only deprived from his due seniority position, but also from his accrued right of promotion therefore, on this ground as well the impugned orders are liable to be set aside.

- C. That appellant has highly been discriminated and that too not only in term of his seniority but also discriminated from his due and legal regular promotion to the post of HC and IHC and whereas respondents, who were juniors have been benefited with undue privileges, who had qualified their Lower School Course after the term of appellant. Every government servant has legitimate expectancy of rising up in government hierarchy by means of regular promotion, but respondents in violation of the principle of legitimate expectancy deprived the appellant from his seniority and further promotion.
- D. That the stance of the respondents that the seniority of the appellant and his two other colleague has been fixed as per instructions of the W/IGP KP, Peshawar letter No.2288-2320/E-IV dated 24-02-2015 is

misconceived on two scores. (i) The decision of the so called committee constituted under the directions of the Hon'ble Supreme Court of Pakistan have acted beyond their jurisdictions for the reason that the Hon,ble Supreme Court of Pakistan had directed them to scrutinize the matter as per merits of the candidates who have qualified Lower School Course, but the respondents instead of strict directions of the Hon'ble Supreme Court of Pakistan made its recommendations otherwise and that is why the Hon,ble Peshawar High Court reversed the findings and recommendations of the so called committee and directed that there was no need of holding B-1 examination. The judgment of the Hon'ble Peshawar High Court, Peshawar in WP. No.1952-P/2015 is hereby attached with the instant appeal as **Annexure-F**. (ii) 2ndly the Hon'ble High Court in the very recent judgment (**Annexure-G**) has declared that the incumbents, who has secured their promotion on granting extra seats for undergoing Lower School Course (180 and those who has secured selection on the basis of the judgment of the Hon'ble High Court) does not come within the preview of out of turn promotion as the department has/had itself created extra seat for Lower School Course.

E. The so called committee constituted for determination of seniority; is not competent to overrule the existing provision of Rule 13.8 therefore, the recommendations of the committee and subsequent order thereupon vide W/IGP KP, Peshawar letter No.2288-2320/E-IV dated 24-02-2015 is void ab inito void and illegal and liable to be struck down on this score alone. The recommendations of the so called Committee is without statutory backing as the same has not approved by the Government of Khyber Pakhtunkhwa nor any sort of amendment has been brought by the Government in Rule# 13.8. In presence of Rule 13.8, the alleged

decision of the Committee has no binding effects therefore, void abinitio and liable to be set at naught. The decision of the Committee and approval of IGP Khyber Pakhtunkhwa dated 24-02-2015 has already been set aside by the Hon'ble High Court. (9)

F. That appellant would like to seek the permission of this Hon'ble Tribunal to advance more grounds at the time of hearing.

In view of the above explained positions, it is humbly prayed that the instant service appeal may be allowed as prayed for above.

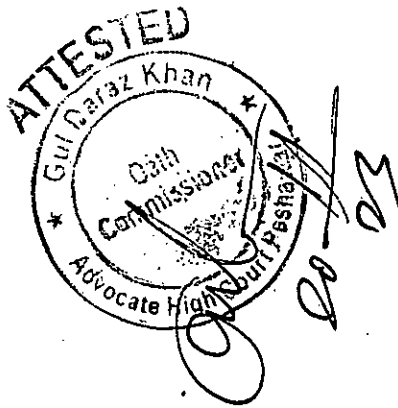

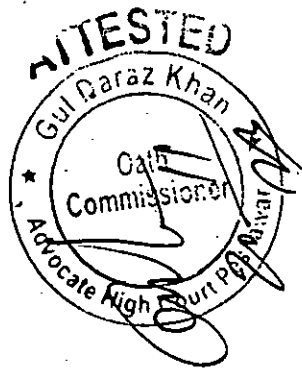



Respected Sir,

With due respect, appellant humbly submit as under:-

1. That the appellant has passed Lower Course from PTC Hangu, vide term ending on 31.07.2014.
2. That seniority shall be determine in accordance with merit position determine by commandant PTC Hangu on the basis of course result out of the candidates of their District.
3. That the nomination of the appellant was made for promotion course (Lower School Course) on the strength of his enrolment from District Kohat. Appellant passed his Lower School Course in terms ending on 31.07.2014 with remarkable Marks at his credit. The same is evident from the result announced by the Commandant PTC, Hangu.

4. That it is pertinent to mention that 1) Mr. Muhammad Aman Belt No.646 2) Mr. Muhammad Shahid Belt No.415, 3) Mr. Faiz Noor Belt No. 4236 and others. All these LHCs have passed their Lower School Course in term ending on 31-07-2014. The seniority of all these LHCs have been fixed in term ending on 31.07.2014, but the seniority of the appellants have been fixed with LHCs, whose Lower School Course ended in the last term of the year 2014, which is a clear violation of Rule No.13.8 of the Police Rules, 1934.
5. That in this view of the matter and in accordance with spirit and provision of Rule 13.8 of the Police Rules, 1934 and departmental practice thereon, appellants were entitled to be placed in the seniority list along with incumbents, who have passed their Lower School Course in term ending on 31.07.2014.
6. That recently the Competent Authority on the recommendations of DPC has promoted the above mentioned LHCs and others, who were allegedly senior on the promotion list-C to the post of Head Constable in violation of Rule 13.8 of the Police Rules, 1934 Vide Notification Vide OB No.452/SRC dated 04-10-2022 and Notification No.9370-75/SRC, dated Kohat the 05-10-2022.
7. That from the result sheet and as per law appellants were to be placed with his colleagues, who had passed their Lower School Course in term ending on 31.07.2014, but appellants have been placed with LHCs, whose term ended in the last term of 2014.



8. That it is pertinent to mention here that respondents were under legal obligation to cause seniority of LHCs every year as per demands/ mandate of Section 8 CSA, 1973 and Rule 17 of APT Rules, 1989, but no such seniority list have been notified and circulated by respondents, till the date.
9. That the appellant applied from provision of seniority list since the passing of Lower School Course, and they was provided tentative seniority list for the year 2022.
10. That from the bare perusal of the seniority list, it is clear that appellant has been placed at serial No.73 of the tentative seniority list vide term ending in the last term of 2014, which is the violation of Rule 13.8 of the Police Rules 1934.
11. That being aggrieved from tentative seniority list, appellant preferred objection petitioner as per law.
12. That respondents were under legal obligation to issue, notify and circulate the final seniority list of all those LHC who were on promotion list "C" but instead of issuing, notify and circulating final seniority list; respondents on the basis of tentative seniority list issues promotion orders Vide Notification Vide OB No.452/SRC dated 04-10-2022 and Notification No.9370-75/SRC, dated Kohat the 05-10-2022.
13. That appellant along with other colleagues applied for provision of Seniority List from the period 2013 to 2022,

but no such seniority list has been provided rather they were informed that no seniority list from 2013 and award has been notified/circulated.

1. That appellant in order to avail all other legal remedy approached RTI but till date no positive response.
2. That treatment of the department by depriving the appellant from his due position in the seniority list is highly unlawful and en-effective upon the rights of the appellant. Appellant is entitled to be placed in the seniority list of LHCs on promotion list-C, in accordance with merit list assigned to him by the Commandant PTC, Hangu on the basis of Lower School Course Examination Result for the term ending on 31.07.2014. This anomaly/error/illegality has deprived the appellant from promotion to the post of Head Constable and further his entitlement to Promotion to the Promotion List-D and undergoing Intermediate Promotion Course and also his enlistment in onward promotion. This anomaly/error/illegality will continue till the end of service career of the appellant therefore, it is necessary to rectify the error/illegality at this initial stage and provide the appellant fair opportunity of rising up in departmental hierarchy through legal means/merit.

In view of the above humble submission, supported by Rule 13.8 of the Police Rules, 1934 and coupled with departmental practice; Your Honour may graciously be pleased to direct the concerned office to prepare fresh seniority list in accordance

**TRANSFER FROM OTHER PROVINCES AND ABSORBED IN

43. Writ petitions filed against the Orders dated 14.04.2022 and 21.04.2022 issued after the decision of the larger bench judgment stand disposed of in the above manner.

44. In view of the above-detailed reasons so recorded, this and the connected writ petitions are decided in the following manners:-

I. *The police officers who were declared as Cadet and Cadet-Instructors pursuant to the provisions of the Police Rules, Standing Order No.11 of 1987, Standing Order No.7 of 2003 and duly protected under the Khyber Pakhtunkhwa Validation of Standing Orders Act 2005 and Chapter 13.7 A and 13.7 B of the Police Rules, they are not hit by the judgment of the Hon'ble Supreme Court of Pakistan relating to out of turn promotions, and as such, demotion/reversion orders of all such police officers are set aside and they are restored to their original positions.*

II. *Promotions/ upgradations made on account of gallantry acts are hit by the judgments of the Hon'ble apex Court, as such, all such upgradations/promotions made on account of gallantry acts or allegedly as they stood fast in the*



performance of duties during the waves of terrorism are not protected and are hit by the judgment of the Apex Court, therefore, all such writ petitions are dismissed in the light of para 25 of this judgment.

III. Cases of Women police officers send for trainings/courses and allowed promotion under Standing Order No. 4 of 2014 are remitted back to the respondent department to reconsider their positions in term of para 27 of this judgment.

IV. Police officers nominated for training on additional seats are considered as not hit by the judgment of the Hon'ble Supreme Court of Pakistan, and as such, their writ petitions are allowed and the impugned order of reversion/demotion is set-aside.

V. Officers transferred from other provinces and absorbed in Khyber Pakhtunkhwa Police or transferred and absorbed within the same police force from other cadre are also considered to be in accordance with law and not hit by the judgment of the Hon'ble Supreme Court of Pakistan, the impugned repatriation orders are thus set aside in the light of para 35 of this judgment.

VI. Cases of absorption of Class-IV employees against the post of Constables are disposed of and their cases are remitted back to the respondent

department to reconsider its decision in accordance with detailed reasons given in para 37 of this judgment.

VII. Contempt of Court cases stand disposed of as the judgment of a larger bench decided on 09.12.2021 has since been complied with vide letter dated 21.04.2022.

VIII. Writ petitions questioning vires of orders dated 12.03.2022, 14.04.2022, 21.04.2022 are disposed of considering it as a policy decision of the Provincial Government, however, their letters to the extent of setting aside the Khyber Pakhtunkhwa Validation of Standing Order Act 2005 is set aside, and the impugned letters are held to have prospective effect as held in para 42 of this judgment.
