

THE NWFP CIVIL SERVANTS ACT, 1973 (N.W.F.P. Act No. XVIII of 1973)

An Act to regulate the appointment of persons to, and the terms and conditions of service of persons in, the service of the North West Frontier Province.

Preamble WHEREAS it is expedient to regulate by law, the appointment of persons to, and the terms and conditions of service of persons in, the service of the North West Frontier Province, and to provide for matters connected therewith or ancillary thereto;

It is hereby enacted as follows:-

- 1. Short title, application and commencement:- (1) This Act may be called the North West Frontier Province Civil Servants Act, 1973.
- (2) This section and section 25, shall apply to persons employed on contract, or on work charged basis, or who are paid from contingencies, and the remaining provisions of this Act including this section, shall apply to all civil servants wherever they may be.
 - It shall come into force at once.

CHAPTER-I

PRELIMINARY

- 2. Definitions:- (1) In this Act, unless the context otherwise requires the following expressions shall have the meanings hereby respectively assigned to them, that is to say-



- Probation, --- (1) Persons appointed to posts by initial regraitment promotion or er shall be on probation for a period of one year.
- The appointing authority, if considers necessary, may extend the probation remod for one year as may be specified at the time of appointment
- On the successful completion of probation period, the appointing authority eall, by specific order, terminate the probation:

- (3) In the event of merger/restructuring of the Departments, Attached Departments of Subordinate Offices, the inter se seniority of civil servants affected by the merger/restructuring as aforesaid shall be determined in accordance with the date of their regular appointment to a cadre or post.
- The inter-se-semority of civil servants in a certain cadre to which promotion is made from different lower posts, carrying the same pay scale shall be determined from the date of regular appointment promotion of the civil servants in the lower post.


