PRELIMINARY OBJECTIONS:

Dated 19-03-2024

1. That the appellant has got no cause of action as well as locus standi to file the instant appeal.
 2. That the instant appeal is badly time barred.
 3. That the appellant is estopped by his own conduct.
 4. That the appellant has not come to this Honourable Tribunal with clean hands.
 5. That the appellant has concealed the material facts from this Honourable Tribunal hence liable to be dismissed.
 6. That the instant appeal is liable to be dismissed for non-joinder / mis-joinder of unnecessary parties.
 7. That the instant appeal is against the prevailing law and rules.
- That the appellant is not entitled for promotion to SST post, because the appellant is serial No 37 while Huriat Begum is at serial No 16 in the Seniority list of the STT.

FACTS:

1. Para No 1 relates her appointment, no comments.
2. Para No 2 relates her Promotion to Senior TT, no comments.
3. Para No 3 , relates Huriat Begum's Promotion to Senior TT, no comments.
4. Para No 4 is Incorrect & not admitted. As the respondent No 2 has been issued notification vide No 5083-88 dated 21-12-2017 in good faith in public interest. The appellant is not entitled for promotion to the post of SST, because the appellant is at serial No 37 while Huriat Begum is at

serial No 16 at the Seniority list of the STT and furthermore, that the appellant has promoted from TT to STT on 26/8/2016, while Huriat Begum has promoted from TT post to STT post, on 18/12/2014, therefore Huriat Begum was at serial No 16 and She was eligible and senior for the post of SST, hence denied.

- 5. Para No 5 relates her Previous Service appeal, no comments.
- 6. Para No 6 relates her inquiry, but the respondent No 2 conducted another inquiry and concluded that the appellant was not eligible to the post of SST as per seniority of STT, no comments.
- 7. Para No 7 is Incorrect & not admitted. As the respondent No 2 conducted inquiry which takes time and the respondent No 2 is not delay the case. The execution petition is consigned on merit, hence denied.
- 8. Para No 8 is Incorrect & not admitted. As the respondent department conducted inquiry committee and the inquiry committee decided that Huriat Begum was promoted earlier to the post of STT dated 10/12/2014, while the appellant was promoted latter on to the post of STT dated 26/08/2016. The claim of the appellant has been rejected on 29/06/2022 as per the final Seniority list of the STT, where the appellant is at serial No 37 and Huriat Begum is at serial No 16 in the final Seniority list.

- 9. Para No 9 is Incorrect & not admitted. As the respondent No 2 has been issued notification vide No 7091-95/ DPC-2022-23 dated 02/01/2023 in good faith in public interest. The appellant is not entitled for promotion to the post of SST, because the appellant is at serial No 19 while Nasim Akhtar is at serial No 13, Khatoon Bibi is at serial No 14, and Shaista is at serial No 15, in the Seniority list of TT, hence denied.

- 10. Para No 10 is Incorrect & not admitted. As the respondents being responsible government officers acted in accordance with law. The departmental appeal of the appellant is badly time barred, hence denied.
- 11. Para No 11, needs no comments.

GROUND

- A. Para A is Incorrect & not admitted. As the respondent No 2 has been conducted inquiry committee and the inquiry committee decided that Huriat Begum was promoted earlier to the post of STT dated 10/12/2014,

while the appellant was promoted later on to the post of STT dated 26/08/2016. The claim of the appellant has been rejected on 29/06/2022 as per the final Seniority list of the STT, where the appellant is at serial No 37 and Huriat Begum is at serial No 16 in the final Seniority list.


- B. Para B is Incorrect & not admitted. As the appellant is not entitled for promotion to the post of SST, because the appellant is at serial No 37 while Huriat Begum is at serial No 16 at the Seniority list of the STT, hence denied.
- C. Para C is Incorrect & not admitted. As the respondents being responsible government officers acted in accordance with law, and the eligible employees have promoted to STT, in the year 2017, hence denied.
- D. Para D is Incorrect & not admitted. As Huriat Begum was promoted earlier to the post of STT dated 10/12/2014, while the appellant was promoted later on to the post of STT dated 26/08/2016. The said promotion order is legal, hence denied.
- E. Para E is Incorrect & not admitted. As reply in the above paras, the appellant was at serial No 37 in the final STT seniority list, needs no comments.
- F. Para F is Incorrect & not admitted. As the appellant is consider for promotion but the other employees are more senior than the appellant, hence denied.
- G. Para G is Incorrect & not admitted. As each and every cases have their own merit and circumstances, need no comments.
- H. Para H is Incorrect & not admitted. As the appellant has not been discriminated and the appellant has been treated accordance with law, hence denied.
- I. Para I is Incorrect & not admitted. As reply in the above paras, needs no comments.
- J. Para J is Incorrect & not admitted. As the appellant has not discriminated, hence denied.
- K. Para K is Incorrect & not admitted. As the respondent has not been promoted junior employees, needs comments.
- L. Para L is Incorrect & not admitted. As the appellant has not been deprived from her legal rights, hence denied.
- M. Para M is Incorrect & not admitted. As Huriat Begum was promoted earlier to the post of STT dated 10/12/2014, while the appellant was promoted later on to the post of STT dated 26/08/2016, hence denied.
- N. Para N is Incorrect & not admitted. As the appellant has not been discriminated, and Junior to the appellant have not been promoted by the respondent department, hence denied.
- O. Para O is Incorrect & not admitted. As the case of the appellant has been settled as per the seniority list, hence denied.
- P. Para P is Incorrect & not admitted. As the claim of the appellant is not legal and genuine, hence denied.
- Q. Para Q is Incorrect & not admitted. As the appellant has been treated accordance to law and rules, hence denied.

R. That the respondents seek permission to raise additional grounds at the time of arguments.

Therefore, in view of the above made submissions, it is most humbly prayed that on the acceptance of this reply, the appeal in hand may kindly be dismissed in favor of the Respondent Department in the interest of justice.






