# Respected Sir:

- That appellant initially inducted in the department in the year 2008 and lastly promoted to the post of Assistant Director from the post of Budget and Account Officer B-16 through DPC / PSB on 28-05-2019.
- 2. That department maintain combine seniority list of Assistant Director, Director Sports Officer and Administrators B-17 according to the rules of 2019 as all these posts having same cadre / grade in the department. (Copy as annex "A")

- 3. That the department issued Tentative Seniority List for the year 2021 stand on 15-09-2021, issued vide covering letter dated 15-09-2021 inviting objections from the concerned officials within 15 days positively. Here it is to be pointed out that officials from S. No. 09 to 16 who were not regularly promoted through DPC but only upgraded were placed senior to appellant whereas appellant was placed at S. No. 19 of the seniority list in violation of law and as he was regularly promoted through DPC / PSB. (Copy as annex "B")
- 4. That appellant preferred objection on proforma to the respondents on the ground that the official from S. No. 09 to 16 has not been promoted to the post of District Sports Officer B-17 on the recommendation of DPC but upgradation of the post that too only post is upgraded and the post was not upgraded along with incumbents but in vain.(Copy as Annex "C")
- 5. That on 16-08-2022, the same Tentative Seniority List which was issued on 15-09-2021 was again issued vide covering letter dated 16-08-2022 on which the appellant filed objection on 29-08-2022 but in vain / not respond / not considered. (Copies as Annex "D" & "E")
- 6. That on 27-01-2023, the department issued Final Seniority List stood on 18-01-2023 but without circulating the same among the concerned officials and was kept in dark from the appellant and other officials, the same seniority list was got from the office on 08-03-2023, here it is to be noted that in the seniority list R. No. 06 to 13 who were only upgraded and not regularly promoted was made senior to appellant whereas appellant who was regularly promoted as Assistant Director on the recommendation of DPC / PSB in the year 2019 he was placed at S. No. 17 against the law and rules and thereafter the appellant preferred departmental appeal to R. No. 02 on 17-03-2023 which is not responded with in the statutory period of three months. (Copies as annex "F" & "G")
- 7. That the appellant preferred Service Appeal No. 1365/2023 on 17-06-2023 before this hon'ble Tribunal wherein reply was also submitted by the official as well as by the private respondents but astonishly the department Issued another Final Seniority List dated

10-10-2023 stood on 18-10-2023 in violation of all rules and law on the subject wherein R. No. 05 was figured at S. No. 01, in spite of the fact that R. No. 05 is the basic employee of Education Department, FATA and no merger of FATA Education Department has been affected with the Sports Department KPK till date besides previously R. No. 05 was illegally inserted in the Seniority List of 2021 upon which the employee of Sports Department preferred objection after which a Committee was constituted which recommended that the R. No. 05 be removed from the Seniority List of 2022 as no merger of Education FATA has been effected with Sports Department and resultantly the R. No. 05 was removed from Tentative Seniority List and Seniority List of incumbents was issued wherein the R. No. 05 was not included and thereafter final Seniority List stood on 18-01-2023 was issued by not including the R. No. 05. (Copies of Tentative Seniority List and Committee Report as annex "H" & "I")

- 8. That to the utter surprise of the appellant, the respondent department during the pendency of Appeal No. 1365 / 23 issued Tentative Seniority List dated 18-08-2023 by figuring R. No. 05 at S. No. 01 on which the appellant preferred objection but not replied where after the department issued Final Seniority List on 10-10-2023 stood on 18-08-2023 wherein the R. No. 05 was figured at S. No. 01 in violation seniority, law and rules on the subject. (Copies as annex "J" & "K")
- 9. That the appellant preferred departmental appeal on the Final Seniority List issued on 10-10-2023 stood on 18-08-2023 wherein the comments of Directorate was called which furnished the comments seconding the plea of appellant but till date the representation of appellant was not responded. (Copy as annex "L")
- 10. That the department might affect further promotions on the disputed and illegal Seniority List which will affect the future of appellant.

Hence, this appeal, inter alia on the following grounds:

## GROUNDS.

- a. That R. No. 05 is illegally inserted in the Seniority List whereas R. No. 06 to 13 has not been regularly promoted and only upgraded so has no right of seniority over the appellant who is regularly
- promoted on the recommendation of DPC / PSB to the post / cadre of Assistant Director B-17.
- b. That upgradation of a post is only meant for monetary benefits having no right of seniority over the officials who are regularly promoted.
- c. That even if R. No. 05 is included in Sports Department even then she will be placed at the bottom of Seniority List as per law and judgments of the superior courts.
- d. That the department violated the judgments of the superior court by issued Seniority List during the pendency of the appeal wherein Seniority List dated 18-01-2023 has been challenged and department is pursuing the same.
- e. That appellant has every right to be placed above R. No. 05-13 on the basis of regular promotion to the post / cadre of Assistant Director B-17.
- f. That the department / official respondents are legally bound to draw seniority list according to law and rules on the subject.
- g. That by drawing wrong seniority list of the incumbents of the department the respondents are trying to deprive the appellant from further promotion which is right of the appellant according to law and rules on the subject.
- h. That charge on the upgraded post does not give right of seniority over the incumbents who are regularly promoted on the recommendation of PSB / DPC.
- That the rules provides for promotion and not upgradation to the promotion post / vacancy. So upgradation in no way give right of seniority to the particular incumbents who are only upgraded.
- j. That the superior courts has drawn distinction between promotion and upgradation in many many judgments clarifying the position.

It is, therefore, most humbly prayed that on acceptance of the appeal, the Seniority List stood on 18-08-2023 issued on 10-10-2023 be modified and R. No. 05 to 13 be excluded from the same and appellant be placed at S. No. 09 above the name of Hamid Ali and below the name of Amjid Iqbal with all back / service / consequential benefits in the interest of justice.

- The notification No. SO (Sport) 1-41/2020/2913-6 dated 10-09-2021 is against the
  procedure / format laid down in the Manual of Secretariat Instructions as it relate to the
  clarification of objections raised on seniority position by the affectives. It was required to
  be issued in the form of letter and not in the shape of notification.
- 2. In sub Para 1 of Para 7 of the Sport Department notification No. SO (Sport) 1-41/2020/2913-6 dated 10-09-2021 it has been stated that Mr. Amjid Iqbal & Shakeel Ahmed were adjusted as Assistant (BPS-14) after being declared surplus. It is clarified that I was not adjusted from the Surplus Pool but appointed through initial recruitment by the District Government on 18-01-2008 (Copy of the order is attached). (Annexure-A)
- 3. In sub Para 2 of para 7 of the said notification it is stated that Mr. Amjid Iqbal and Shakeel Ahmed assumed charge on the upgraded posts of Assistant and no DPC was held, in this regard it is pointed out that in the notification of the Up-gradation of the scale of the post of Assistant from BPS-14 to BPS-16 it is clearly mentioned that the pay scale of the post of Assistant was upgraded with incumbents throughout the Province with the directions that the pay of all the incumbents of the posts of Assistant throughout the Province shall be fixed in the upgraded Pay scale without nolding DPC as it was up-gradation of scale and not up-gradation of the posts. Thus there was no need to place the matter before DPC (copy attached). (Annexure-B)

The posts of Deputy District Sports Officers BPS-16 have been up-graded to the Posts of District Sports Officers BPS-17 without incumbents of the posts for which DPC is necessary as per laid down procedure (copy attached). (Annexure-C)

4. In sub para 3 of the said notification reference of superintendent, Assistants, Senior De true Costill categories is the similar / same as explained in para 3 above.

- Peshawar High Court Peshawar judgment announced on 19-06-2013, Fiance Department upgraded the post of Computer Operator in all the Departments / Offices of the Khyber Pakhtunkhwa and the incumbents took the charge without DPC / seniority. In this regard it is clarified that in the said notification of Finance Department clearly mentioned that the Pay of the incumbents will be fixed in the next higher Pay scale. As such there was no need of DPC. But in the case of Deputy District Sports Officers and District Sports Officers no such clarification was issued by the Finance Department (Copy attached). (Annexure-D)
- 6. In sub-Para 7 of the said Notification it is stated that in the joint seniority list for promotion to the posts of Deputy Directors / Regional Sports Officers (BPS-18) Mr. Amjad Iqbal & Shakeel Ahmad had to be in the list of Assistant Directors (BPS-17) for being eligible to be in the list. Both the officers entered in to the list on 28-05-2019 while other officers on 08-03-2018.

In this regard it is stated that Mr. Amjad Iqbal & Shakeel Alumad entered in to seniority list of Assistant Directors for Promotion to the post Deputy Directors / Regional Sports Officers through legal and regular process of DPC while the others officers (District Sports Officers) only took charge and avail all benefits of BPS-17 illegally because after the up-gradation of the posts of Deputy Districts Sports Officers BPS-16 to District Sports Officers BPS-17 DPC was required but no DPC was held for the up-graded post of Deputy Districts Sports Officers BPS-17.

In View of the above submission it is clear that the District Sport Officers in the Seniority List from No.9 to 16 are still BPS -16 and availing all benefits of BPS -17 without any legal procedure and they are still junior to me because I was promoted regularly through legal process of DPC on 28-05-2019.

Keeping in view the above clarification / justifications it is requested that necessary correction in the seniority list may kindly be made and my due right may be given to me.

Kindly refer to your letter No. SO(Sports)1-41/Seniority list/2023/3840-43, dated 6th April 2023 on the subject noted above and to submit the requisite replies to the observations raised by the Establishment Department:

- Copy of Directorate General of Sports letter No. 17/Seniority List/2021/5051-54, dated 16-08-2022, whereby the tentative seniority list was circulated is attached as Annex-A.
  - The appeal of Mst Nazia Zaki, Assistant Director, Directorate of Sports merged areas is against the procedure and not considerable because she was required to submit the same through the Administrative Department. As regards the exclusion of her name from the tentative seniority list, a committee was constituted by the Sports Department vide Notification dated 21-12-2018 (Annex-B) for the settlement of issues arising out of the merger of the Directorate of Sports merged areas. A meeting of the committee was held on 02-11-2022. It was explained that the Directorate of Sports of the erstwhile FATA was initially a subsidiary office of the erstwhile FATA Education Department Chyber Pakhtunkhwa. Some employees were appointed under the Federal Governament scheme FATA Sports Projects on contract basis from the year 2007 to 2010. Later on, the Finance Divisor Government of Pakistan through the Education Department created various categories of posts for the establishment of the Directorale of Sports erstwhile FATA. The employees of Directorate of Sports merged areas submitted appeal for obsorption / adjustment in Sports Department Khyber Pakhtunkhwa against regular post. The case was refferd to the Establishment Department for advice. The Establishment Department Khyber Pakhtunkhwa clarified vide letter No. SOR-1(ESAD)4-1/2018 dated 09-09-2020 (Annex-C) that the issue regarding abosorption and subsequent determination of senority of employees of erstwhile FATA Sports Directorate comes in the ambit of surplus pool policy 2001. It is added that Finance Department created posts for the Directorate of Sports merged areas and aflowed budget under a separate DDO code delegated under the post of Director Sports merged areas for 10 years, Moscover, the merger of erstwhile EXTX is meant for the integration of the area while not thut of the services of the precument servants in any capacity of their services.

No policy guidelines have been issued by the Provincial Governament so far in this regard: Hence the absorption of the employees of erstwhile FATA in the Directorate General of Sports Kliyber Pakhtunkhwa will create agonies for the employees of the Directorate of Sports and will lead to litigation. Minutes of the meeting of the committee are at Annex-D. A detailed report was submitted to the Administrative Department vide letter dated 13-12-2022 Annex-E. Subsequently, the usue was discussed in a formal meeting held in the office of Additional Secretary Sports in which it was agreed to exclude the name of Mst Nazia Zaki, Assistant Director Directorate of Sports merged areas from the tentative seniority list based on facts mentioned in the minutes of the meeting of the committee as well as in the letter of Directorate of Sports as referred to above (Annex-D and E).

Copy of the judgment dated 22-03-2018 passed by the august Peshawar High Court at Annex-F. In pursuance of the said judgment, Finance Department created supernumerary posts vide letter dated 13-09-2022 Annex-G. As regards, the rejection of observations raised by Mr. Amjad lqbal and Mr. Shakeel Ahmad, it is pointed out that the officers at S.No. 08 to 15 of the tentative seniority list had taken the charge of the upgraded posts (that is DSO BS-17) on 08-03-2018, while Mr. Amjad lqbal and Mr. Shakeel Ahmad were promoted to the equivalent posts of AD BS-17 on 28-05-2019, hence it is equivalent to charge the established right of seniority of Senior Officers. Therefore, the objection/observation raised by the above Officers was declared baseless in the meeting held in the office of the Additional Secretary Sports Department taking based on taxts/records.

The said tentative list was circulated so many times and after considering objections, the same has now reached finality.





The following discrepancies are also brought into the notice:-

- 1. The subject tentative seniority list was issued on1-5-2020 for the year 2020 and Objected to it dated 22-06-2020(annexure-A).
- 2. In the light of the sports department notification No. SO(sports)1-41/2020/2913-16 dated 10-9-2021, directorate GENRAL of sports of sports issued the said seniority list Vide letter no. 17/seniority list/2021 dated 15-9-2021(annexure-B) and I again objected to it dated 28-9-2021(annexure-C).
- 3. Now the subject seniority list has been issued for the third time vide No.17/seniority list /2021/5051-54 dated 16/08/2022. My objections are still same as already raised two time previously mentioned at serial Nos.1 & 2 above.
- 4. In the first seniority list the name of Miss Nazia zaki was not included as she do not belong to cadre but her name has been included in the seniority list issued second time on 15/9/2021 which is not understood. Her name therefore be removed from the seniority list.
- 5. For the 4<sup>th</sup> time the seniority list stood on 18-01-2023 issued without circulating among the officers and an undisputed certificate was issued and submitted for finalization of Secretary Sports on 27-01-2023(annexure-D).
- 6. Tobjected on 17-03-2023.(annexure-E)

And after all the above process I have not found any reply and then I knocked the door of the court and filed a Service appeal before the service Tribunal Peshawer on 17-06-2023, and 21-00-2023 date is fixed for hearing.(annexure-F)

#### Preliminary objections

- 1. Final or tentative seniority list must be approved by competent authority and issued under his signatures/ stamp. In our case it has not been done.
- 2. No O&M study has taken place for merger where some posts would be abolished, some rename some upgraded and recreated.
- 3. Officer at SL NO 1 has been shown recruited on initial appointment which is not true as initial recruitment in BPS-17 is only possible through Public Service Commission and in the instant case no such recommendation letter from Public Service Commission is available.

#### <u>Details</u>

It is added that the former FATA sports directorate a subordinate office of the former FATA education directorate has not been absorbed/merged in the DIRECTORATE GERNAL OF SPORTS Khyber PAKHTUNKHWA but in the new tentative seniority list, the name of Ms maia zaki and some other officers of the former FATA education directorate has been included which is against the rules.

It is further added that neither the DIRECTORATE GERNAL OF SPORTS restructured over the former SPORT DIRECTORATE, a subordinate office of the former FATA directorate, merged with the DIRECTORATE GERNAL OF SPORTS Khyber PAKHTUNKHWA. Actually, the staff of the former FATA Sport, were the employees engaged under a project of the former FATA educate of so, it is humble requested that those officers may be adjusted in their parent department and exclude them form out seniority.

It is pertinent to mention that the Directorate of Sports Marge areas is still volving independently/separately without any actual merger of services and budget in the Director ne General of Sports while the merger of erstwhile FATA is meant for the integration of the area while not that of the services of the government servants working in any capacity of the services, regular/ project / contract basis.

It is to further clarified that the post created for the posting the services of such employees (regular/contract /project) are created under the separate DDO code entristed /delegated under the post of Director Sports Merged Areas, so there are not drawing their salaries from Director General Sports Khyber Pakhtunkhwa, which further delineate / illustrates that the erstwhile FATA sports. Directorate is not yet merged in the Directorate General of Sports Khyber Pakhtunkhwa, then no question of inter-se-seniority emerges at this time and is pre-mature while such matter are not yet decided by the Establishment Department. The is further stated that those post of the erstwhile FATA directorate are not covered under existing service rules of the Directorate General Of Sports Khyber Pakhtunkhwa which seemingly on at is an anomaly in itself. In inter-se-seniority.

In this regard reference to the Establishment & Administration Department invariable Pakhtunkhwa letter NO.sor-1(E&AD)-1-1-2018 dated 09-09-2020 addressed to secretary mosts regarding the appeal or absorption/ adjustment of regular employee of erstwhile FATA sports

Directorate in the sports department Khyber PAKHTUNKHWA against regular position is in and where it is mentioned that the issue of absorption & subsequent determination of seniodic of employee of EX-FATA. Directorate of Sports come under the ambit of surplus pool policy of and the establishment department further states that the sports department need to follow the same in the true spirit.

Similarly objection/ observation against the officers from S#. 8 to 15 is also given below :-

The post of deputy district sports officers BPS-16 have been up-graded in the posts of district sports officers BPS-17without mentioning incumbents of the post for which DPC is necessary as per laid down procedure, these officers (district sports officers) only took charged and availed all benefits of 869-17 illegally because after the up-gradation of the posts of the deputy districts sports officers BPS-16 to districts sports officers BPS-17 DPC was required out no DPC was held for the up graded post of deputy districts sports officers BPS-17

In view of the above submission, it is clear that the assistant director at slice and others from merged tribal districts are not eligible to be represented in the seniority list value district sports officers from S# 8 to 15 of the seniority list are still in BPS-16 and available benefits of BPS -17 without any legal procedure and they are still junior to me and as it is requested that necessary correction in the seniority list may kindly be made my due right may be giving to me.
