

The appellant may kindly be placed in intermediate college course list "D" in between the name names of his Colleagues ASI Kashar Khan District Dir Lower and ASI Sajid Ali District Swat. In case, if this appeal is pending before this August Tribunal or before any decision by this August Tribunal the ASI Sajid Ali District Swat or any other junior ASI is promoted to the post of SI, the appellant may kindly be promoted to the post of SI, and the appellant may kindly be graciously granted Seniority as per Seniority of the appellant.

Any other remedy not specifically asked in this appeal and the appellant is entitled may kindly be given.



Respectfully Sheweth:

**BRIEF FACTS LEADING TO THE INSTITUTION OF INSTANT APPEAL ARE GIVEN AS FOLLOWS:-**

- 1) That the appellant was appointed as constable vide order dated 04-01-1993 in the Swat KPK Police and the appellant has performed his duty to the best of his ability and honesty since the day one first due to efficient performance the appellant, on completion of different department course the appellant passed intermediate college course in 2008 from Police training College Hangu. While coming in serial No. 3 at the relevant course. The appellant was included in list "D" head constable and promoted through order No. 5131-37E dated 18-11-2008. (Copy of the order dated 18-11-2008 is attached as annexure "A")
- 2) That the appellant performed his duties punctually, regularly and efficiently and kept unblemished record.
- 3) That due to insurgency period in Swat District the appellant took tow days leave and want to safeguard his family members the appellant carried his family to some safe place i.e., District Peshawar due to the threat of Taliban. The appellant was on the way back to join his duty but meanwhile the curfew was announced and there was no chance for appellant to come to Swat and join his duties. The appellant was absented from duty and was dismissed from his service without proper inquiry due to appellant unintentional absence from duty.

- 4) That this august Tribunal announced its judgment on 27-04-2010 to make fresh inquiry about appellant unintentional and willful absence from duty. The inquiry officer after fresh making inquiry came to the conclusion that the appellant has good service record. The family members of the appellant have been martyred and the appellant is currently fit for service.

(Copy of inquiry report is attached as annexure "B")

- 5) That on the basis of the above mentioned inquiry the Respondents No. 2 through his order dated 30-11-2010 converted the unintentional absence of the appellant into leave without and reinstated the appellant to his post along with other Police persons. (Copy of order dated 30-11-2010 is attached as annexure "C")

- 6) That after reinstatement the appellant name was already included in list "D" Head constable for promotion to the post of ASI at serial No. 42 on the said list the appellant attended the office of Respondent No. 2 on 02-03-2011 for the sake of DPC. The appellant was deprived on order dated 21-04-2011 from said DPC due to non-availability of the ACR of the appellant for the year 2009, 2010. The appellant was deferred in the said DPC while Junior Head Constables were awarded promotion to the post of ASI. (Copy of order dated 21-04-2011 & 08-04-2011 are attached as annexure "D" & "E" respectively)

- 7) That the appellant filed departmental application / appeal before Respondent No. 1, who ordered the Respondent No. 2, the case within of the appellant in the next DPC. (Copy of order of Respondent No. 1 is attached as annexure "F")
- 8) That next DPC on 05-10-2011 the appellant again appeared before Respondent No. 2 for promotion to the post of ASI and inclusion the name of the appellant in the DPC. The appellant was differed on 11-10-2011 for next DPC subject to prediction satisfactory and efficient ACR for in the year 2011. (Copy of the office order dated 11-10-2011 is attached as annexure "G")
- 9) That the appellant was deprived from his due rights while junior head constables were promoted to the post of ASI. Those ASI have no ACR for the year 2011 and they were fresh comers from intermediate Course having no practical experience or any ACR for the year 2011 at the time of DPC. (Copies of the relevant record is attached as annexure "H" & "I" respectively)
- 10) That on dated 18-01-2012 the appellant appeared in the third DPC and Respondent No. 2 promoted the appellant to the post of ASI on the basis of two years probation period through order dated 13-02-2012. (Copies of order dated 13-02-2011 is attached as annexure "J")

- 11) That the appellant completed two years probation & awarded grade A in ACR of the year 2011,2012,2013, therefore the appellant filed an application for the grant of seniority & confirmation in list "E". (Copy of application is attached as annexure "K")
- 12) That the appellant completed the two years probation period and during that period the appellant ACR for the year of 2011, 2012, 2013 were in grade A therefore the appellant was confirmed in list "E" at serial No. 163 due to efficient performance and good ACR. (Copy of confirmation letter ~~23~~ 28-05-2014 are attached as annexure "L")
- 13) That the Respondent No. 2 did not provide seniority to the appellant, while confirmed the promotion order of the appellant in the list "E" confirmation order dated 11-06-2014. (Copy of order is attached as annexure "M")
- 14) That the Respondent No. 2 gave / granted promotion who seniority to some other ASI who were not able to produce good ACR at the time of previous DPC and promotion. (Copies of orders of Junior ASIs who were given promotion + seniority are attached as annexure "N")
- 15) That on 04-07-2014 the appellant filed departmental application / representation before Respondent No. 1 on the basis of above mentioned facts. (Copy of appeal dated 04-07-2014 is attached as annexure "O")

- 16) That the Respondent No. 1 sent the departmental appeal of the appellant to Respondent No. 2 for comments. The Respondent No. 2 sent the same appeal to DPO Swat who sent the same to establishment clerk and DSP Legal for further necessary actions. (Copy of order is attached as annexure "P")
- 17) That DPO Swat through DSP Legal through letter N. 15436-E dated 30-09-2014 commented and filed no objection on the seniority of the appellant. Similarly the establishment clerk also given the same opinion. (Copies are attached as annexure "Q" & "R" respectively)
- 18) That the Respondent No. 2 on dated 23-10-2014 through letter No. 8661-E sent his comment to Respondent No. 1 for further necessary action. (Copy of letter is attached as annexure "S")
- 19) That after completion of the inquiry comments and proceeding of the Respondents the appeal of the appellant is still pending in the office of Respondent No. 1.
- 20) That ninety days have been elapse but the Respondent No. 1 has not decided the appeal of the appellant, therefore along with so many other grounds the appellant file the current appeal before this August Tribunal on the following grounds.

Grounds of Appeal:-

- i) That the above mentioned order is illegal, against the Govt. policy and justice.
- ii) That the Impugned orders are against the law, rules & natural justice.
- iii) That on letter No. 1014-16 dated 30-11-2010 on which the appellant was reinstated and the absence was considered leave without pay. Furthermore at the same order at serial No. 2 & 76 were also consider on leave without pay. Similarly at serial No. 2 & 76 Mian Said Rahman Head Constable No. 582 & Mr. Bakhtullah Head Constable No. 92 were immediately sent for intermediate course and were given promotion to the post of ASI.
- iv) That in DP 29-05-2014 and order dated 11-06-2014 by Respondent No. 2 Mr. Sahib Gul ASI was promoted as at SI serial No. 1 and was also given / awarded seniority. The name of Sahib Gul was in listed among the names of his colleagues Mr. Habib-ur-Rahman SI and Mr. Muhammad Rahim SI.
- v) That according to police rules there is no probation period for list "D" of Head Constables to the post of list "D" ASI.
- vi) That the previous carrier / service of the appellant is unblemished, while the unintentional absence of the appellant was considered leave with out pay.

- vii) That according to the rules regulation of the department the appellant ACR were supposed to be maintained and kept secret by respondent themselves, therefore it was not the duty of appellant to provide ACR to respondents for promotion to the post of ASI.
- viii) That the appellant was illegally and against the rules & regulation differed from promotion while junior head constables were promoted to the post of ASI.
- ix) That equal protection of law and equal treatment is the basic right of the appellant. The respondents have given seniority to some other ASI while, deprive the appellant from his due right.
- x) That the respondent No. 1 consider the case of the appellant in next DPC which is based on gross illegality.
- xi) That if the appellant was not given previous seniority then the appellant would face irreparable loss due to over-age and would not be able to receive upper college course.
- xii) That as per seniority of the appellant, the appellant must be sent for the training of upper course like other ASIs.

- xiii) That there is no fault of the appellant in the entire service carrier but the respondents through lame excuse and fault of their own had deprived the appellant from promotion & seniority.
- xiv) That if the appellant was not awarded promotion with all back benefits and seniority the appellant may suffer irreparable loss.
- xv) That the appellant will not be able to be promoted in coming entire service which is a permanent loss to the appellant.
- xvi) That the respondent No. 2 made appellant to wait for next DPC without any reason.
- xvii) That as the appellant was on two years probation period therefore the appellant was compelled ~~application/ appeal~~ to file any departmental representation till finalization of probation period.
- xviii) That the appellant was not given any opportunity of personal hearing.
- xix) That the appellant case is very much similar to those ASIs, who have been awarded seniority along with promotion, therefore, the appellant is entitled for same treatment because it is the principles of law and natural justice that equal should be treated equally and no discrimination be done with the appellant.



- xx) That the further grounds, with leave of this Honorable Court, would be raised at the time of arguments.

**PRAYER**

In view of the above submissions, on acceptance of this appeal the appeal / representation of the appellant dated 04-07-2014 may kindly be allowed with all back benefits and may kindly be placed in the seniority list "D" on the basis of DPC dated 02-03-2011. The appellant may kindly be placed in intermediate college course list "D" in between the name names of his Colleagues ASI Kashar Khan District Dir Lower and ASI Sajid Ali District Swat. In case, if this appeal is pending before this August Tribunal or before any decision by this August Tribunal the ASI Sajid Ali District Swat or any other junior ASI is promoted to the post of SI, the appellant may kindly be promoted to the post of SI, and the appellant may kindly be graciously granted Seniority as per Seniority of the appellant.

Any other remedy not specifically asked in this appeal and the appellant is entitled may kindly be given.
