filed even after couple of years) after their appointments with no condonation of delay, rendering all these not maintainable. When the departmental appeal has been filed beyond the period prescribed in Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974, then appeal before this Tribunal becomes not maintainable. Reliance is placed on 1995 SCMR 1505 titled "Anwarul Haq v. Federation of Pakistan", PLD 1990 SC 951 titled "Chairman, PIAC v. Nasim Malik" and 2004 SCMR 1426 titled "State Bank of Pakistan v. Khyber Zaman & others".

11. Therefore, all the appeals are dismissed. Costs shall follow the event. Consign. Copy of this order be placed on files of all connected service appeals. Consign.

> 8. Admittedly, there is no original or appellate order passed by any authority, from which the appellants could be said to be aggrieved of. Even if we consider their contention that they were never paid salaries since their appointments and the alleged nonpayment/non-release of salaries since the appointment of the appellants was the original order, then the fact that the appellants filed departmental appeals in 2021 i.e. much after the time provided in Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974 could not be controverted by the appellants.

> 9. The request of the learned counsel for the appellants for sending the matters to the Appellate Authority cannot be considered in view of the judgment of the Supreme Court of Pakistan reported as 2023 SCMR 1087 titled "Dr. Sayyid A.S. Pirzada Vs. The Chief Secretary, Services and Administration Department and others" wherein, the Supreme Court of Pakistan was pleased to found as under:

"7. We, therefore, hold that once the appeal, application of review or representation, as the case maybe, of a civil servant is not decided by the departmental authority within a period of 90 days and he has elected to approach the Tribunal through preferring an appeal after lapse of that period, then his appeal has to be decided on merits and the Tribunal cannot dispose of that appeal by issuing direction to the departmental authority to decide the appeal, application for review or representation of the appellant, because the said remedy already stands exhausted by virtue of the lapse time."

10. All the departmental appeals have been filed after lapse of statutory period of thirty days as required by the Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974, (some were

3. Prayer of all the appellants in these cases is the same, that on acceptance of these appeals, the respondents might be directed to release monthly salaries of the appellants w.e.f respective dates of their appointment till date, with all consequential benefits.

4. Appellants' cases in brief are that they were appointed on different dates (given in the respective appeals) in the Health Department. According to the appeals the appellants were performing duties but their salaries were stopped from different dates (mentioned in their respective appeals). They filed departmental appeals on different dates but those were not responded, hence, these service appeals.

5. The department was provided a number of opportunities to file replies but it did not. Therefore, it was placed ex-parte.

6. Today, the learned counsel for the appellants made a simple request that as the appellate authority had not decided the departmental representations of any of the appellants, therefore, all the matters might be sent to the Appellate Authority to decide the departmental representations of the appellants.
