JUDGMENT

ATIQ-UR-REHMAN WAZIR MEMBER (E):- Brief facts of the case are that upon the recommendations of Public Service Commission, the appellant was initially appointed as Lecturer (BPS-17) vide order dated 15-10-1992, who later on was promoted as Assistant Professor (BPS-18) vide order dated 01-01-2010. During the course of his career, the appellant applied through proper channel to the post of Registrar (BPS-20) in Abdul Wali Khan University Mardan (AWKUM) and the appellant was selected and appointed as registrar for a period of three years vide order dated 19-08-2014. The appellant submitted request to the respondents to relieve him of his post to join his new assignment,

which however was regretted, instead the appellant was asked to submit resignation from the post of assistant professor. The appellant again requested for retention of his lien or counting his service under section-418 of the Civil Service Regulations (CSR), which too was not acceded to, hence the appellant tendered his resignation on 10-10-2014, but when the appellant came to know that the post of registrar is a tenure based post, hence he requested again on 27-05-2015 for conversion of his resignation into a request to relieve him from service in order to join new assignment, but in the meanwhile his resignation was accepted vide order dated 08-06-2015, against which the appellant filed departmental appeal dated 30-062015 for withdrawal of his resignation or confirmation of his pension for the services he rendered in the respondents department, but his appeal was rejected vide order dated 01-12-2015, hence the instant service appeal with prayers that the impugned orders dated 08-06-2015 and 01-12-2015 may be set aside and resignation so tendered may be allowed to be withdrawn or in alternative, the appellant having rendered more than 20 years of service be allowed pension for the service rendered.

O2. Learned counsel for the appellant has contended that the appellant has not been treated in accordance with law and his rights secured under the law has been violated; that before acceptance of resignation, the appellant has virtually withdrawn his resignation, but was not considered by the respondents, which is against law and norms of natural justice; that the appellant has at his credit more than 20 years of service, however, the respondents rejected departmental appeal of the appellant, hence his long and spotless service has been washed out, inspite of the fact that under the law he is entitled either to have count his service for the purpose of pay and pension or at least he should have been allowed pension for the service he rendered in the Higher Education Department; that the respondents illegally insisted for resignation, despite the fact that the appellant

was entitled to retain his lien over his post or to have been allowed deputation; that case of the appellant is covered under section-418 of CSR.

- O3. Learned District Attorney for the respondents has contended that upon his selection as Registrar, the appellant was required either to submit resignation from the post of Assistant Professor or to quit the job of registrar and continue with his job; that the appellant opted to submit his resignation and quit the job of Assistant Professor, now he cannot opt to withdraw his resignation; that university is an autonomous body and any civil servant who wants to join the autonomous body, will have to resign from his previous job, hence request of the appellant for relieving was regretted and his resignation was accepted by the competent authority; that it is prerogative of the government to accept or reject the resignation.
- 04. We have heard learned counsel for the parties and have perused the record.
- 05. Record reveals that the appellant was properly granted NOC for applying to the post of Registrar and upon his selection as Registrar in Abdul Wali Khan University Mardan (AWKUM) vide order dated 19-08-2014, the appellant placed a request dated 25-10-2014 to the respondents to relieve him either on deputation or retaining his lien in his parent department in order to join his new assignment, but the appellant was compelled to tender resignation from the post of Assistant Professor. The appellant though was hesitant but finally tendered his resignation on 10-10-2014. The appellant assumed the charge as registrar on 17-11-2014 and after taking over charge, it transpired that the post of registrar is a tenure based post only for the period of three years, hence he submitted an application to consider his resignation as withdrawn, but his request was declined vide order dated 17-06-2015, but in the meanwhile his resignation was accepted vide order

dated 08-06-2015, against which the appellant filed departmental appeal dated 30-06-2015, which was rejected vide order dated 01-12-2015.

Placed on record is a letter of Administration Department dated 03-10-06. 1989 containing instructions that resignation tendered by a Government Servant shall either be accepted or rejected by the competent authority within the stipulated period of not more than 30 days of it submission and acceptance/rejection thereof be communicated to the Government Servant concerned accordingly, but in case of the appellant, his resignation was accepted after lapse of almost eight months, which is contrary to the instructions circulated by the provincial government. Placed on record is another letter dated 24-12-1959 of Administration Department containing instructions regarding resignation that where a government servant who has tendered resignation, withdraws it before it is accepted by the competent authority, or where after the acceptance but before the acceptance is communicated to him, he is allowed to withdraw the resignation. It was noted that the appellant requested for withdrawal of his resignation on 27-05-2015 well before acceptance of his resignation dated 08-06-2015 and as per instructions circulated by administration department vide order dated 24-12-1959, the appellant was entitled to withdraw his resignation before its acceptance, but the respondents illegally accepted his resignation in haste without taking into consideration his pending request for withdrawal of his resignation. In the judgment reported as 2003 PLC (CS), 1535 it has been held that ESTA CODE, Edition (1989) clearly mentioned that in case Civil Servant makes withdrawal of his resignation before the same was accepted by the competent authority, resignation would be deemed to have been withdrawn. In other judgments reported as 2015 PLC (CS) 337 and 1984 PLC (CS) 435, it has been held that resignation could be withdrawn or recalled before its acceptance by the competent authority, whereas the appellant had also requested for withdrawal of his resignation, but such request of the appellant was not

considered positively by respondents, which however was not warranted and on this score alone, the impugned orders are liable to be set at naught.

- 07. We have also noted that the appellant in his departmental appeal alleged his resignation not to be voluntary, but he was forced to do so and to this effect, august Supreme Court of Pakistan in its judgment reported as 2005 SCMR 1194 has declared such action of the respondents as illegal. Last but not the least, section-418(b) states that resignation of an appointment to take up another appointment, service that counts, is not a resignation of the public service, so in view of section-418(b) of CSR, the resignation so tendered cannot be termed a resignation in real terms and depriving the appellant from benefits of his long service would not be in accordance with the canons of law.
- 98. We are of the considered opinion that the appellant having more than 20 years service at his credit cannot be ousted for technical reasons, as the appellant submitted his application for withdrawal of his resignation well before its acceptance, but his request was illegally rejected. Most importantly, the appellant was properly granted NOC by the respondents for joining his new assignment and in view of granting such NOC, the respondents were required to grant him either deputation or retaining his lien against his original post, which however was not done by the respondents. The appellant was denied fundamental right of due process as guaranteed under Article-10-A of the constitution.
- O9. In view of the foregoing discussion, the instant appeal is accepted. Impugned orders dated 08-06-2015 and 01-12-2015 are set aside and resignation of the appellant stands withdrawn and service of the appellant as Assistant Professor (BPS-18) is restored without back benefit with observations that period during which he remained as Registrar would be treated on duty against leave accrued, if any, or leave without pay for the purpose of his length of service and

future benefits. Parties are left to bear their own costs. File be consigned to record room.

Respectfully Submitted:

- 1. That the appellant was initially appointed in the Higher Education Department as Lecturer BPS-17 on the recommendation of Public Service Commission on 15.10.1992.
- 2. That during the course of his service the appellant was promoted as Assistant Professor BS-18 on 01.01.2010.
- 3. That while serving in the capacity of Assistant Professor, the Abdul Wali Khan University Mardan (hereinafter to be referred as AWKUM) vide advertisement NO. 40/2013 advertised different posts including the post of Registrar BS-20 on regular basis. (Copy of advertisement is attached as annexure A).
- 4. That the appellant applied through proper channel to the respondent NO. 5 for the post of Registrar BS-20, as per requirement of law he obtained departmental permission/ NOC before applying and submitted the same along with the application. (Copies of the application form and NOC are attached as annexure B&C).
- 5. That the appellant was duly considered by the Selection Board and recommended for appointment, the syndicate of the AWKUM approved the recommendation of the selection board and accordingly the appellant was appointed as Registrar BS-20 vide office order dated19.08.2014. Vide office order dated 22.08.2014 a corrigendum was issued appointment as Registrar BS-20 was made for a period of 3 years. (Copies of appointment letter & corrigendum are attached as annexure D & E).
- 6. That the appellant submitted his arrival report in the AWKUM on 20.08.2014, and took Charge of the post on 17.11.2014, duly acknowledge vide letter dated 17.11.2014. (Copies of the letters dated 20.08.2014 & 17.11.2014 are attached as Annexure F & G)
- 7. That on his appointment as Registrar in AWKUM, the appellant requested the respondent Govt for relieving him of his post to join the new assignment, however it was regretted and instead the appellant was directed to submit resignation. (Copies attached as Annexure H)
- 8. That since the AWKUM was considering the post of Registrar BS-20 as tenure post, hence the appellant took up the matter with the respondent department allowing him lien or counting of his service

under 418 Civil Service Regulations, however the department was insisted to resign before joining, hence he submitted resignation on 10.10.2014. (Copies of the resignation & correspondence with the department are attached as Annexure I & J).

- 9. That in the meantime when the appellant sensed that the AWKUM University Service is tenure based besides the HED vide their action are completely vanishing his past service hence he vide letter dated 27.05.2015 requested that his resignation be considered as a request for relieving him from service in order to join his new assignment. However quite illegally letter No. SO (Colleges) HED /13-9/2010 dated 8.06.2015 communicated on 30.06.2015 accepted the resignation of the appellant. (Copies of the letter dated 27.05.2015 & 08.06.2015 are attached as K&L
- 10. That the appellant submitted his departmental appeal dated 30.06.2015 for withdrawal of his resignation or confirmation of his pension for the service he rendered in the respondent department. However the appeal was finally regretted vide letter dated 01.12.2015. (Copies of the departmental appeal and rejection order are attached as Annexure M & N).
- 11. That the Orders impugned are illegal, unlawful, without lawful authority, hence this appeal inter alia on the following grounds:

Grounds of appeal:

- A. That the Appellant was not been treated in accordance with law, and his rights secured and guaranteed under the Law and Constitution has been violated.
- B. That before acceptance of resignation vide letter dated 27.5.2015, the appellant has virtually withdrawn the application for resignation, when he requested that his request for resignation may be considered and read as "Relieving from service in order to join his new assignment at AWJUM w.e.f 10.10.2014 afternoon".
- C. That the appellant has at his credit about more than 20 years of regular pensionable service, however, vide the rejection of the departmental appeal his long and spotless service career has been washed out, though under the law he is entitled to either have count his service for the purpose of pay and pension or at least he should have been allowed pension for the services he rendered to the Higher Education Department.

- D. That infact at the time when he initially applied for the issuance of relieving order to join the new assignment as Registrar BS-20 AWKUM, however, quite illegally it was insisted that the appellant has to resign before joining the new assignment, similarly while submitting resignation he was under the impression that the services in the AWKUM as Registrar is regular and pensionable, when it later transpires that it was a tenure post, he forthwith submitted application for treating the resignation as a request for relieving him from service, having done so the respondents were having no authority to have issued the acceptance of resignation and by doing so they acted illegally and in violation of law.
- E. That the case of the appellant is covered under the provisions of 418 of the Civil Service Regulations even if it is accepted that the appellant has resigned from service for the sake of convenience the relevant provision is reproduced:-
 - "418. (a) Resignation of the public service, (or dismissal) or removal from it for misconduct, insolvency, inefficiency not due to age, or (failure to pass a prescribed examination entails forfeiture of past service.
 - (b) Resignation of an appointment to take up another appointment, service in which counts, is not a resignation of the public service."
- F. That the Appellant seeks the permission of this Honourable Court to rely on additional grounds at the hearing of this appeal.

It is, therefore, humbly prayed that on acceptance of this appeal, the appeal as prayed for in the heading of this appeal may be accepted.



The meeting started with recitation of verses from the Holy Quran by Mr. Farhad Safi, Lecturer, Department of Journalism & Mass Communication, AWKUM. The Chair welcomed the participants and thereafter proceedings of the meeting commenced.

The Secretary, Syndicate presented the agenda items and discussion/decisions took place as following:

Agenda item No.1: Confirmation of the minutes of the 11th meeting of the Syndicate

The minutes of the 11th meeting of the Syndicate, held on February 9, 2015, were placed before the house for confirmation.

Discussion:

The agenda item was placed before the house for confirmation. The Registrar explained that the minutes were recorded, circulated, distributed and authenticated as per Rules of the Business of the Syndicate. The authenticated minutes of the 11th meeting of Syndicate are required for confirmation from the August House.

Special Secretary HED questioned the status of Statutes with reference to letter of Governor's Secretariat. The Vice Chancellor explained that observations raised by the Governor's Secretariat regarding the Statutes were discussed in the Senate in its 7th meeting held on June 30, 2015. He added that as per Rules of Business of the Senate, the proceedings are recorded by the Registrar of the university (Secretary, Senate) and are circulated among the members for comments for any discrepancy between the recorded proceedings and decisions taken in the meeting. He added that no observations from any member were received to the Secretary within stipulated time of fifteen days.

The Vice Chancellor made it clear that after confirmation of the authenticated copy of the minutes of 6th meeting of Senate, the matter has been resolved. He further added that the Secretary, HED, however, raised some objections about the same in the 7th meeting of the Senate held on June 30, 2015, which is yet to be received in this office in writing. The Special Secretary

was of the view that the matter shall be placed before the Chancellor through Higher Education Department for clarification.

Mr. Aziz Khan Khattak, Special Secretary Establishment, Prof. Dr. Syed Sakhawat Shah, Nominee of HEC and Engr. Ejaz Yousafzai clarified that as a matter of routine, minutes of the previous meeting are confirmed in the ensuing meeting of the house.

Decision:

After in-depth discussion, the house unanimously confirmed the minutes of the 12th meeting of the Syndicate.

Agenda item No.2:

Action taken in pursuance of the decisions on the 11th meeting of the Syndicate

Mr. Abdul Ghafoor Baig, Special Secretary, HED once again questioned the status of the Statutes. The Vice Chancellor informed that agenda item has already been approved by the Syndicate and is reported as a matter of compliance.

Prof. Dr. Syed Sakhawat Shah, Nomince of HEC pointed out that PhD degree holders may be appointed on Tenure Track System only, once the university approves HEC Statutes for TTS.

Dr. Zahid Hussain, Principal UCSS explained that it is a common practice in most of the universities, that they adopt follow HEC guidelines as well as their own Statutes. He quoted Quaid-e-Azam University, Islamabad and University of Peshawar as ready reference. Special Secretary HED pointed out that the university Statutes are made under Act i.e. law, whereas HEC has guidelines/recommendations and in the case law will prevail.

The Chair made it clear that criteria for appointment of Teaching Faculty is the same both in AWKUM as well as HEC TTS Statutes.

Decision: After lengthy discussion, the house perused the item and appreciated timely compliance in the decision.

Extension in Study Leave in respect of Mr. Tahir Zeb, Assistant Professor, Department of Physics, UCS Shankar

Decision:

The house looked into the item and unanimously agreed to grant extension in study leave (without pay) for one year commencing from March 1, 2015 on existing terms and conditions as per provision in the Statutes.

Agenda item No.4:

Recommendations of the 8th meeting of the Academic Council

Discussion:

The house considered the agenda item at a great length. Prof. Dr. Syed Sakhawat Shah, Nominee of HEC, pointed that Department of Agriculture should be treated as an independent faculty. The Vice Chancellor explained that Agriculture is a newly launched Teaching Department and with passage of time it will grow both in size and activities and will then be able to emerge as an independent faculty. Mr.—Abdul Ghafoor Baig, Special Secretary, HED raised the question of financial impact in re-structuring of the faculties. The Vice Chancellor asked the Treasurer to explain the financial implication in the budget status. The Treasurer highlighted that the university has a mechanism to generate more than 70 % of its budget. He added that the university is fastly growing and can meet the additional expenditure involved in the establishment and re-structuring of departments and faculties with no financial liability. He further explained that this issue was thoroughly debated in the meeting of F & PC and care was taken for raising our own resources to meet this expenditure.

While discussing the agenda item No. 8 of the Academic Council, Mr. Abdul Ghafoor Baig, Special Secretary HED and Prof. Dr. Syed Sakhawar Shah, Nominee of HEC stated that introduction of new Departments may be based on marketability and availability of the jobs. Special Secretary, HED pointed out that introduction of IR department will not be wise without market survey as the university already has Department of Political Science. Dean Faculty of Arts explained that IR Department is launched on request of Principals of affiliated public sector colleges of the university. He further stated that the teaching staff is already available in the university so it will be in the benefit of the institution to launch Department of IR. Nominee of HEC stated that introduction of new programs must be linked with accreditation from the relevant councils. The Vice Chancellor explained to the house that all of the programs offered by the university have been accredited by the respective council, except the newly launched Agriculture and Animal Husbandry departments, where accreditation is in final stage of approval from the respective Councils and the university has already fulfilled all the pre-requisite in this regard.

Talking on the Agenda item, Special Secretary HED informed the house that the agenda item may be kept pending in the line with Chancellor's directives. The chair explained that the item has already been recommended by the relevant body where it was represented by Dr. Khalid Khan, Additional Secretary, HED. In the 9th meeting of the F & PC held on May 5, 2015, the item was placed for confirmation. Mr. Kaleem Baloch, Deputy Secretary, HED represented HED in the 9th meeting of the F & PC. The Vice Chancellor wanted to know as to how a Deputy Secretary can overrule the decision of Additional Secretary, who too being below the rank of Additional Secretary was unauthorized to attend the meeting. The Vice Chancellor further added that the matter was placed before the Senate in its 7th meeting held on June 30, 2015, where the budget has been approved with zero deficit.

Mr. Aziz Khan Khattak, Special Secretary, Establishment and Prof. Dr. Sakhawat Shah, Nominee of HEC stated that once the matter has been approved by the Senate with zero deficit, then the revised budget estimates may be produced before the Syndicate for perusal. The Vice Chancellor asked the Treasurer to table the revised budget in summarized form with zero deficit as decided in the Senate in its 7th meeting held on June 30, 2015, for perusal of the Syndicate. Discussion:

While discussing the item, Prof. Dr. Syed Sakhawat Shah wanted to know about the procedure followed in agenda item no.1 of the Selection Board i.e. "Transfer of existing faculty from BPS to TTS". The Registrar presented all the relevant documents including evaluation reports of Technical Review Committee.

Dean Faculty of Sciences raised observations in Selection/recommendations in agenda item No. 3 of the Selection Board, where she told the house that being the convener of the Scrutiny committee, she didn't consider the application of Dr. Zahid Hussain for the post of Professor of Chemistry.

The house inquired about the deficiency in the case, to which Dean Faculty of Sciences answered that the applicant didn't sign the application form, the Scrutiny committee didn't consider his case and no subject expert was present in the Selection Board, except Dean Faculty of Sciences herself, where she declined to evaluate the applicant.

The Vice Chancellor explained that after scrutiny of applications, the list of eligible and ineligible applicants is placed on university webpage giving an opportunity to ineligible applicants to lie an appeal. Dr. Zahid Hussain, along with others filed an appeal before the Appellate Committee, against the decision of Scrutiny committee and the Appellate Committee

Islamic Republic of Pakistan. Mr. Shakeel Ahmad and Engr. Ejaz Yousafzai also supported the view point.

Special Secretary Establishment highlighted that Performance Audit is different from Pre-Audit, Internal Audit and Audit conducted by Director General, Audit. He explained that Chartered Accountant really help in streamlining the financial regulations. He further explained that financial audit is different from performance audit and may be allowed. The Vice Chancellor explained that performance audit is done by Higher Education Commission, which has required methodology and trained HR's for it. He further explained that as per provision third party audit is the responsibility of the university. Mr. Ejaz Yousafzai, Dr. Saeed Islam and Mr. Muhammad Zubair termed the third party audit as violation of the Constitution of Pakistan. They opined that performance audit is carried out by HEC and the ranking of the university is determined through performance audit as the HEC has a established accreditation and evaluation sections for this purpose.

Decision/Recommendations:

The house unanimously demanded the Higher Education Department to re-visit the provision in the Act in consultation with HEC and Vice Chancellor of public sector universities through the assembly.

PER PROVISION IN SECTION 14 & 16 OF KHYBER PAKHTUNKHWA UNIVERSITIES (AMENDMENT) ACT, 2015

Section 14 of the Khyber Pakhtunkhwa Universities (Amendment) Act, 2015, provides that:

"(1) The Treasurer shall be appointed by the Syndicate on recommendation of the Selection Board from amongst the candidates with relevant professional qualification and experience and on such terms and conditions as may be prescribed:

Provided that the Treasurer shall not be appointed from the superannuated employees retired from the government / universities service and teaching faculty.

- (2) The experience and the professional and academic qualifications necessary for appointment to the post of the Treasurer shall be such as may be prescribed.
- (3) The Treasurer shall-
 - (a) manage the assets, liabilities, receipts, expenditures, funds and investments of the University;
 - (b) prepare the annual and revise budget estimates of the University and present

them to the Syndicate or a committee thereof for approval and incorporation in the budget to be presented to the Senate;

(c) ensure that the funds of the University are expended on the purposes for


which they are provided;

- (d) have the account of the University audited annually so as to be available for submission to the Senate within six months of the close of the financial year; and
- (e) perform such other duties as may be prescribed.
- (4) The term of office of the Treasurer shall be three years and may be renewed from time to time.



PENSION PROTECTION AND RELATED BENEFITS IN CASE OF MR. SHER ALAM,

REGISTRAR

This has reference to Notification vide No. 1(1)-Reg-1/AWKUM/2014/11229 dated August 22, 2014, wherein the appointment of Registrar (BS-20), AWKUM was made on regular basis. The officer applied against an advertised position through proper channel and the Higher Education Department, Peshawar relieved him off the department vide No. SO(COLLEGES-II)HED/13-9/2010 dated June 8, 2015.

The officer has 22 years and 7 months as regular service at his credit and has requested for protection of pension and related benefits as admissible in Section 186 (2) of the AWKUM Pension Statutes, 2013

"The Statutes shall apply to Former employees of the Federal and Provincial Government who acquired service in the University through proper channel and whose pension contribution is borne by the respective government".

Acceptance of resignation and willful absence for more than five (5) years.

Under the existing practice, even a temporary Government servant is required to sign an undertaking containing inter alia the following provisions:-

- (a) I understand that my employment under Government is temporary and that my services may be terminated by Government at any time, without assigning any reasons, by giving a notice for a period not less than 14 days or payment, in lieu of the notice, of a sum equivalent to my pay for 14 days or for the period by which the notice falls short of 14 days;
- (b) I agree that I wish to terminate my services under Government at any time, I shall resign in writing and shall thereafter continue to serve Government until my resignation is accepted.
- (c) I also understand that if I absent myself from duty without resigning in writing or before the acceptance by Government of my resignation, I shall be liable to disciplinary action, which may involve disqualification from future employment under Government.
- 2. It has however, come to notice that in certain cases Government servants have tendered resignations and without waiting for acceptance have left their jobs unauthorisedly and kept themselves absent for years. The departments on their part failed to initiate any action against such employees in time with the result that they subsequently reported for duty after the passage of long periods on one excuse or the other.
- 3. It has also been noticed that liberal relaxations are being granted under FR.18 in cases of willful absence from duty for more than 5 years without cogent/convincing reasons whereas according to the rules ibid a Government servant remains no more a Government employee after willful absence for five years.
- 4. The matter has been considered and it has been decided that:-
 - (a) After tendering resignation, a Government Servant shall not leave his job until the acceptance of his resignation by the Competent Authority nor shall he be granted any leave. In case one leaves his job without acceptance of his resignation he shall be treated as absender and disciplinary action should invariably be initiated against him.
 - (b) Resignation tendered by a Government servant shall either be accepted or rejected by the Competent Authority within the stipulated period of not more than 30 days of its submission and acceptance/rejection thereof be communicated to the Government servant concerned accordingly.
 - (c) After 5 years of continuous absence, services of a Civil Servant shall automatically stand terminated under FR.18 and Rule 12 of the NWFP Civil

A



Servants Revised Leave Rules, 1981. In the light of Rule 12 ibid, a willful absence of more than five years shall not be converted into leave without pay.

5. It is therefore, requested that the above instructions may be brought to the notice of all concerned for strict compliance in future.

(Authority: S&GAD's letter No.SORII(S&GAD)6(37)/89, dated 3rd Oct.,1989).

Determination of seniority of officials who are allowed to withdraw their resignation

A question has arisen whether a Government servant who resigned and has subsequently been allowed to withdraw his resignation should be assigned seniority and given other benefits which would have accrued to him had he not resigned.

- 2. When a resignation tendered by a Government servant has been accepted and the acceptance has been communicated to him, it becomes final. There can be no question of allowing him to 'withdraw' the resignation.
- 3. Where a Government servant who has tendered resignation withdraws it before it is accepted by the competent authority, or where, after the acceptance but before the acceptance is communicated to him, he is allowed to withdraw the resignation, he continues in the post held by him without a break and the question of re-fixation of his seniority, etc. does not arise.
- 4. Where an appellate authority finds that the resignation was not tendered voluntarily or that it is otherwise null and void, the appellate authority may re-instate the Government servant concerned. On re-instatement the Government servant shall be regarded as having continued in service throughout.
- 5. If a Government servant, whose resignation has been accepted and communicated to him, is appointed to Government service thereafter, such appointment shall be regarded as a fresh appointment. The seniority, pension, leave, etc, of such a Government servant shall be fixed in accordance with the rules applicable to him as if this appointment was his first appointment to Government service.
- 6. There may, however, be cases in which it may not be fair to treat such a re-employed Government servant as a new recruit and it is proposed to give him any benefit in relaxation of the rules, the orders of the Government should invariably be obtained.

(Authority S&GAD letter No.SOXII/2-96/59, dated 24.12.59)

Preparation/issuance of seniority list of Government Servants

I am directed to say that sub-section (1) of Section 8 of the NWFP Civil Servants Act, 1973, inter alia provides that for proper administration of service, cadre or post, the appointing authority shall cause to prepare a seniority list of the members for the time being of such service, cadre or post. Similarly, the note below clause(e) of sub-rule(2) of the rule 6 of the NWFP Service Tribunals Rules, 1974, enjoins upon the appointing authority or any other authority which has been delegated the powers to make decision regarding seniority of

A



a Government Servant to prepare and notify in the official Gazette a list of Seniority of Government Servants under its administrative control. The list so prepared shall be maintained upto date and shall be revised at least once a year. The NWFP Civil Servants (Amendment) Act, 1989, also provides that the seniority list prepared under sub-section (1) of Section 8 (of the NWFP Civil Servants Act, 1973) shall be revised and notified in the official Gazette at least once in a calendar year, preferably in the month of January.

- 2. I am further to say that the Governor, NWFP has been pleased to delegate his powers to Chief Secretary, NWFP to approve the issuance of the Seniority List of the members of a service, cadre or post for which the Governor is appointing authority.
- 3. The above instructions may please be brought to the notice of all concerned for guidance/compliance please.





Respectfully sheweth:

- 1. That the appellant has got no locus standi/cause of action to file the instant appeal.
- 2. That the appellant has not come to this Honourable Tribunal with clean hands.
- 3. That the appellant is estopped by his own conduct to file the instant appeal.
- 4. That the appellant is trying to conceal material facts from the Honourable Tribunal
- 5. That the appeal in hand is bad for non joinder of one of the necessary party like Secretary Finance and Secretary Establishment.

ON FACTS.

- 1. Correct. Hence no comments.

- 7. Incorrect. That the appellant on selection and appointment took over the charge of the post of registrar BPS 20 in Abdul Wali Khan University Mardan (AWKUM). Before joining his service, he was required to submit his resignation from the post of Assistant Professor in the Higher Education Department and he submitted his resignation and it was accepted by the competent authority. The appellant had the option either to resign from the service of Govt. of Khyber Pakhtunkhwa, higher Education Department and than join the university service or not join at all the university service and thus continue his services as Assistant professor in the higher Education Department. But the appellant opted for the university service. Now he cannot turn around other ways and now he cannot be allowed to make a volte –face.
- 8. As explained in the proceeding paras the appellant had two options either to join the service of university as registrar or sacrifice his past 22 year service as assistant professor. He opted for the former i-e University Service.
- 9. The appellant is a well matured person possessed of enough intelligence to make selection of either of the two options already explained. In order to join his service in the university as Registrar, he had submitted resignation from service to Secretary Higher education department. Moreover, University is an



autonomous body and if any civil servant who wants to join the autonomous body, he will have to resign from the present post, so his request for relieving was regretted and his resignation was accepted by the competent authority. Furthermore, it is the prerogative of the govt to accept the resignation, therefore, the Provincial Govt, accepted the resignation. The rest of the para relates to respondent No.4.

- 10. Correct that the appellant submitted his departmental appeal dated 30-6-2015 for the withdrawl of resignation but the same was regretted as explained in the preceding facts above. (copy of resignation and acceptance is attached as Annex A and B).
- 11. That the orders issued by the respondents are lawful, legal and the appellant has no cause of action to impugn the same before the Honourable Service Tribunal.

ON GROUNDS

- A. Incorrect and misconceived. The appellant is treated according to law.
- B. Before joining his service in University as registrar he has thoughtfully chosen for the same and tendered his resignation from the post of assistant professor which was accepted by the competent authority while the other application for consideration his resignation application as request for relieving i-e in other words withdrawl of his resignation was not accepted by the competent authority.
- C. The appellant is to be blamed for choosing the wrong carrier. He left the job in Higher Education department and joined the service of University. All his services of more than 22 years stands forfeited to the Government due to the decision of the appellant himself for which the respondent cannot be blamed.
- D. Incorrect as explained in the preceeding paras that the appellant opted for the service of University instead of service with the Provincial Government. He resigned from service with the respondents and his application for withdrawl of resignation could not bear any fruit. As the process of resignation had reached to completion. After resignation from service with the respondent all his services stands forfeited to the Government. The respondents have done no wrong in accepting his resignation from service.
- E. Incorrect and misconceived. The regulations as referred by the appellant are not attractable here. Govt instructions that after resignation the past services of the appellant stands forfeited. (Copy attached as Annex C)
- F. That the respondents also seek permission to assist the Honourable Tribunal besides the above facts.

Prayer.

In view of the above, the service appeal being devoid of merits may graciously be dismissed in the public interest.




